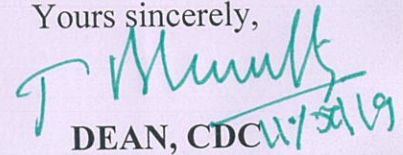

All the Principals of Constituent/Affiliated Colleges (University, Government, Private Aided & Private Unaided) under the jurisdiction of Satavahana University are hereby informed that Aadhaar Enabled Biometric Attendance System (AEBAS) is mandatory for all the Staff and Students vide Memo:No:1234/MC/2022 dated 12-10-2022 from the Higher Education (MC) Department, Govt. of Telangana. This requirement is important for claiming the Fees Reimbursement by the students (E-Pass) and also calculating the duty period of the Staff, both Teaching and Non-teaching for calculating their leaves and also for Promotions/CAS purposes.

In view of the above, it is instructed to all the Colleges under the jurisdiction of Satavahana University whose student's attendance is not registered through Aadhaar Enabled Biometric Attendance System (AEBAS) will not be allowed to take write the semester Examinations and if any College fails to implement the same, action shall be initiated as per the rules in vogue by the University.
