In pursuance of Executive Council decision and subsequent recommendations of the Deans Committee, the University has constituted an Inspection Committee to assess the infrastructure facilities available at the Department of Chemistry, Govt. Degree College for Women, Karimnagar to carry out research work leading to award of Ph.D. degree in Chemistry. The Committee visited the College on 14.11.2022 and after thorough examination of the facilities available and the eligibility of the faculty as Research Supervisors the Committee recommended to recognize the Department as Research Centre in carrying research programs leading to award of Ph.D. degree in Chemistry by the University.

In view of the above, the Vice-Chancellor in anticipation of ratification by the Executive Council, has accorded approval for recognition of the Department of Chemistry, Govt. Degree College for Women, Karimnagar as Research Centre to carry out research programs leading to award of Ph.D. Degree in Chemistry under the faculty of Chemistry from the academic year 2022-23. The recognition as Research Centre is for a period of (Five years) and it is mandatory on part of the Centre to adhere to the following conditions.

- 1. The College should continue to participate in Research Activities regularly.
- 2. The College should furnish the required information in the prescribed proforma to be obtained from the Office of Dean, CDC as sought by the University within the stipulated time annually.
- 3. The College should submit the detailed research facilities improved from time to time and the progress of the research work of the scholars on rolls, once in every six months to the Dean of the Faculty concerned.
- 4. The College has to pay an amount of Rs.25,000/- per annum for each department towards annual recognition fee to the "Registrar Income Account", Satavahana University, Karimnagar.
- 5. Two faculty members: Dr.M.Prasanthi, Asst. Professor and Dr.G.Srinivas Reddy, Asst. Professor may be recognized as supervisors. This two faculty members have to apply to the Dean, Faculty of Science separately for issuance of necessary orders.
- 6. The rules of Ph.D. Admission evaluation progress Report and award of Ph.D. Degree will be done by the University as per rules in vogue in the University and UGC guidelines issued time to time.
- 7. The College has to further strengthen library in terms of additional books, Research journals and create physical facilities to the Scholars.
- 8. The Chemistry Lab has to provide water and gas connection, Rot Evaporator, Uv visible spectrophotometer, fuming hood etc to be immediately operationalzed. Contd... 2 page.

- 9. The Principal has to give an undertaking to provide Research facilities in the Research Centre.

 10. Subscription of E-Journal will be recorded as a provide Research facilities in the Research Centre.
- 11. Any problem arising between scholars and supervisors will be resolved at the College Level only.
