The Satavahana University designs and prescribes the curricular of the different courses offered in this Institution after consultations with Telangana State council for Higher Education (T.S.C.H.E). The University periodically reviews and updates the curriculum of various courses to suit the changing needs of the society. 2. The Institution follows the curricular pattern revised by the Satavahana University, Karimnagar, Telangana State. Government Degree College, Godavarikhani follows the pattern of CBCS system for UG and PG Programs. 3. The Institution implements the

curriculum given by the University through (i) Classroom Teaching (ii) Student Seminars (iii) Extension Lectures by inviting experts from the Academic and Industry (iv) Project Work (v) Field Visit (vi) Group Discussion (vii) Quiz , Lesson plans, Weekly, Monthly are scheduled to the students. viii) Virtual Class Room was renovated with all the modern facilities, students can utilize it for classes which are not available by the staff here. 4. The Institution deputes its teachers to various Departmental conferences where in they will represent views of the students and teachers for the development of curriculum and its effective implementation. 5. The Institution analysis the Academic Progress of the students in terms of analyzing the Examination results semesterwise. 6. The Institution ensures to achieve the curriculum objectives analyzing the placement activities undertaken by the TSKC of the Institution and the same is communicated to the University every year. 7. The Institution offers restructured and self financed courses which provides Academic flexibility to the students and offers Employment Opportunities. The courses includes 1) B.Sc. (Mathematics , Physics, Computer Science) 2) B.Com. (Computer Applications ) 3) B.A. (Computer Applications) 4) B.Sc. (Botany, Zoology, Chemistry, Bio-Chemistry, Bio- Technology) 8. The Institution follows the curriculum designed by the University. However the Course cutting issues are taught as a part of extra-curricular activities in the Institution such as National Service Scheme, National Cadet Corps and Women Empowerment Cell Activities etc... Lectures by Eminent Lawyers on "Human Rights and Gender Issues " are arranged to sensitize students. 9. All Departments conduct the periodical tests as per the schedule and evaluate the quality of its enrichment programs. 10. i) The Institution arranges training class to improve Knowledge in Computer subjects for Teaching and Non-Teaching staff. ii) The Teaching faculty is deputed to attend the O.C / R.C being organized from time to time by the State Government/ University HRDCs to empower them to handle the new curriculum. iii) TASK (TSKC) has registered students from all years and conducted various programs like Three Days Program on "21st Century Transferable Skills "in the month February from 13.02.2020 to 15.02.2020 and 'Mahindra Pride Classroom Training' with the collaboration of TASK for Seven Days in the month of March from 04-03-2020 to 11-03-2020. iv) All the Teaching Staff had taken online classes for the students during COVID-19 Lock down period from 15-04-2020 to 31-5- 2020. The response from the students was good and it was successful.
