ORDER:-

- 1. Government have received several representations from certain People's Representatives of the State, requesting to accord permission to start new Government Degree Colleges at their respective assembly constituencies in the State, during the academic year 2008 2009.
- 2. Accordingly, Government after careful examination of the above representations, hereby accord administrative sanction for setting up of five new Government Degree Colleges from the academic year 2008–2009, with B.A., B.Com & B.Sc (Conventional Courses) at the following places in the States: -
 - (01) Government Degree College at Cumbum, Prakasam District.
 - (02) Government Degree College at Warangal in Warangal Assembly Constituency.
 - (03) Government Degree College at Kamalapuram Town, Kadapa District.
 - (04) Government Degree College at Patancheru, Medak District.
 - (05) Sri Gangula Thimma Reddy Memorial Government Degree College at Yerraguntla, near Allagadda.
- 3. The recurring and non recurring expenditure of Rs.1,50,00,000 (Rupees one crore and fifty lakhs only)[@ Rs.30.00 Lakhs per each College] for the 1st year i.e. 2008 2009, for setting up of the five new Government Degree Colleges, as ordered at Para (2) above, shall be met with in the existing budget provision of the department [towards Salaries, Equipment and Contingencies etc.] and the Commissioner of Collegiate Education, A.P., Hyderabad, is directed to submit the proposals for re appropriation / additional funds during the last quarter of the year.
- 4. The Commissioner of Collegiate Education, A.P., Hyderabad, is requested to take further action to send necessary re appropriation proposals, for actual amount required at appropriate time, to the Government for taking further necessary action in the matter.
- 5. The Commissioner of Collegiate Education, A.P., Hyderabad, is also requested to identify the existing buildings of Junior Colleges or others where the Classes are proposed to be held pending construction of permanent accommodation
- 6. Orders regarding recruitment of Teaching and Non Teaching staff shall be issued separately.
