Sub:- APCES – Dr.Chandra Mukherjee, Lecturer in Hindi, Government Degree College for Women, Begumpet, Hyderabad – No Objection Certificate for Passport and Permission to work as ICCR Hindi Chair at University of West Indies on Deputation – Orders – Issued.

Read:- Lr.Rc.No.547/Estt/2015, dated:14.02.2015 of the Principal, Government Degree College for Women, Begumpet, Hyderabad.

In the circumstances stated by the Principal, Government Degree College for Women, Begumpet, Hyderabad in her letter in reference cited, the Commissioner of Collegiate Education, Telangana, Hyderabad hereby sanctioned deputation for a period of One year starting from August / September, 2015 to work as ICCR Hindi Chair at University of West Indies as per the conditions stipulated in G.O.P.No.10 Finance & Planning (FW.FR-II) Department dated:22.01.1993 and also issues No Objection to obtain Passport subject to the following conditions:-

1. that, there should not be financial commitment or Foreign exchange problem to Government.
2. that, she should complete the syllabus allotted to her before leaving the country
3. that, she should take prior permission of the Principal of the college before actually leave India.
4. that, she should return to India soon after completion of her tenure.
5. On return from the assignment she should apply for reposting orders along with relieving orders from the authorities of University of West Indies.

(iii) Dr. Chandra Mukherji will deliver at least one public lecture during the academic year to be arranged by the University, which would be termed as "ICCR Lecture on India".

(iv) Conduct and performance: - She will abide by the host University's code of conduct and human resources policies and laws of the country of deputation. She will be governed by the provisions of IFS (Conduct Rules) & CCS (CCA) Rules during the period of deputation to ICCR.

(v) Employment of family members: - Any dependent family members if residing with her shall not accept any employment in Trinidad & Tobago on payment basis without prior permission of the ICCR, who will consider such proposals only if recommended by concerned Mission/Post and in consultation with the Ministry of External Affairs, when necessary. (Note- All expenditure on accompanying family members will be borne by Dr. Chandra Mukherji).

c. Pay & other remuneration payable by ICCR :-

(i) During the period of deputation, Dr. Chandra Mukherji will draw from the relevant Mission/Post the same basic pay and grade pay as is being drawn by her in the present scale of pay in parent organization, with annual increments to the next higher stages in the scale.

(ii) No other allowance, including deputation duty allowance, will be admissible.

(iii) The Quantum of Additional Allowance admissible will be determined on the basis of her grade pay. Once the Quantum of Additional Allowance is fixed, any revision of pay scales/grade pay on account of annual increment, promotion or grant of ACPs shall have no effect on the drawal of related Quantum of Additional Allowance.

(iv) Further, the Quantum of Additional Allowance will stand reduced to the extent of any honorarium being paid by the University under the MoU with ICCR, excepting the amount of honorarium being allocated to payment of rent and health cover as laid down in the MoU.

(v) The Pay and other admissible allowance and their drawal during home leave or any other leave will be regulated in terms of relevant provisions of IFS (PLCA) Rules.

(vi) Dr. Chandra Mukherji will not accept any other remuneration other than as provided in this letter and in the MoU while on deputation to ICCR.

d. Pension/Provident Fund: - During the period of deputation, Dr. Chandra Mukherji will continue to be governed by the rules of her parent department relating to the pension/provident fund etc. The Mission/Post will remit employers subscription to the provident fund by RBI drafts through deduction from the monthly salary bills to her parent institution under intimation to the ICCR.

Offer of Appointment

Dear Madam,

We are glad to inform you that Dr. Chandra Mukherjee, Associate Professor, Dept. of Hindi, Government Degree College (W), Begumpet, Hyderabad has been selected for deputation as ICCR's Hindi Chair at the University of West Indies, Port of Spain, Trinidad & Tobago for a period of one academic year to begin in August, 2015 extendable for one more academic year on the recommendation of the Mission and host University. The terms and conditions of this deputation would be as follows:-

a. Tenure: - The period of deputation will commence from the date she joins the University and ends on the day she is relieved from the University. The deputationist is entitled to preparation/joining time of upto 7 days at the time of commencement and completion of tenure during which she should report to ICCR to sign her joining report/relieving report. If there is any gap between the date of signing the joining report/relieving report and joining her parent department, it should be regularized by the latter under applicable rules-

b. Obligations: -

i) Dr. Chandra Mukherji will discuss and finalize the curriculum in consultation with the University.

(ii) This offer is subject to a medical examination and obtaining a medical fitness certificate in respect of Dr. Chandra Mukherji. Such medical examination and fitness certificate is to be obtained from a Government hospital at Hyderabad and submitted to ICCR along with the formal acceptance of this offer. Cost of medical examination will be reimbursed by ICCR.

She is the most recent academic who has been sent to UWI St. Augustine by the Indian Council for Cultural Relations to support the teaching of Hindi as a foreign language. Advance Visit by Rear Admiral

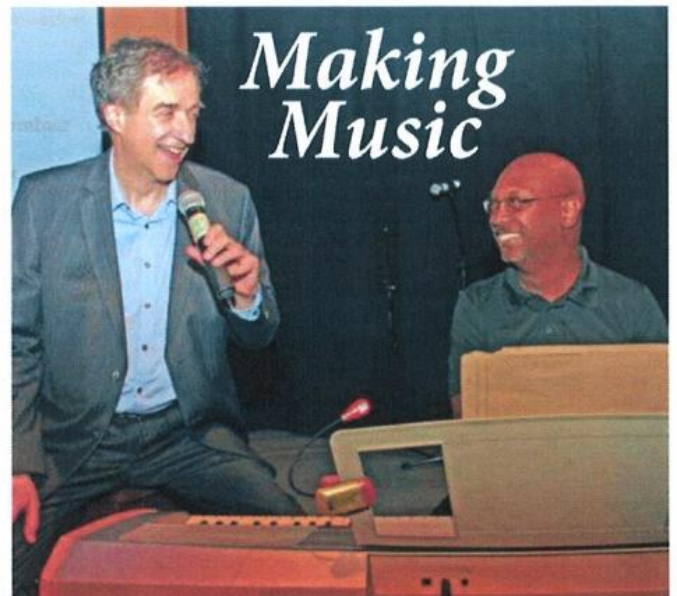
Trafficking in narcotics and people; natural disasters; security and defence – issues which are significant within the Organisation of American States (OAS) – are high on the agenda when Rear Admiral Martha Herb, Director, Inter-American Defense College (IADC) returns to Trinidad and Tobago with her class in April.

The Rear Admiral was in the country in mid-February and paid a courtesy call to PVC and Campus Principal, Professor Clement Sankat, where she told him that this was actually an advance visit before her class arrives under an arrangement with the T&T Government and the Defence Force.

The IADC operates under the aegis and funding of the OAS and the Inter-American Defense Board. It provides a professionally oriented, multidisciplinary, graduate-level course of study over an eleven-month programme, giving students opportunities to travel abroad and to study security issues.
