Discussion: The syllabus is as per CBCS pattern, unitization, pattern of question papers, panel of examiners, internal assessment and semester end examinations.

The scheme of examination which has been changed from the academic year 2019-20,approved in the 7th Academic council is being followed for 1st,2nd & 3rd Years, i.e. 60 marks for external examination and 40 marks for internals.

Division of 40 marks is as follows.

- 1. 20 marks internal assessment in the form of descriptive exam, where two internals will be conducted and average of two is considered.
- 2. Unit wise test in the form of 20 objective questions, carrying half mark each and a total weightage of 10 marks.
- 3. 5 marks for seminar / quiz/ group discussion and 5 marks for assignments.

The semester end examinations for the courses commencing from 2022-23 are evaluated for 60 marks. The question paper shall be set according to Blooms Taxonomy as approved in BOS meeting and the same is to be given to the controller

of examinations.

A candidate shall be declared to have passed in individual Theory course if she secures a minimum of 40% aggregate marks (Internal & semester end examination marks put together), subject to a minimum of 40% marks in semester end examination.

The final year syllabus of all courses are changed and the same is highlighted in respective course BOS.

It is also submitted that all the courses are relevant to employability.

Resolution: Minutes and recommendations of the Meeting of the BOS of different subjects is approved.

40:60 assessment pattern was reiterated and reapproved.

Ratification of new programs of study for the year 2022-23. (Annexure – III)

Discussion: As approved by the Commissionerate of Collegiate Education and keeping in view the needs of the industry, enhancement of employability skills of the students, it is proposed to start new courses in the following subjects for the academic year 2022-23.
