Rationale:

Policy Statement:

Aims:


- To ensure equal opportunities to students coming from different sections in academic, curricular and co-curricular activities.

- To build the capacities of women students by organizing skill development programmes.
- To sensitize all the students on gender issues by organizing gender sensitization programmes.
- To prevent all forms of discrimination and violence against women through committees like, Grievance Redressal, Anti-Ragging, Women Empowerment Cell and Internal Complaints Committee.
- To empower the students with overall skills to face the challenges of life.
- To strictly adhere to gender laws and bring gender perspective in all the aspects.

Implementation:

- Awareness programmes on Women Empowerment to be organized by inviting prominent women in different fields in collaboration with She Teams.
- Awareness Programmes on Nutrition and Health for women are to be organized regularly to make women students and staff aware of the importance of women's health for a better society.
- Programmes on the importance of self-defence training are to be conducted for women students and staff.
- An initiative like a certificate course on 'self-defence' is also introduced.
- Gender Sensitization programmes are conducted to create awareness among students.
- Awareness programmes against ragging and harassment are organized to make women students aware of the legislations provided for them.
- Awareness programmes against eve-teasing and sexual harassment at workplace are organized by the Internal Complaints Committee (ICC).
- Screening of inspirational films is taken up to provide innovative ways of introducing the concept of women empowerment
