Context:

The Memorandum of Understanding (MoU) is made on Degree College for Women, Begumpet (A), Hyderabad, India hereinafter known as "GDC for Women, Begumpet" represented by it's authorized officer "Principal" and Government City College (Autonomous), Hyderabad hereinafter referred to as "GCC (A), Hyderabad" represented by its authorized officer "Principal"

A. About GDC for Women, Begumpet (A):

Government Degree College for Women, Begumpet, Hyderabad was established in 1971. It is located centrally at Begumpet and caters to the needs of the girl students of twin cities and also the nearby districts. The college provides university education to deserving candidates in a secular atmosphere and is committed to serve the economically weak, socially underprivileged and needy students. During the last four decades the college has grown from strength to strength and presently helps about 3676 students to access higher education. With an objective of "Empowerment of Women through Knowledge", the college helps the students to become truly empowered citizens. The college celebrated its Silver Jubilee in 1996.

Keeping in tune with the changing needs of the society, new courses are being introduced from time to time. Since1994, three vocational courses and several restructured Courses have been introduced. PG Courses like M.Sc. Chemistry, M.A English, M.A Economics, M.Com and M.Sc Mathematics.

Recognizing the potential of the college the UGC has conferred autonomous status to the college in the year 2012. As such the first year students admitted into UG programme will conform to the autonomous pattern of education. Presently (during AY 2020-21) the Student Strength is: UG-3676, PG-170.

The college has two floors with spacious class rooms and laboratories, a good Library with a Reference section and a Reading Room. Telangana Skills & Knowledge Centre (TSKC), the Computer Centre, the Health centre, the Gymnasium, the MANA TV (T-SAT Nipuna) and the Audio-Visual Department are the other supporting services provided by the college. During the academic year 2016-2017, the college was assessed and re-accredited by NAAC with B+ grade (securing CGPA 2.64 (3rd Cycle).

There are 89 experienced teaching Staff, a Librarian, a Physical Director and Computer Instructors. Most of our lecturers received Best teacher Awards from the Government of

Andhra Pradesh and other organizations. The Administrative Officer and 39 Non-Teaching Staff help in the maintenance and smooth functioning of the college. The overall academic, administrative and financial responsibility of the college is vested with the Principal.

B. ABOUT GCC (A) Hyderabad:

City College owes its origin establishment in 1921 to the largesse of the VII Nizam of the erstwhile Hyderabad state, Nawab Mir Osman Ali Khan, who was known as the modern architect of Hyderabad." The institution started as an Urdu School grew later into an Institution of Higher Education. It became a constituent college of Osmania University and in 1967; the college became 'Government City College (A), Hyderabad.'

The academic ambience of the institution is enhanced by the exemplary achievements of its outstanding Alumni. Union Cabinet Ministers like Sri Shivaraj Patil, Sri P. Siva Shanker, Chief Ministers like Sri S.B.Chavan, Sri Veerendra Patil and Marri Chenna Reddy and several Vice-Chancellors, Doctors, Engineers, Scientists, Lawyers, Defence Personnel, Olympians, Arjuna Awardees, Padmashree recipients have been students of this august institution, continuously inspiring the succeeding generations to follow in their path and achieve greater laurels.

The college with highly qualified faculty and state-of-the-art infrastructure creates an environment conducive for higher learning works with a vision to bring in holistic development of students with student centered pedagogical models. The college stands first in Degree Online Services Telangana (DOST) admissions with intake of 1500 completely being filled with meritorious students.

This collaboration encourages students to improve English language skills from both the colleges. This agreement is being made between the colleges to encourage the UG and PG Students to improve language and literature skills. The parties are desirous of recording the terms and conditions of their agreement in writing.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSED AS UNDER

Scope: The Scope/ Objectives of the MoU are as follows:

- Facilitate Accreditation by NAAC (National Assessment and Accreditation Council).
- To enable students well versed with the communicative English.
- To develop students' ability to use English in day-to-day real-life situations.
- To understand the written text and be able to use skimming and scanning skills.
- To be able to use English to express ideas etc.
- To be able to speak English fluently and accurately.
- To think in English and then speak.
- To be able to compose freely and independently in speech and writing.
- To be able to critically read and analyse books.
- To acquire a vocabulary of 2500 words.
- Ability to use reference material such as encyclopaedia, dictionary, etc.
- Certificate programmes for Students on communication skills in English
- Faculty and Student exchange programmes
- Joint language orientated research work
- Facilitate Student Mini Projects and Final Year Projects.

B. GENERAL TERMS & CONDITIONS:

a) This MoU shall be effective from the date of signing of the parties and will remain in force for a period of three (3) years wef 2021-2022.

b) This MoU will be reviewed by the partnership committee members from time to time and may be amended with the consent of both the parties and thereafter confirmed in writing.

- c) The parties agree and acknowledge that no other rights are granted except as explicitly
- d) Neither party shall transfer or assign its interests, obligations or rights in this agreement without the written consent of the parties, provided that such consent will not be unreasonably withheld.
- e) Neither party shall be liable by reason of failure or delay in the performance of its obligation under this MoU, if such failure or delay is caused by the acts of God, Strikes, Lockouts or any other causes beyond its control and without its fault or negligence on mutual agreement.
- f) Any other arrangements or activities or commitments shall be made on mutually agreed terms from time to time.
- g) No amendments to the MoU shall be valid unless executed in writing and signed by both the
- h) Nodal Officer will be nominated from respective university/ college for carrying out activities with respect to Students, Faculties and Non-Teaching Staff.
- i) Financials commitments if any can be decided on mutual agreement before commencement of each activity.

C. TENURE AND TERMINATION:

This agreement shall commence from the date of agreement and shall continue in force for three years on mutual agreement. Either party may terminate this agreement upon 60 days prior written notice to the other party, which will however be subject to compliance to completion of all commitments made. Notwithstanding any such termination, both parties shall ensure that all activities in progress are completed successfully.
