As per the request made by the IQAC of the college to the External Peer team members, the peer team visited Government Degree for Women, (Autonomous), Begumpet - 1085 on 30-03-2021 and interacted with the Head of the Institution, teaching faculty and the office staff of the college in view of the Extension of Autonomous status. The team reviewed the functioning of the mandatory bodies and the documents concerning the unique initiatives and transparent system developed. The details of the visit and observations are given below:

- 1. The members under the chairmanship of Dr Rajender Singh, Joint Director, Commissionerate of Collegiate Education visited the institution on 30.03.2021.
- 2. They interacted with the Principal, Vice Principal, Coordinator of Autonomy, Coordinator of IQAC, Controller of Examinations, Heads of the Departments, Administrative Officer, Office superintendent, Coordinators of various committees and made note of the positive impact in the functioning on account the Autonomous status.
- 3. The following documents were verified and noted to ascertain the regularity an functioning of the mandatory bodies in view of the stipulated UGC guidelines
  - > Annual Reports of last 5 years submitted to the University.
  - ➤ The Autonomous Report of the college submitted to UGC for the extensi of Autonomy.
  - ➤ The Annual Quality Assurance Reports (AQAR) of previous years.

- > Minutes of the Governing Council, Academic Council, Board of Studies and Finance Committee.
- > Audited statements of expenditure of the last 5 years.
- > The minutes of the IQAC in view of NAAC post-accredited initiatives.

The committee has made the following observations after its interaction and review of documents:

- a) The institution has fulfilled all the requirements in the constitution of all the mandatory bodies such as Governing Council, Academic Council, Board of studies, Finance committee and the IQAC. The selection of its members of the bodies and the meetings of these statutory committees are in tune with the UGC guidelines of 12th five year plan period.
- b) The initiatives undertaken are in accordance with the NAAC Peer Team Report / UGC Autonomy Review Team Report / University Autonomy Review Team Report. The college has a clear-cut perspective plan for both long term and short term.
- 4. The institution has been initiating new quality academic activities every year. The IQAC has been proactive in strengthening the good practices and ensuring the quality in all activities. The college has separate manuals of best practices, teaching methodologies, manual of professional ethics and clearly stated and integrated development policies.
- 5. The institution prepares and adheres strictly to Academic Calendar every year.
- 6. The college has separate exam section with a strong room and the unique initiatives of this section include conduct of online exam, coding system, provision for re-totaling, provision of photocopy of the Answer script under reverification, announcement of results within 45 days after the completion of examination, result analysis. All the exams are conducted under CCTV surveillance.
- 7. The College has three floors in all the 4 blocks with spacious classrooms and laboratories, a good Library with Reference section and Reading Room and a spacious Playground and Open Air Auditorium. The Computer Center, Research Centre, TSKC Lab, English Language Lab, the Gymnasium, the Virtual Classroom, Health Room, Women Empowerment Cell,

- Entrepreneurship cell are the other supporting services provided by the College.
- 8. The Telangana Skills and Knowledge Centre (TSKC) is doing a commendable work by organizing various training programmes and certificate courses. The institution has a MoU with IIT Bombay for Spoken Tutorial and a tie-up with ni-MSME for Entrepreneurship Skill development programmes.
- 9. The Board of Studies of every department has revised syllabus by introducing topics that have relevance. More than 20% of the curriculum has components relating to modern professions in companies and corporate. The vision of the institution is reflected in the redesigned syllabi of various disciplines. The institution has reintroduced 5 PG courses in English, Economics, Mathematics, Commerce and Chemistry.
- 10. The Sports, NCC and NSS departments have been established and play a vibrant role in the College by conducting various programmes.
- 11. The College has implemented the Choice Based Credit System for all the Undergraduate courses it is offering since 2014.
- 12. Another note worthy development is that the Gross Enrollment Ratio of the college has increased on account of the 53 multi disciplinary courses and quality additions.
- 13. In addition to all the above mentioned good practices, there has been full support to co-curricular, extra-curricular, literary, cultural, sports and games activities. The National and State Level medals and recognitions reflect the achievements of the college.
- 14. The institutional data was submitted to AISHE (All India Survey on Higher Education), Department of Higher Education, Ministry of Human Resource Development, Government of India for the academic year 2019- 2020.
- 15. The institutional data was submitted to NIRF (National Institutional Ranking Framework) Department of Higher Education, Ministry of Human Resource Development, Government of India for the academic year 2019-20.
- 16. The institution is certified by ISO 9001:2015 in February, 2020.

A structured feedback system from the students and other stake holders is taken every year.

#### Recommendations:

- Mission statements to be reviewed and reframed periodically based on attained targets and latest developments.
- 2. Each subject shall have more number of Certificate Courses.
- Development of e-Content modules for the courses introduced this academic year.
- 4. Enhance the number of Extension and Outreach programmes.
- 5. Increase in number of value added and socially relevant courses.
