OBJECTIVES:

Employees and students shall make every effort to reduce the amount of energy associated with lighting in the college campus by:

- Turn lights off in unoccupied spaces.
- · To install LED bulbs in the complete campus to save energy
- Maximizing the use of natural light and turning off all non-essential lighting whenever possible.
- Turning off exterior building architectural lighting between 11:00 pm and 6:00 am.
- To calculate the energy use in the college and its environmental impact.
- Computer power management software shall be enabled to minimize the operation and consumption of electricity when computers are not in use.
- Computers purchased with the College funds are required to be ENERGY STAR.
