Memorandum of Understanding

Between

Government Degree College for Women Nalgonda

And

Nalgonda Economics Forum Regd No 297/13

Government Degree College for Women, Nalgonda (hereinafter called GDCW) and Nalgonda Economics Forum (hereinafter called NEF) establish hereby a formal understanding of cooperation and friendship which is intended to further the academic objectives of each institution and to promote better understanding between the faculty and students of GDCW and the faculty and students of NEF. Under this Memorandum of Understanding, the two institutions will proceed to implement the following endeavors and exchanges of materials and personnel.

Areas of Cooperation

Cooperation shall be carried out, subject to the approval of the competent authority of GDCW and NEF, through such activities or programmes as:

- 1 Exchange of faculty members.
- 2 Exchange of students.
- 3 Joint research activities
- 4 Participation in seminars and academic meetings
- 5 Exchange of academic materials and other information
- 6 Special short-term academic programmes

The terms of such mutual cooperation for each specific programme and activity that is implemented under the terms of this MoU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular programme or activity and the terms of such programme shall be negotiated on an annual basis.

Scope of the Cooperation

The areas of cooperation include, subject to mutual consent, any Programme offered at either institution as felt desirable and feasible on either side and that both sides feel can contribute to the fostering and development of the cooperative relationships between the two institutions. The assistance to be provided by each of the contracting parties will be teaching, research, exchange of faculty and students, and staff development, etc. as deemed beneficial by the two institutions.

The cooperation will be focused on the following fields of study initially;

- To develop economic awareness among students.
- To give coaching in economics for P.G entrance and various competitive exams.
- To conduct seminars and debates on economic issues.
- To conduct essay writing and quiz competition to the students in economics.
- To inculcate economic concepts among students.
- To conduct Economic festivals.
- To conduct model tests for various competitive exams. 7.
- Conduct computer based tests.

The Memorandum of Understanding (MoU) shall remain in force for a period of three years from the date it is signed by the appropriate persons of the two institutions. It may further be extended or amended with the written agreement of both parties. This MoU may be terminated by either party subject to the delivery of six months advance notice, in writing, At GDCW, Head of the Department of Economics will oversee the implementation of the MoU. At NEF, the President of the Forum will oversee the implementation of the MoU.

Both parties understand that all arrangements will have to be negotiated and will depend on the availability of accommodations.
