


7.1.7 The institution has disabled-friendly, barrier free environment

POLICY DOCUMENT FOR DISABLED-FRIENDLY, BARRIER FREE ENVIRONMENT

POLICY OBJECTIVES:

- To ensure that all legal entitlements be made available to the persons with disabilities
- To create suitable regulatory mechanism for effective delivery of services to disable Students and Staff of the college.
- To ensure full participation of persons with disabilities and to provide them the equal opportunities for development.
- To provide all kind of support in academic and examination related issues.
- To provide special guidance and counselling to differently abled students.

ACCESSIBILITY POLICY:

The institute should provide various facilities in creating a disabled friendly campus.

The following principles of accessibility will be observed: -

- To provide study material to all students with disabilities.
- To create awareness programmes for all the teaching Staff and non-teaching staff regarding the issues of accessibility.
- According to the G.O.Ms.No.339, Education (EC.2) Department, dated:15.12.1999, (Visually Challenged/Impaired, Hearing Impaired, Orthopedically Challenged) 3% of the total number of seats in UG admissions shall be reserved for the Physically Challenged persons.
- The institute will ensure the representation of all the types of disabilities listed in the rights of persons with disabilities 2016 and as per government regulations from time to time.


FACILITIES AVAILABLE FOR STAFF AND STUDENTS:-
