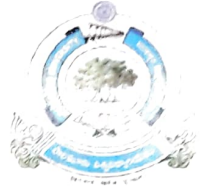



The Commissionerate of Collegiate Education of the Government of Telangana is the Department to regulate and develop Undergraduate and Post Graduate Education in the Degree Colleges in the State of Telangana.

The Commissionerate of Technical Education of the Government of Telangana is the Department to regulate and develop Technical Education in the Engineering Colleges and Polytechnics in the State of Telangana.

The two are hereinafter referred to as CCE&TE.

Rotary International is an international service organization whose stated purpose is to bring together business and professional leaders in order to provide humanitarian service and to advance goodwill and peace around the world. It is a non-political and non-religious organization open to all. Rotaract which is part of Rotary is a service, leadership, professional and community service organization for young men and women between the ages 18-30. Rotaract focuses on the development of young adults as leaders in their communities and workplaces. Clubs around the world also take part in international service projects, in a global effort to bring peace and international understanding to the world.

Rotary India Humanity Foundation, hereinafter referred to as RIHF is a Society that concerns itself with the furtherance of the work of Rotary in India including the imbuing of the spirit of service and nation building into the youth of India,

Both CCE&TE and RIHF believe that the development of young men and women, beyond the academic curriculum, by developing in them a sense of empathy, responsibility, service and leadership will go a long way in community and nation building as well as equip the young people to be equipped with leadership, problem solving and organization skills that will stand them in good stead in their professional and business lives.

Based on this objective, CCE&TE and RIHF have agreed to cooperate for establishment to Rotaract Clubs in the **1100 Degree Colleges** and **187 Engineering Colleges** in Telangana state with a total student population of approximately 5 Lakhs in Degree Colleges and 2,72,921 in Engineering colleges.



The scope of cooperation includes:

- Establishment of Rotaract Clubs in the Colleges.
- Involvement of Youth in service activities in the areas of Literacy, Water, Sanitation, Disaster Management, Health and Environment.
- Jointly certify the youth for time spent and the work done.
- Facilitate the development of training programmes for development of professional skills and leadership.
- Develop a platform for the interaction between professionals and business leaders in society and Youth.

Roles and Responsibilities:

The Role and Responsibilities of CCE&TE will be:

1. To disseminate a circular and or general resolution that will inform Degree Colleges and Engineering Colleges about this partnership.
2. Encourage the formation of one or more Rotaract Club in each Educational Institute under the aegis and sponsorship of a Rotary Club.
3. Provide a list of the Colleges and Engineering Colleges with the details and introduction of the head of the Institution/ nodal officer to Rotary to facilitate establishment of Rotaract Club.
4. Provide opportunities to RIHF and Rotary to talk about Rotaract to the institutions, students at appropriate meetings and conferences, both physical and online for furtherance of the propagation of the Rotaract movement
5. Take steps to treat Rotaract on par with NSS.
6. Co-sign the certificates given to Rotaractors for their involvement and achievements.

The Role of RIHF will be:

1. To arrange for a Rotary Club to sponsor and advise each Rotaract Club.
2. To involve Rotaractors in service through the Rotaract Club or through the activities of a Rotary Club and their Corporate partners.
3. To provide an opportunity for the youth to improve the leadership and professional skills through their Rotaract Club.
4. Appoint Rotarian advisors to regularly visit and interact Rotaractors to help them in their work and to be their window to the Rotary world.
5. To encourage Rotaractors to participate in leadership positions beyond their Club.
6. Co-sign the certificates given to Rotaractors for their involvement and achievements.



Both parties shall meet quarterly to assess the impact created by this cooperation and refine the levels of cooperation for maximum achievement of the shared objectives.


This MOU shall be valid for an initially period of 5 years and extendable for a similar period by mutual consent.


