#### Qualitative analysis of Criterion 1

The Government Degree college is affiliated to Palamuru University Mahbubnagar and it functions within the frame work of institutions and curriculum by the affiliating University. The time table of the college is well defined as per the CCE/Affiliating University and teacher's dairies are maintained. The college is offering B.Sc courses with different specialisations at the UG level. It has one PG Program, M.Sc mathematics. All the programs are following CBCS semester pattern, ICT based teaching is yet to be practised in the college. The five faculty members are paper setters at the University level and four are paper evaluators at UG level of the University. The HEI offers certificate courses (30Days) i.e Sericulture, M.S. office, Notarisation Dietetics and skill enhancement courses of 2credits each. The institution integrates crosscutting issues with the help of teaching Environmental science, Gender sensitization, Basic computer skills and awareness programs of health and hygiene. The students are encouraged to take the field assignments and field trips and some students have participated in competitions of projects presentations. The IQAC collects the feedback partially from the students and teachers related to the syllabi and other academic activities of the institution. The feedback analysis is also shared with the faculty members .

The admission process is followed by the college is transparent and done at state level by DOST. The average enrolment percentage of last five years is 36.19 which is quite poor while, seats allocated by the government /University are quite high. Therefore, a large number of seats remain vacant. The academic calendar is followed while conducting continuous teaching learning and internal evaluations.

Actual number of students admitted in the reserved category is increasing year wise and average percentage of seats filled from reserved categories is 64.09. The special English language classes are conducted for the slow learners from the rural background and especially from Telugu and Urdu medium. Subject orientation and remedial classes are also conducted for the slow learners. The advanced learners are made group leaders for the groups of slow learners while the special classes are conducted for the advanced learners also. The advanced learners are encouraged to give seminars and to undertake project assignments. They are also motivated to participate in all the co-curricular activities.

All Students are encouraged to learn through student centric methods such as experiential learning, participatory learning and problem solving methods are used to enhance learning experiences. All the departments organize field trips and students learn through the observation and they participate in group discussions organized by each department.

The college has only one ICT enabled classroom while the new technology should be implemented to enhance for teaching learning effectiveness. Out of four permanent faculties only two are PhD holders and one is perusing PhD. The Mechanism of CIE is done for 20 marks and 80 marks examination is conducted by the University as semester end examination. Internal assessment is transparent and robust in terms of frequency and Mode. In the internal assessment following modes are used: Multiple choice questions, fill in the blanks,

The HEI has not received any grants from Government and nongovernment agencies for research. The teachers are not recognised research guides of the affiliating University. There is no incubation centre and innovation centre in the college.

The HEI has fully functional NSS Unit where one hundred students are enrolled. Through NSS and other departments college conducts swatch Bharat Abhiyan on the college campus and in the nearby villages. The college conducts various extension activities like voter enrolment program and "Telenganaku Haritharam Program". College also conducts blood donation and organ donation awareness programs with the help of local government hospitals and charitable trusts. The college celebrates women's day, National Youth day and road safety week. One seminar/workshop was conducted on research methodology. Women empowerment cell organised many relevant activities. Training of self-defence is also imparted to the students.

The institution must encourage the teachers to publish research papers in reputed and UGC listed research journals. Only one faculty member has written five books in Telgu Language in last five years.

The college organised extension and outreach activities with Red –Cross society, Lions club, District Aids control Authority, District anti corruption Authority and the forest Department. The college has received two awards in recognition of extension and outreach activities from the Government and Government recognised bodies in the last five years. On an average 18.22% students have participated in extension activities. The college received first prize at state level for highest blood donation in a year. There is need to explore collaborative activities leading to research.

The college has 5.05 acres land area. The college has 13 classrooms, which includes 6 lecture halls, and two rooms with 5 labs and 01 library room, one principal's chamber and one office room. There is one girl's common room and there is also one computer lab which is ICT enabled. The college has upgraded to 50 MBPS internet facility. The college is also having open spacious ground which could be used for outdoor games and sports activities no adequate facility for out door and indoor games and Gym. The open space has also a small botanical garden with limited number of medicinal and ornamental plants. The biometric facility is available. There are upgraded to fourteen CCTV cameras are fitted in the corridors' of the building. There are two bore wells with over-had water tanks. There is a small canteen corner for the students and staff. The college has spent 100.6 lakh rupees spent on the infrastructure augmentation in last five years. The library is equipped with 1700 copies of text books and 45 reference books. The internet facility is used for digital library in a limited manner. The library is using Soul3.0 latest version 2022. There is scope for the substantial automation of the library services. Annual expenditure for purchase of library resources is 0.28 lakhs. The students' computer ratio is 8.8:1. The college is having Wi-fi facility in the entire college. There is no AMC for the maintenance of the computer infrastructure however college gets it maintenance done as and when required from the local vendors. There is a mechanism for civil maintenance in a limited way.

The college being run by the Government of Telengana a good number of students get benefited by the government scholarships. More than 80% students have received scholarships and free ships provided by the government in last five years. The college is doing the following activities for capacity building and skill enhancement: Language and communication skills, Life skills (Yoga, physical fitness, health and hygiene) and ICT/computing skills. The efforts are being taken for the guidance for competitive examinations and carrier counselling is provided. The college has constituted committees for students' grievances and sexual harassment as well as ragging cases. The committees have resolved grievances reported by the students in timely manner. The college has maintained the records of the same. Telangana Skills & Knowledge centre is established in the HEI and a few students have been placed through their efforts. 32 students have gone for higher education in the reputed institutions. Two students have been selected for the adventure camp at national level to be conducted in Himachal Pradesh through NSS. The college nominates class representatives for each class and their meetings with faculty are conducted once in a month. They discuss issues related to curriculum and extracurricular activities. The college is doing sincere efforts in implementing mentor and mentee system. Students are given representation in statutory and non statutory bodies. The college encourages students to participate in sports and cultural events/competitions. On an average 8 students have participated in such events and competitions in last five years. The college has an Alumni association though it is not registered. The old students have contributed less than one lakh rupees for furniture.

The college has clear vision and mission statement reflecting the role of teachers and the principal as leaders in higher education. The 23 committees have been formed with adequate representation of teachers and students for effective college governance and its management.

The decisions are taken by the staff council which is headed by the Principal of the college. The institution is practising the principle of decentralisation and participative management. The institution has its organogram. The major academic and financial decisions are taken by the Commissioner of College Education (CCE). The college is affiliated to Palamuru University therefore the decisions related to syllabus revisions, conduct of examinations and evaluations are taken by the University. The teaching staff recruitment is done by the TSPSC. The CAS Promotions are as per the rules of the CCE.

The college effectively implements e governance in the areas of administration, finance and accounts, students' admission and support and conduct of the examinations.

The regular staff is provided certain welfare facilities like Telangana State General life Insurance, Employee health cards, GPF, CPS, Pension and gratuity. The 11 teachers have been supported to attend conferences and workshops in last five years. The college has organised two training programs for professional development of teaching and nonteaching staff. Five faculty members have participated in FDP and PDP in the last five years. The CCE is responsible for CAS of teaching faculty as per the Annual Performance Indicators. The internal audit is conducted by CA appointed by the CCE. The external audit is conducted regularly by the Accountant General (AG) Government of Telangana as per their schedule. College has received rupees six lakhs from the funds of the local MLC, Vassavi club and Lions club of Nagarkaurnool provided water tank facility from their funds.

The IQAC is established as per the NAAC norm, and conducts its regular activities and maintains its records, but it needs to be more proactive. It needs to do more MOU in the proper legal format.

The college has ISO certification 2015 and it participated in NIRF evaluation. The green audit of the college has been done by the imitative of CCE and has received B grade for the same.

The HEI has women empowerment cell and grievances redress all committee to strengthen gender sensitivity and gender equality. However, there is a scope to take more initative in this case. At present the college has LED bulbs and tubes which are used for energy conservation. The college ground has one sensor based light arrangement. The measures for solid waste management are taken with help of local municipal authority. The college has prepared a compost pit for liquid waste management. The septic tanks are made for washroom waste. The E-waste management committee follows the guidelines of the CCE. The college has bore well and rainwater harvesting facility. The college is taking initiative for green campus by encouraging students and teachers to use bicycles and battery powered vehicles. The green audit has been completed by the college. The college has barrier free environment for the disabled and has built ramps for them. The college celebrates national days like: 26th January, 15th August, 2nd October, teacher's day, National Unity day and the 8th March women international day. Other than these regional festivals alike Bhathukamma are celebrated in the college. College takes keen interest to sensitize students and employees towards constitutional obligations like values rights and duties of citizens through curriculum and extracurricular activities. The college offers elective courses related to constitutional obligations in each semester. The NSS unit of the college takes extracurricular activities to educate students about their rights and duties.

College has its own code of conduct and ethics policy and the same has been uploaded on the college website.

Best Practice 1: Book Practice: To inculcate the reading and writing habits among the students college initiates and implements practice of reading as well as book review. Several students participated in this activity.

Best Practice 2: The yoga is practiced once in a week for the students and staff for bringing good health and bringing harmony between mind and body.

Institutional Distinctiveness: The institution practices several activities for transforming students in to good human beings with knowledge, skills and the social commitment through its NSS units which conducts programs and voter enrolment.

'YuvaTharangam' the flagship program initiated by the department of collegate education of Telangana stae government in which students of the college participated and own prizes in Jignasa students study projects.
