

No. 1492023, SCTPC TSSP who has successfully completed his 9 months institutional training, is hereby appointed as PC TSSP w e.f. 26-07-2021 in the time scale of pay Rs. 24280 - 690 - 24970 - 720 - 27130 - 750 - 29380 - 830 - 31870 - 940 - 34690 - 1030 - 37780 - 1110 - 41110 - 1190 - 44680 - 1280 - 48520 - 1400 - 52720 - 1500 - 57220 - 1630 - 62110 - 1730 - 67300 - 1850 - 72850 in RPS 2020. Subsequently he is posted to 4th Bn TSSP in the existing vacancy with immediate effect. Further, the conditions as per service rules abiding his appointment are mentioned below.

As per rule 16 (c) (i) of TS State and Subordinate Service Rules-1996 he will be under probation for a period of 2 years on duty within a continuous period of 3 years from the date of appointment. He must complete (2) years of duty period within (3) years from 26-07-2021, failing which his services will be terminated. The appointment orders are subject to outcome of WPs/SLPs pending if any. He is informed that as per rule 17 (ii) of TS State and Subordinate Service Rules-1996 the appointing authority may, at any time before or after expiry of the prescribed period of probation either extend by not more than one year, whether on duty or otherwise, the period of probation of a probationer, in case the probation has not been extended under sub-rule (b) of this rule or terminate his probation and discharge him from service after giving him one month's notice or one month's pay in lieu of such notice, on account of unsatisfactory performance or progress during training or unsatisfactory performance of duties or unsatisfactory conduct or for any other sufficient reason to be recorded in writing

As per rule 16 (e) of TS State and Subordinate Service Rules 1996, the appointees with in the period of probation period should pass requisite tests/examinations. As per rule 16 f (ii) if within the period of probation a candidate fails to pass such tests or acquire such qualifications as may be prescribed in the rules or in the special rules, the appointing authority shall by order discharge him from service unless the period of probation is extended under the sub rule (b) of Rule 17 and if within such extended period also, the candidate fails to pass such tests or acquire such qualifications, the appointing authority shall discharge him from service.

If his mother tongue is not Telugu or if he has not taken Telugu as second language in 7th or 8th class or any higher examination, he should also get himself qualified by passing the Third language test in Telugu conducted by the TS Public Service Commission within the period of probation prescribed. If he fail to pass the third class language test in Telugu, his increments in the time scale of pay shall be postponed without cumulative effect till he pass the test and if he do not pass the test within a total period of 3 years from the date of appointment, he will be discharged from service, unless he is given additional chances for passing the test by the Director General of Police, TS. Hyderabad who may for adequate reasons to be recorded in writing give a probationer two successive additional chances for passing the test in Telugu.

He is further informed that he shall serve the Police Department for a minimum period of 5 years as per the agreement bond given by him at the time of undergoing Stipendiary Cadet Training, failing which he shall be liable to repay the pay and allowances or any other remuneration received by them in addition to the amount spent by the Government on his training together with interest thereon. He shall be liable to serve in any part of the Telangana State including deputation units or when ordered by the Government of Telangana in any other State of the Indian Union.

- If he is selected for appointment by direct recruitment for another post, category or class within same or different services and appointed to it in the State Govt, his lien on the service of probationary right from part of the service under the State Government which he was holding prior to such appointment by direct recruitment shall be retained for a period of 3 years under Rule 30 (e) of Telangana State & Subordinate Service Rules, 1996
- The In-service candidate who has been selected and appointed under direct recruitment will get protection of his pay as per Rules.
- vi) He should occupy Government quarter and stay in Police lines of the Bns / Units wherever the quarter is available.
- viii) He will commence his probation w.e.f.26-07-2021 under rule 16 & 17 of Telangana State Subordinate Service Rules 1996.
- viii) As per the GO Ms No.655 Fin. (Pension-I) Dept., dt: 22-09-2004 PCs come under new Contributory Pension Scheme introduced by the Government of Telangana State w.e.f. 01.09.2004.
