



SIGNATURE OF THE PRESIDENT/SECRETARY.

FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS

01. PRESIDENT: He is the head of the Society and presides over the meetings of the General Body and Executive Committee. He can cast his vote in case of tie in decision making. He can supervise all branches all the branches of the Society.
02. VICE PRESIDENT: He shall assist the President in discharging his duties. In the absence of the President he shall perform the routine duties of the President as entrusted by him.
03. SECRETARY: He is the chief executive of the Executive Committee and is a custodian of all the records relating to the Society and responsible to run routine administration, to correspond on behalf of the Society. He has to summon and convene the meetings of the Society. He has to take on record all minutes of the meetings of Executive Body and General Body of the Society convened with the permission of the President. He shall guide the Treasurer in preparing the Budget and expenditure statement of the Society.
04. JOINT SECRETARY: He has to do the work that may be entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.
05. TREASURER: He is responsible for all financial transactions and funds of the Society. He has to main books of account properly supported with vouchers. He has to prepare the accounts of the Society jointly with the Secretary or President. He has to get the books of account audited by the Auditor appointed by the Executive Committee.
06. OFFICE BEARERS: They are responsible persons to attend such activities of the Society, which the Executive Committee entrusts to them.
07. ELECTIONS: Election for the posts of Executive Body members shall be conducted for every two years in the Annual General Body Meeting or a specially convened General body Meeting, for the said purpose.
08. QUORUM: Half of the total members for General Body Meeting and $\frac{1}{4}$ for Executive Committee meeting.
09. FUNDS:
- i) The funds shall be spent only for promotion and to the attainment of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of the members of the Society through any means.
 - ii) Any surplus funds available with the Society shall be invested in such modes as may be prescribed U/s.11(5) of the Income Tax Act from time to time.
 - iii) The Society shall be eligible to raise, borrow any loans, funds from any individual firm, Company, Bank or any other financial institution to meet its financial requirements.
 - iv) The funds of the Society shall constitute from the donations given by the General Public, subscriptions from its members, fees or remuneration collected from the users of the services of the Society.


SIGNATURE OF THE PRESIDENT/SECRETARY

10. BOOKS OF ACCOUNT: The Accounts of the Society shall be maintained or caused to be maintained by the members of the Executive Committee, of the Society for recording all the inflows and outflows of the Society, and shall be closed by the end of March every year. Annual Accounts of the Society shall be drawn and got audited by a Chartered Accountant prior to the presentation of the same before the General Body for their adoption or approval. Any member of the Society is entitled to inspect the records at the premises of the society during working hours.
11. BANK ACCOUNT/S: Bank Account(s) of the Society shall be opened in the name of the Society in one or more scheduled banks as may be decided from time to time by the Executive Committee and shall be operated by such of those office bearers as may be specified by the Executive Committee from time to time.
12. AMENDMENTS: No amendment or alteration shall be made in the aims and objects of the Society unless it is voted by 2/3rd of its members present at a special meeting convened to the purpose and confirmed by 2/3rd of the members present at a second special meeting, and shall be carried out in accordance with Section 8 of the A.P. Societies Registration Act, 2001.
13. LIABILITIES OF THE SOCIETY AND ITS MEMBERS:
- i) The liabilities of the Society are limited to the fixed and financial assets of the Society, and the members of the Society are not in any way responsible for the liabilities of the Society. The members will however be responsible for the personal guarantees given on behalf of the Society for any loan raised by the Society.
 - ii) None of the Office bearers of the Society shall be allowed to use funds or the assets of the Society or allowed to derive any benefit either directly or indirectly from the Society as stipulated U/s.13(1) (c) of the Income Tax Act, 1961.
14. LEGAL PROCEEDINGS: Society may sue or be sued in the name of PRESIDENT, as per the provisions laid down in Section 19 of A.P. Societies Registration Act, 2001.
15. WINDING UP: In case the Society has to be wound up, the property and funds of the Society that remain after discharging all the liabilities, if any, shall be transferred or paid to some other institution with similar aims and objects and which is registered under section 12 A of the Income Tax Act, 1961.
16. APPLICATION OF THE ACT: All the provisions which are not specifically mentioned herein shall be governed under all the sections of the A.P. Societies Registration Act, 2001.
17. CERTIFICATE: Certified that this is the correct copy of the Rules and Regulations of the Society.
