On the basis of the recommendations of the University Inspection Committee, which visited your college to verify the infrastructural facilities made available by the College and to verify the extent of fulfillment of conditions stipulated in the affiliation orders 2011-12 and compliance report submitted vide reference cited, the University has accorded approval for grant of extension of provisional affiliation for the academic year **2012-13** to your college to offer following Under Graduate courses/Combinations as detailed below with the intake shown against each, subject to fulfillment of the following conditions and general rules of affiliation.

Conditions :

1. The required independent infrastructure viz., 9 class rooms, five labs and all other necessary facilities for Degree College to be provided.
2. All the laboratories to be strengthened by procuring required equipments, instruments, glassware & Chemicals with proper water and gas connections.
2. Library to be established by procuring a minimum of five new titles / editions **each** in the subjects offered by spending Rs. 1,00,000/-
3. Teaching diaries and student attendance registers are to be maintained as per norms.

NOTE: Candidates are to be admitted as per the sanctioned intake mentioned in the OU affiliation order and the admitted list need to be submitted by the date stipulated to the Director, Directorate of Academic Audit, OU.

GENERAL GUIDELINES:

1. Non- Compliance of the conditions laid down by the Inspection Committee within the stipulated time shall lead to withdrawal of affiliation.
2. The College should appoint teaching staff through duly constituted Selection Committee as per OU norms and also obtain University approval for the same.
3. The Management is warned not to admit the students over and above the ceiling strength.
4. **As per the decision of the Executive Council if the College makes admissions over and above the permitted strength in any Course, that course of the college will be automatically disaffiliated.**
5. For Change of Premises/Management/Society/Name of the College the Management should approach the University before 31st December of each year following the guidelines issued by the APSCHE and which were communicated to your College Vide Lt.No.437/MR/H/03-04/Acad/IV-2 &3 , Dt.08.04.2004.. Any violation in this regard will lead to penal action including disaffiliation.
6. The College is required to maintain institutional records as given in proceedings No.423/AAC/96, dt 04-05-1996 and to keep them ready for inspection.
7. The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/ IUTF /Academic records, fees etc. as prescribed by the University from time to time.
