The Government is implementing Rashtriya Uchchatar Shiksha Abhiyan (RUSA) a Centrally Sponsored Scheme (CSS) jointly funded by the Central and State Governments towards attaining higher levels of access, equity and excellence in State Higher Education system. As part of the scheme, the Government Degree Colleges are provided with grants under Component-V (upgradation of existing Degree Colleges to Model Degree Colleges) @Rs.4.00Crore per College towards creation of New facilities, Renovation/Upgradation of existing facilities and New Equipment/Facilities.

The Project Approval Board (PAB), vide ref.1st cited approved funding grants to three (03) Government Degree Colleges under Component-V for upgradation to Model Degree Colleges and MHRD vide ref.2nd cited released grants. The Govt., vide ref.3rd cited, directed the CCE to issue Administrative Sanction Order (ASO) to these institutions to implement RUSA.

In this connection, the Commissioner of Collegiate Education and the State Project Director, RUSA hereby accords Administrative Sanction for an amount of Rs.4.00Crore (Rupees Four Crore only) each to the Principals of GDC(W) Karimnagar, GDC(W) Hussainialam, Hyderabad and Pingle GDC(W) Waddepally, Hanamkonda, Warangal District. Out of sanctioned Rs.4.00crore, Rs.1.40 crore each is earmarked towards creation of (i) New facilities and (ii) Renovation/Upgradation of existing facilities and Rs.1.20 crore is earmarked towards (iii) New Equipment/Facilities as mentioned in Annexure of this proceeding in their respective colleges.

Further, RUSA is a norm based and outcome dependent funding program and hence is to be implemented in conformity with the RUSA guidelines. Therefore, it is requested to execute the works as per the RUSA norms and submit the UC.

The Principals of the Government Degree Colleges are hereby instructed to approach the executing agency TSEWIDC and take necessary action duly following the procedure in vogue towards execution of works/procurement of equipment and ensure that the works be completed by 2016-17 as per RUSA norms.
