PRIVATE DEGREE COLLEMES - Admission of Certain Un-Aided Degree Colleges to Grant-in-Aid - Orders - Issued.

Government in G.O.2nd read above, have issued revised orders admitting certain Junior/Degree Colleges to Aid with effect from 16-4-1990 in relaxation of the rule of communal reservation and the provisions of Daployment Act/Rules, provided that the Colleges have satisfied all other conditions to allow Grant-in-Aid and also make good the back-log of SC/ST vacancies in future appointments. These orders were issued in modification of the eaplier orders issued in the G.O.1st read above.

2. The Director of Collegiate Education in his letter 3rd read above has submitted proposal for admitting certain Degree Colleges to Grant-in-Aid subject to the fulfilment of the conditions stipulated by the Grant-in-Aid committee. The Director of . Collegiate Education has furnished the particulars regarding the fulfilment of the conditions like payment of Corpus Fund etc., by these institutions and has requested the Government to admit these colleges to Crant-in-Aid as per the recommendations of the Grant-in-Aid committee.

5. Government, after careful consideration of the proposal of the Director of Collegiate Education and the recommendations of the Grant-En-Aid Committee, hereby admit the 10 Degree College listed in the Annexure-I to this order to Grant-in-Aid, on the analogy of the orders issued in the G.O.second read above. Accordingly Government direct that:-

The 10 Private Degree Colleges: (shown in Annexure) which have made appointments to Teaching and Non-teaching posts in contravention of the rule of communal reservations be admitted to Grant-in-Aid with effect from 16-4-1990 or the date of eligibility whichever is later as shown against each college, provided they have fulfilled all other conditions to make them eligible for Grant-in-Aid.

The Roster points on which appointments were made in contravention of rule of communal reservations in respect of teaching posts/prior to 1-10-1985 and Non-teaching posts in the Degree Colleges upto the date of this orders be carried forward;

) All fature appointments to the teaching and Non-teaching posts in their respective Zones/units of appointments should first be made from the reserved category condidates cily, to clear the back-log of reserved vacancies, so carried forward.

An under-taking shall be obtained from the private managements of these institutions to the effect that they shall abide by this decision of the Government to make good the back-log of SC/ST vacancies and also to the effect that all future appointments shall be made in accordance with the procedure laid down by the Government and by following the rules of communal reservation, failing which Grant-in-Aid shall be stopped forthwith besides taking suitable action against the managements in accordance with the provisions of A.P. Education Act, 1982.

4. Government also direct that the appointments of teaching and Non-teaching staff made without following the provision of employment Exchanges Act shall be deemed to have been condoned in relaxation of the provisions of the said Act and Rules thereunder for the purpose of admission of the said Degree Colleges to Grantin-Aid if they are otherwise found eligible for admission to Aid. But it is hereby made clear to the private Managements that hereafter such irregular appointments made without the medium of the Employment Exchange will result in withdrawal of Grant-in-Aid.

Aid at the minimum of the respective pay scale.

5. The admission os these 10 Private Degree Colleges to Grantin-aid is subject to observ ance of the general or special conditions imposed by Government from time to time in respect of Grant-in-Aid institutions.

7. Government further direct that institutions as listed in Schedule to this order be admitted to Grant-in-Aid with effect from 16-4-1090 or the date of eligibility whichever is later as shown against each college, with courses and sections indicated against them-The details of Teaching and Non-teaching posts admitted to Grant-in-Aid in respect of each of these 10 Private Degree Colleges are furning shed in the Annexure-II to this order.

8. Government sanction is hereby accorded for payment of Grant-in-Aid, not exceeding Rs.1,85,82,852/- (Rupees One Corre Eighty five lakhs Seventy two thousand Eight hundred and Fifty two only, to these 10 Private Degree colleges during the financial year 1991-1992 (i.e. from 16-4-1990 or the date of eligibility upto 26-2-1991 and from 1-3-1991 to 29-2-1992) as per institution-Wise... break-up given in Annexure-II-to-this order. This amount shall be released immediately and paid directly to the employees in accordance with the procedure laid down in this regard.

9. The expenditure shall be debited to "2202 - General Education 05 - Universities and Higher Education - 194 Assistance to Non-Government colleges and institutions - 5.H.(06) Assistance to Aided Colleges Grants-in-Aid towards salaries (in respect of Degree Colleges)".

10. This order issues with the concurrence of Finance and Planning (EE) Department, vide their U.O.No.D-91-09/175/901/EE/91, dated 3-5-1991.

Accordingly, the cadre strength of each category of Teaching Posts subject wise pertaining to the Government Degree Colleges annexed to these proceedings is fixed with reference to the Scale Register and recommendation of the committee constituted for Reorganization of courses.

The Principals of all Government Degree Colleges in the State are informed that the earlier orders issued with regard to cadre strength of Teaching Staff of their respective Colleges communicated vide this office Proceedings Rc.No.81/GDC&CS/2015,dated:28.08.2018,are superseded by these orders (As per Annexure).

Therefore, all the Principals of Government Degree Colleges in the State are informed to make necessary entries with regard to the revised cadre strength of Teaching Posts subject wise in the respective staff registers and scale registers, and report compliance and further directed to maintain a permanent record for the posts now communicated without fail.
