



approached Hon'ble High Court and filed W.P.No.7417 of 2016. While the W.P.No.7417/2016 is pending before the Hon'ble High Court, the applicants in the O.A.No.4710/2015 have filed a petition seeking to withdraw the said O.A. filed by them. Considering the petition, the Hon'ble High Court by an order dated:28.04.2016 has disposed off the Writ Petition by permitting the applicants in O.A.No.4710 of 2015 to withdraw pending on the file of the Hon'ble APAT., Hyderabad.

The Junior Lecturer now promoted is informed that his/ her services as Lecturers in Government Degree Colleges are purely temporary and liable to be terminated at any time without notice and without assigning any reason what so ever for such termination. He/She is also informed that his/her appointment as Lecturer is ordered without prejudice to the claims of other senior lecturers if any, in the subject in the Zone.




