STOP EVE-TEASING !

Sex teasing is a violation encountered by women all over the world. It is a grave offence which could in certain circumstances result in their punishment.

In certain instances sex teasing could be an offence and if anybody is proven to be a public enemy.

Women need not and should not suffer in silence when they are victims of sex teasing. They should promptly report it and ensure that provisions are provided.

Such women grapple with the problem of sex teasing in all examples, both in work, in schools, colleges, public transport, roads and every other possible public place.

The sections dealing with Eve-teasing are:

Section 294

This section penalises annoying acts of obscenity by a man against a woman in a public place. Such acts include but are not limited to singing songs, reciting poems, shouting words or making gestures against a woman which are obscene in nature.

Examples:
 When an adult (18 or more) obscene remarks at a lady passenger.
 When a man tries to annoy a girl by singing vulgar songs.

Section 354

This section provides punishment for violation of sex teasing which leads to the loss of mental harassment and consent to seduction and physical abuse.

Section 354 applies to acts of the accused which not only cause insult and outrage the modesty of a woman, but also causes or threatens to cause physical harm to her.

It is non-bailable and non-compoundable and punishable with imprisonment for a term of 1-3 years.

Policy against Sexual misconduct/ Harassment, eve teasing, stalking

1. The college has 'zero tolerance' policy for any acts of sexual harassment. A standing committee for prevention of sexual harassment/ eve teasing has been constituted to look into any complaint in this regard.

2. Objectives of the Committee are to:

- i. prevents discrimination and sexual harassment against women, by promoting gender equality among students and employees;
- ii. Make recommendations to the College authorities for prohibition, resolution, settlement and prosecution of acts of discrimination and sexual harassment against women, by the students and the employees.
- iii. Deal with the cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment;
- iv. Recommend appropriate punitive action against the guilty party to the college authorities.

3. Procedure:

The Committee shall deal with all the complaints of sexual harassment relating to students, staff and faculty studying/working at GDC Shadnagar.

The written complaint of discrimination or sexual harassment may be addressed by the victim or a third party to the Convener of the Committee on Sexual Harassment and Eve Teasing. If the complaint is made to the Head of the Department or any Committee Members of the college, the same shall be forwarded it to the Convener of the Committee.

4. According to the Hon'ble Supreme Court guidelines, any or a combination of the following acts shall be deemed as "unwelcome" sexually determined behaviour (whether directly or by implication):

- i. Physical contact and advances.
- ii. Demand or request for sexual favours.
- iii. Sexually coloured remarks.
- iv. Showing pornography
- v. Other unwelcome physical, verbal or nonverbal conduct of sexual nature.

5. In addition, the following acts shall also amount to sexual harassment: *

- i. Eve-teasing
- ii. Unsavory remarks.
- iii. Jokes causing or likely to cause awkwardness or embarrassment.
- iv. Innuendos and taunts.




- v. Gender-based insults or sexist remarks
- vi. Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like.
- vii. Touching or brushing against any part of the body and the like.
- viii. Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings.
- ix. Forcible physical touch or molestation.
 - x. Physical confinement against one's will and any other act likely to violate one's privacy.
 - xi. Non-consensual communication, including face-to-face communication, telephone calls, voice messages, e-mails, text messages, written letters, gifts, or any other communications that are unwelcome.
 - xii. Use of online, electronic or digital technologies in connection with such communication, including but not limited to:
 - ◇ Posting of pictures or text in chat rooms or on websites;
 - ◇ Sending unwanted/unsolicited email or talk requests;
 - ◇ Posting private or public messages on Internet sites, social networks, and/or school bulletin boards;
 - ◇ Installing spyware on a person's computer;
 - ◇ Using Global Positioning Systems (GPS) or similar technology to monitor a person.
 - xiii. Pursuing, following, waiting for, or showing up uninvited at or near a residence, workplace, classroom, or other places frequented by the person.
 - xiv. Surveillance or other types of observation including staring or "voyeurism"
 - xv. Trespassing
 - xvi. Direct verbal or physical threats
 - xvii. Gathering information about an individual from friends, family, or co-workers
 - xviii. Accessing private information through unauthorized means
 - xix. Threats to harm self or others
 - xx. Defamation and/or lying to others about the person, or
 - xxi. Using a third party or parties to accomplish any of the above



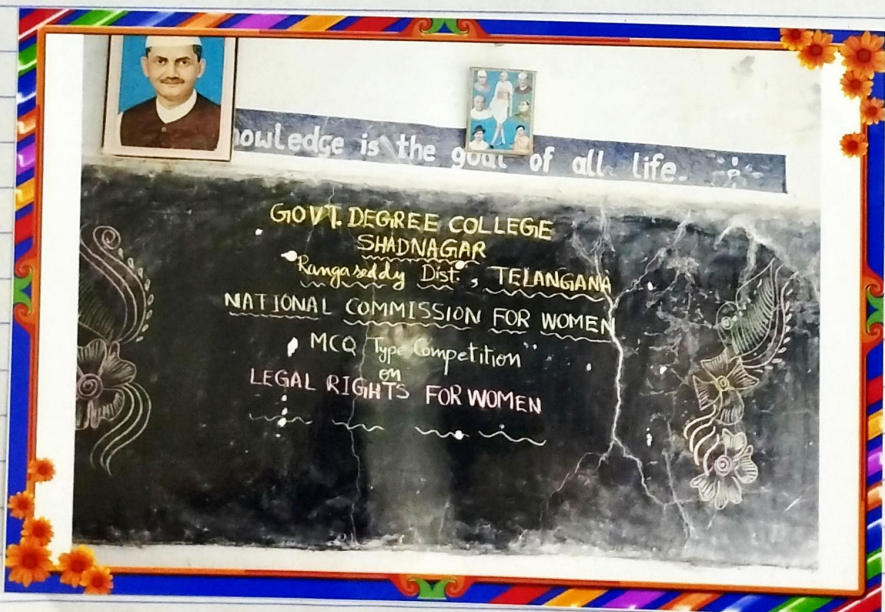
③ MCQ Type Competition on "Legal Rights for Women"

The Women Empowerment Cell convenor & lectures in Physics at GVC Shadnagar Smt. Nughat Naseem immediately contacted her parents & inlaws.



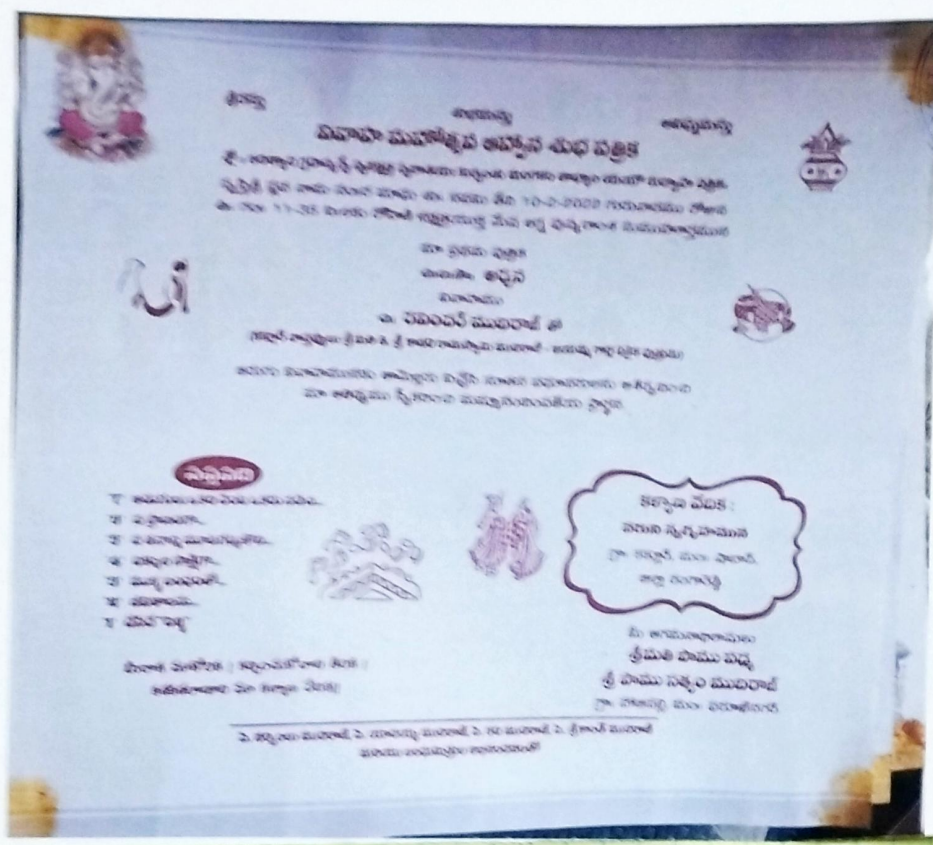


She explained them the importance of course completion.
