## Context:

The Memorandum of Understanding (MoU) is made on 29-11-2021 between **Tara Govt. Degree College (A), Sangareddy**, India hereinafter known as represented by its authorized officer "Principal" and **Government City College (Autonomous), Hyderabad** hereinafter referred to as "GCC (A), Hyderabad" represented by its authorized officer "Principal"

### A. About Tara Govt. Degree College (A), Sangareddy:

**Tara Govt. Degree College (A), Sangareddy** is a Public Institute located in Sangareddy, Telangana and was established in the year 1977. The college is accredited by The National Assessment and Accreditation Council (NAAC) and is affiliated to Osmania University, Hyderabad.

The Institute offers various Under-Graduate Courses namely B.A., B.Com, B.A (Hons.), and B.Sc. with 51 combinations, and 11 Post-Graduate courses such as MA (English), M.Com, M.Sc..

This agreement is being made between the colleges to encourage the UG and PG Students to improve language and literature skills. The parties are desirous of recording the terms and conditions of their agreement in writing.

### **NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSED AS UNDER**

**Scope: The Scope/ Objectives of the MoU are as follows:**

- Facilitate Accreditation by NAAC (National Assessment and Accreditation Council).
- To enable the students comprehend the spoken form.
- To develop students' ability to use English in day-to-day life and real life situation.
- To understand the written text and able to use skimming, scanning skills.
- To write simple English to express ideas etc.
- To be able to speak English fluently and accurately.
- To think in English and then speak.
- To be able to talk in English.
- To be able to compose freely and independently in speech and writing.
- To be able to read books with understanding.
- To acquire a vocabulary of 2500 words.
- Ability to use reference material such as encyclopaedia, dictionary, etc.
- Certificate programmes for Students on communication skills in English
- Faculty and Student exchange programmes
- Joint language orientated research work
- Facilitate Student Mini Projects and Final Year Projects.
- Conduct Inter-Collegiate competitions for language development and a healthy spirit.

### **B. GENERAL TERMS & CONDITIONS:**

- a) This MoU shall be effective from the date of signing of the parties and will remain in force for a period of **three (3) years wef, 2021-2022.**
- b) This MoU will be reviewed by the partnership committee members from time to time and may be amended with the consent of both the parties and thereafter confirmed in writing.
- c) The parties agree and acknowledge that no other rights are granted except as explicitly stated herein.
- d) Neither party shall transfer or assign its interests, obligations or rights in this agreement without the written consent of the parties, provided that such consent will not be unreasonably withheld.

- e) Neither party shall be liable by reason of failure or delay in the performance of its obligation under this MoU, if such failure or delay is caused by the acts of God, Strikes, Lockouts or any other causes beyond its control and without its fault or negligence on mutual agreement.
- f) Any other arrangements or activities or commitments shall be made on mutually agreed terms from time to time.
- g) No amendments to the MoU shall be valid unless executed in writing and signed by both the parties.
- h) Nodal Officer will be nominated from respective university/ college for carrying out activities with respect to Students, Faculties and Non-Teaching Staff.
- i) Financials commitments if any can be decided on mutual agreement before commencement of each activity.

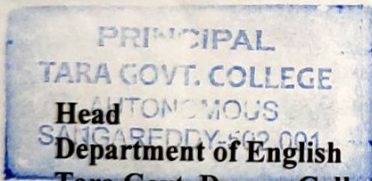
**C. TENURE AND TERMINATION:**

5. Both the parties may also exchange services, time to time, if need be, that are not mentioned in this document.





## MEMORANDUM OF UNDERSTANDING (MOU)

Whereas the above named institutions recognize that academic collaboration would be of mutual benefit and would provide strengths in Research and Education and their mutual interest in engaging themselves in academic co-operation.

### Scope

- The scope of this MOU covers the knowledge sharing of mutual interest
- This MOU is not legally binding, except as specifically set out below.
- Nothing in this MOU is intended to, or shall be deemed to, establish a joint venture between the parties, constitute either party as the agent of the other party nor authorise either of the parties to make or enter into any commitments for, or on behalf of the other party.
- This MOU can be amended only in writing and subject to agreement by both the two parties.

### Objectives of the Agreement:

1. Joint Research Programme.
2. Joint holding of Conference/ Seminar/Workshop/Training/Symposia etc.
3. Exchange of Knowledge Resources.
4. To Promote Research Collaboration through sharing of Information, Samples, Digital Records, data photographs etc.
5. To Improve Inter- Institutional contacts by facilitating access to field areas, libraries through intellectuals.

6. Enhancing skills of Students/ aspirants through Special Lectures, Workshops and Symposiums.

**Role of the Institution:**

1. The Institutions shall provide the available infrastructure & basic amenities such as electricity, water, telephone, etc; suitable and ready for delivering the Special Lecture, Workshop, Symposium and other Academic Activities.
2. The Institutions shall cooperate as a partner for joint activities for mutual benefits.

**Joint Responsibilities:**

Promotion for the programmes undertaken shall be advertised/ propagated through respective websites of the parties.

**Duration and Termination of Agreement**

This renewal of MoU shall be effective from the date of signing and shall remain in force for a period of three years. In case, the associate intends to terminate the contract, it shall communicate the institution six months in advance.

**General Provisions**

1. Both the parties have full power and authority to enter into this MoU and take any action, execute any documents required by the terms hereof; and that this MoU entered into has been duly and validly executed and delivered. And this is a legal, valid and binding obligation enforceable in accordance with the terms hereof; and that the executants of this MoU are duly empowered and authorised to executive this MoU and to perform all its obligations in accordance with the terms herein.
2. This agreement shall not be binding for any other agreement for either party. Parties shall be free and independent to carry on other services besides that covered under the scope of this MoU.

**Notices**

Unless otherwise provided herein, all notices or other communication under or in connection with MoU shall be given in writing and may be sent by personal delivery or post or



courier of facsimile. Any such notice or other communication will be deemed to be effective if sent by personal delivery, when delivered, if sent by post, two days after being deposited in the post and if sent by courier, one day after being deposited with the couriers, & if sent by facsimile when sent (on receipt of a confirmation to the correct facsimile number).

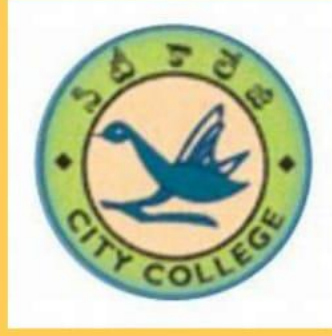
### For The Academic Year 2021-22 Poetry recitation competition on 21 March 2022
