ANTI-RAGGING COMMITTEE

FOR THE ACADEMIC YEAR 2021-2022

As per the UGC Regulations on Curbing The Menace of Ragging in Higher Educational Institutions, 2009, the Anti-Ragging Committee was constituted in Government Degree College, Mancherial to eradicate, if any:

- a) Misconduct of any student either in spoken or written form or any action that has the effect of harming others
- b) Indulging in undisciplined activities that cause physical or psychological harm or fear or apprehension
- c) Asking others to do things that they normally will not do and causes a sense of shame or emotional embarrassment
- d) Any act that disrupts others academic activity
- e) Financial extortion or forceful monetary burden on a fresher or any other student
- f) Any act of physical abuse including sexual, homosexual assaults stripping of clothes, forcing obscene lewd acts and gestures causing physical and mental torture
- g) Any act of abuse by spoken words, emails, posts, public insults to derive sadistic pleasure
- h) Any act that affects the mental health and self confidence of any student with or without intent to derive sadistic pleasure or priority over others

Roles and Responsibilities of the Committee:

- 1) To ensure compliance with the provision of UGC regulation 2009 at the institute level.

2) To monitor and oversee the performance of anti ragging squad in prevention of ragging in the institution.

This committee proclaims that ragging is totally prohibited in Government Degree College, Mancherial, inside and / or outside the campus and anyone found guilty of ragging and / or abetting ragging whether actively or passively, or being a part of conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations 2009 as well as under the provisions of any penal law for the time being in force.

Punishments for Ragging

Every single incident of ragging, a FIR shall be lodged without exception by the college authorities with the local police. In addition one or any combination of the following punishments can be awarded:

- a) Cancellation of admission
- b) Suspension from attending classes
- c) Withholding / withdrawing scholarship / fellowship and other benefits
- d) Debarring from appearing in any test / examination or other evaluation process
- e) Withholding results
- f) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc
- g) Suspension / expulsion from the hostel
- h) Rustication from the institution for period ranging from 1 to 4 semesters
- i) Expulsion from the institution and consequent debarring from admission to any other institution

The committee here nominates the following faculty as the Anti-Ragging squad to regular inspection of any occurrence of ragging incidents.

The members of the Anti-Ragging Squad are as follows:

1. Chairman – Dr. V. Chakrapani
2. In charge– M. V. Patwardhan
3. Member – Sri. M. Kishore Kumar, NSS Unit-I officer
4. Member – Dr. Mahatma Santhosh, NSS Unit-II officer
5. Member – M. Kanakalaxmi, Lecturer in Political Science

The duties of the Anti- Ragging Squad are: (a) To make surprise raids on hostels and other places vulnerable to incidents of and having the potential of ragging. (b). To conduct on the spot enquiry in to any incident of ragging.

It is resolved that the Anti-Ragging Committee along with the Anti-Ragging Squad have to prepare the Annual Anti-Ragging Action Plan and it is to be submitted to the Chairman at the earliest.

It is also resolved that the Anti-Ragging Committee and Squad have to conduct meetings at the beginning of the semester and at the end of the semester.


