2.3.2 - Students mentoring system available in the institution? Give details. (maximum 500 words)

YES. Teachers are natural mentors of their students. To formalize the same, and as directed by University rules, College has a proper student mentoring system in place. In the beginning of each session, after the admission process is over, each department is required to assign a teacher mentor to each student of first year. As an example of Mentor Mentee ratio, if a department has 10 teachers and 100 students, then each teacher will be mentor to 10 students. The mentor is required to prepare a list of his/her mentee students and get acquainted with them. Mentors conduct a meeting with their mentees to discuss their problems and issues. These issues can be related to college infrastructure, academic, non academic, or personal as well. The mentor tries his/her best to find solutions to any such issues arising in student's life and informs the college administration about the matter if need be. Being away from protection of home and parents can be really challenging for young students and thus such students need special care and attention. Some cases have been reported where students approach their mentors to discuss about problems arising in their homes, or problems related to their landlords, or some issues with their friends / classmates, or something related to college infrastructure and facilities. They freely tell their problems either orally or in writing to their mentors, who in turn listen to them patiently and solve their issues as much as possible. Although students are free to approach their teachers anytime if any issue is disturbing his/her routine, still, the system of mentor – mentee builds an extra confidence and sense of security

among students. This whole system leads to a better connection between students and teachers and helps build a friendly and cordial relation between them. Students get a sense of protection because they know that they have someone to go to in case of any eventuality.



BEST PRACTICE - I 1. TITLE OF THE PRACTICE: ONLINE TEACHING 2. GOAL: 1. To ensure the completion of syllabus according to the academic planner of each Department. 2. To encourage teachers to adapt to technological advancements 3. To face pandemic situation in a bold way 4. To improve pass percentage. 3. THE CONTEXT: The syllabus coverage in some cases is being hurried and towards the end of the semester, information is being crammed at once. This sluggish coverage initially and hurried coverage later should be avoided giving enough time to students in comprehending the topics and assimilating the facts. The teachers find it difficult to keep pace with the techno - savvy student learners. It has become essential for some of the teachers to adapt to the latest pedagogic styles and include ICT in class room teaching. The mismatch between the student learner and the teacher in the use and comfort of handling varieties of tools available for teaching - learning needs to bridged. During the fag end of the semester, COVID-19 pandemic affected teaching-learning very badly. Hence, it became necessary to search for a way to go ahead with the academic planner. 4. THE PRACTICE: 1. Created whatsapp groups of students to sensitize them on need for wearning masks, cleaning hands with sanitizer or soap regularly, maintaining 2 meter distance with others avoiding unnecessary step out and quiting social gatherings. 2. Used online platforms for synchronous teaching by sharing study material and assignments. 3. Used online platforms such as zoom, google meet, etc. for synchronous teaching. 4. Institution is meeting regularly online to discuss the academic planning, curricular aspects and the progress of online teaching. 5. EVIDENCE OF SUCCESS: Syllabus is completed in time and the students who are in remote areas are also able to continue education. 6. PROBLEMS ENCOUNTERED AND RESOURCES REQUIRED: Initially, it was difficult for teachers and students to adapt to the technology. Food internet facility is required. BEST PRACTICE - II 1. TITLE OF THE PRACTICE:

Evaluation of Teachers by Students 2. OBJECTIVE OF THE PRACTICE: 1. To encourage self-improvement in teaching skills 2. Need Addressed and the Context Teacher development is not taken seriously because the feedback of stakeholders is seldom obtained. The need addressed, therefore is to provide teachers an opportunity to look at themselves through the eyes of learners. 3.
