

#### GENERAL GUIDELINES:

3. The Management is warned not to admit the students over and above the ceiling strength.

For Change of Premises/Management/Society/Name of the College the Management should approach the University before 31<sup>st</sup> December of each year following the guidelines issued by the APSCHE and which were communicated to your College Vide Lt.No.437/MR/H/03-04/Acad/IV-2 &3 , Dt.08.04.2004.. Any violation in this regard will lead to penal action including disaffiliation.
7. The College is required to maintain institutional records as given in proceedings No.423/AAC/96, dt 04-05-1996 and to keep them ready for inspection.
- 8: The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/ IUTF /Academic records, fees etc. as prescribed by the University from time to time.






