

ORDER :

In pursuance of selection of candidates for the post of Assistant Commercial Tax Officer made by Telangana State Public Service Commission Hyderabad and allotment of provisionally selected candidates to Hyderabad Rural (Nodal) Nodal Division of Zone-VI vide references 1st & 3rd cited, Sri/Smt. **M SWAPNA**, is appointed as Assistant Commercial Tax Officer in the pay scale of 28940-820-30580-880-33220-950-36070-1030-39160-1110-42490-1190-46060-1270-49870-1360-53950-1460-58330-1560-63010-1660-67990-1760-73270-1880-78910 in PRC, 2015.

His/her appointment is subject to the following terms & conditions.

1. The above appointment of the individual is purely temporary under Rule 10(a) of the Telangana State and Sub-Ordinate Service Rules, 1996 and is liable to be terminated at any time without any prior notice and without assigning any reasons.
2. That the services of the candidates will be regularized subject to his character and antecedents being found satisfactory on verification and his/her physical fitness and subject to satisfactory completion of mandatory training program as prescribed by the Joint Commissioner of State Tax concerned.
3. That he/she is required to submit the original documents in respect of academic qualifications, age/community and local cadre etc., to the concerned Drawing and Dispersing Officer for verification before permitting then to join duty.
4. He/she shall undergo mandatory training,
5. The reservation & appointment to BC-E group will be subject to the adjudication of the litigation pending before the Hon'ble Court.



6. As per rule 11(a) of the Telangana State and Sub-Ordinate Service Rules, 1996 read with G.O.Ms.No. 340 GA (Ser-D) Department, dt.23-07-1999, a candidate, selected for appointment by direct recruitment either through the Telangana State Public Service Commission or through any other agency, shall be required to join the post for which he/she has been selected within (60) days taking the date of dispatch (by register post with acknowledgement due) of the appointment order as crucial date of reckoning the prescribed time limit. If he/she does not join the post within the stipulated period, the offer of the appointment shall be treated as automatically cancelled and the name of the candidate shall be deemed to have been omitted from the list of approved candidates. In view of this, the candidate is instructed to report to the Joint Commissioner(ST) within (60) days from the date of dispatch of these proceedings.
7. That during the period of training, he/she shall draw the minimum of the scale of pay of ACTO's. The scale of pay of ACTO's is Rs. 28940-820-30580-880-33220-950-36070-1030-39160-1110-42490-1190-46060-1270-49870-1360-53950-1460-58330-1560-63010-1660-67990-1760-73270-1880-78910 in PRC, 2015.
8. That he/she will be on probation for a period of two years on duty within a continuous period of three years. The period of training counts towards probation and for all other purposes as per Sub-rule (a) of Rule 8 of TCTSS Rules.
9. During the period of probation, he/she shall pass the following departmental test:
 - i) A pass in the Government Technical examination in Book Keeping by the lower grade or any other qualification which is recognized as equivalent by the State Government.
 - ii) A pass in the Account Test for Sub-Ordinate Officers Part-I of Account Test for Executive Officers, and
 - iii) A pass in Part-I Commercial Taxes Laws and Rules and Part-II Other Laws as per the syllabus prescribed by the Government from time to time.
10. That the seniority of the candidate shall be strictly in accordance with merit list sent by the TSPSC duly following the rule of reservation, prescribed in Rule 22 of the Telangana State and Sub-Ordinate Service Rules, 1996.
11. That in case he/she is already in Government Service/ Government undertaking, he/she will get himself/herself relieved properly from the parent Department under intimation to this Department.

12. That he/she should also pass the second class language Test in Telugu (full test) during the period of probation, failing which the probation shall be extended and the increments in the time scale of pay shall be postponed without cumulative effect until the Test is passed. As per Rule 14(a) of the Telangana State and Sub-Ordinate Service Rules, 1996, a person who has passed the SSC or its equivalent examination or with Telugu as one of the subjects, shall be exempted from passing the 2nd class language test in Telugu and that he/she shall obtain a specific exemption from the competent authority.
13. If he/she fails to pass the Examination and Tests prescribed within the time, specified, all his increments in the time scale of pay shall be postponed with cumulative effect till he/she passes the Examination and if he/she does not pass the Tests within a total period of three years from the date of appointment he /she shall be discharged from the service and penal action shall be initiated as per Rules and penalty shall be imposed.
14.
