ORDER

Government sanction the starting of a Government
Degree College at Devarakonda in Nalgonda District
from the Academic year 1981-82, subject to fulfilment
of the following conditions:-

- (i) The College Committee concerned should credit into Government account an amount of Rs. 2.00 lakhs (Rupees Two lakhs only) immediately i.e., before the starting of the college;
- (ii) The College Committee should provide temporary accommodation immediately for locating the college and also (25) acres of land for construction of permanent buildings in future. (The additional accommodation will have to be found by the College Committee);
- (iii) The College Committee should provide furniture, equipment and books required for the college as indented by the Principal immediately. For this purpose a part of this corpus fund also can be utilised with specific orders of Government.
- (iv) The College should start with 1st year (Group) B.A. and B.Com., one of the three optional subjects should be restructured course as approved by the University;
- (v) Telugu should be the medium of instruction. English medium also can be had provided there is minimum strength of students prescribed by the Government.

2. The amount of Rs. 2.00 lakhs referred to in para 1 (i) above shall be credited into the Government Account under the head of account "077. Education - I. University and other Higher Education - H.H. 15. Other receipts - S.H. (01) Contributions and income from Endowments."

3. The expenditure shall be debited to "277. Education - E. University and other Higher Education - M.H.10. Government Colleges - Schemes included in the Plan - S.H. (01) Government Degree Colleges for Men - 010. Salaries etc" and shall be met initially from the existing provision in the Current year's Budget and additional funds will be provided during the course of the year by enhancing the Plan ceiling for 1981-82 and subsequent years. The Director of Higher Education is requested to send proposals for sanction of staff soon after the deposit of corpus fund into Government Account by the College Committee.
