ARTICLE I: SCOPE OF THE MOU: - This MOU details the modalities and general conditions regarding collaboration between TELANGANA SKILL AND KNOWLEDGE CENTRE (TSKC), GOVERNMENT CITY COLLEGE and ANUDIP FOUNDATION

ANUDIP FOUNDATION would be obliged for the following:

- a) Providing training of soft and technical skills to students
- b) Collaborate and work together for placements



GOVERNMENT CITY COLLEGE would be obliged for the following:

- a) Conducting Placements with Anudip Foundation.
- b) Sharing of pre and post placement data with Anudip Foundation
- c) Collaborate and work together for trainings with Anudip Foundation.

## ARTICLE II: TERMS OF AGREEMENT

- a) Organization of joint conferences and seminars
- b) Joint guidance of career guidance, training and placements of student
- c) ANUDIP Foundation may seek assistance/guidance of faculty member/s in trainings.
- d) Would allow the visits of students to College to provide them with an exposure to various equipment, instrument, etc.
- e) The duration of the MOU shall be for a period of 3 years from the effective date.
- f) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students under the MOU.
- h) Any clause or article of the MOU may be modified or amended by mutual agreement

\*In any of the activities mentioned above, no financial aspects are involved, no amount, no payment conditions, etc. . . . Expect for any stationary things at time of Campus Drive College shall take care. This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the courts at HYDERABAD
