- 3. Both parties will jointly organize service activities, skill development programmes/ programmes on issues of the society/ workshops on mutual agreed topics from time to time.
- 4. The faculty of Department of Economics, Govt. City College (Autonomous) (G.C.C), High Court, Ghansi Bazaar, Hyderabad will offer consultancy services to the Manatharam Human Welfare Council, as and when required.
- 5. Both the parties may also exchange services, time to time, if need be, that are not mentioned in this document.
- 6. This Memorandum of Understanding does not cover any financial transactions.

The Memorandum of Understanding (MOU) will come into effect on the date of signature and will remain in force for five years unless either of the parties delivers written notice to the other of its intention to terminate the MOU, in which case, it will terminate three months after the receipt of such notice.
