MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING IS ENTERED BETWEEN ON THIS 19th DAY OF MARCH 2021, BY AND BETWEEN

Women Empowerment Cell, Government City College (GCC), having its campus at Ghansi Bazaar, Hyderabad, Telangana 500002, India, (here in after referred as Women empowerment Cell (WEC) which expression shall unless repugnant to the context or meaning thereof be deemed to include its successors and assigns of the FIRST PART

MY CHOICES FOUNDATION having a principal place of business at H. No. 6-2-39, Flat No. 301, A-Block, 3rd Floor, AC Guards, Lakdi-ka-pool, Hyderabad (here in after referred to as "MCF") which expression shall unless repugnant to the context or meaning thereof be deemed to include its successors and assigns of the SECOND PART

Women Empowerment Cell, Government City College (GCC), Ghansi Bazaar, Hyderabad, and MY CHOICES FOUNDATION have endeavored to join together to organize training programmes, awareness programmes, guest lectures and community service programmes.

ROLE OF MY CHOICES FOUNDATION

MCF shall conduct programmes related to

- Gender sensitization
- Violence against women
- Domestic violence and laws to prevent violence (498A of IPC and protection of women from Domestic violence Act, 2005)
- Prevention of Child Sexual Abuse
- Sexual Harassment and prevention of cyber crimes
- Human Trafficking
- Healthy relationships and boundaries
- Also conduct training programmes and community service programmes related to the areas mentioned above

Role Of WEC, Government City College,

- Shall provide infrastructure facilities for conducting the Programmes
- Designate a person to coordinate all programmes.
- Provide students & Volunteers for the programmes as per the nature and scope of the programme/session.
- No financial commitment is given by Women Empowerment Cell of Government City College in organizing any Program

VALIDITY OF MOU

In view of synergy in the objectives of the two organizations, it is desirable that Women Empowerment Cell, Government City College (GCC) and My Choices Foundation enter into a Memorandum of Understanding (MOU) for making available the expertise and facilities existing in both the organizations for promoting training, awareness and community service programmes in the fields of common interest within the framework of charter of both the institutions for an initial period of 3 years beginning from the 1st of May 2021.

1. DISCLAIMER:


The parties do not intend this MoU to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party hereto shall act as an independent entity and neither shall act as an agent of either organization for other purposes.

2. **NON-EXCLUSIVITY:** The agreements reflected by the provisions of this MoU are non-exclusive in nature and both the parties can enter into cooperative arrangements with other parties to suit their organization needs.
3. **CONFIDENTIALITY:** The parties understand that in the course of their association, they shall have access to confidential information provided by the other party. Accordingly, the parties agree that such information shall be maintained in the strictest confidence and trust, except such information which is by nature, non-confidential or which is the public domain or which the party comes to know about other than through violation of any law or legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to a competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MOU.
4. All disputes, differences and questions of any nature which at any time arise between the parties to this agreement or their respective representatives and assigns or any of them out of the construction of or concerning anything contained in or arising out of this agreement or as to the rights, duties or liabilities under it of the parties to it respectively or their respective representatives shall referred to arbitration under the arbitration and conciliation Act, 1996 or any statutory amendments or re enhancement thereto. The Arbitration proceedings shall be held at Hyderabad, India.
5. Any party may by notice in writing to the other parties change the address and / or addresses to which such notices are to be delivered or made.
6. No amendment or modification of this agreement shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of this agreement. The modifications / changes shall be effective from the date on which they are made or executed unless otherwise agreed to.
7. Court of jurisdiction for any dispute will be Hyderabad, India.
8. No financial commitment is given by Government City College ,WEC in Organizing the program by MCF.

ARTICLE 1:

The output of these collaborative efforts may be used by either or both parties, with the recognition and acceptance of each party's contribution.

The Principal, of THE COLLEGE- WEC and the Programme Co-ordinator, MCF will be jointly responsible for working out operational details of the agreement between the two organizations and ensure proper and effective implementation of the MoU.



Both THE COLLEGE WEC and MCF may add, modify, amend or delete any part of this agreement by mutual consent and understanding of the signing authorities.

ARTICLE 2:



