The Govt. City College, Hyderabad agrees to:

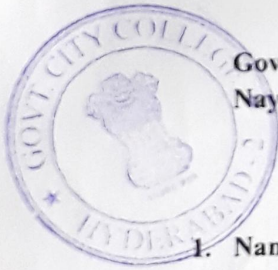
