FOR CREDENTIAL MANAGEMENT SYSTEM

This agreement made this day of 21<sup>st</sup> of April 2023 between the Commissioner of collegiate education, Telangana State, Hyderabad (which expression shall unless repugnant to the context of meaning thereof be deemed to include successors and permitted assigns the PARTY will be called as "CCE-TS"

AND

Whereas M/s. Vivenns Global Private Limited a company incorporated under the Companies Act 1956 and having its corporate office at Kukatpally., Telangana State represented by its General Manager – Operations, S. Narendra Kumar, form the Second Party, hereafter called "VGPL".

NOW THEREFORE THIS INSTRUMENT WITNESS AS FOLLOWS

WHEREAS CCE-TS desires to assign " **Credential Management for Colleges** " to a service provider as per details given in the Tender No. CCE-AC/SPL/3/2023-ACADEMIC CELL Dt.19.01.2023. Terms and conditions mentioned in the Tender document is applicable and binding to both the parties have consented to abide by the same .

2. Whereas after careful evaluation of proposals submitted by the participants, the committee constituted by CCE-TS has decided to entrust the work of " Credential Management for Colleges " to VGPL.

3. THEREFORE this agreement is executed on the following terms and conditions agreed between CCE-TS and VGPL.

4. Credential Management System assigned to VGPL shall be as per the scope of the work mentioned in the tender document.

5. Responsibilities of VGPL and CCE-TS/ Colleges shall be as per the tender Document

6. Performance Bank Guarantee

VGPL shall submit Performance Bank Guarantee in favour of The Commissioner, CCE-TS, Hyderabad for 10% of the yearly order value within 21 days of the placement of the order. This Bank Guarantee shall be valid up to 60 days after the completion of the contract from a scheduled / nationalized bank in India.

8. Payment terms & conditions: Vivenns Global Private Limited shall raise the bills on respective colleges after completion of the Work mentioned in the scope of work for each semester. The colleges shall scrutinize the bills and make the payment directly to VGPL.

9. Changes / Amendments : CCE-TS shall have the right at any time, by written notice, in the form of an amendment order, to make changes it deems necessary, including, but not limited to changes in specification design, delivery, testing methods, packing or destination. If any such required changes cause an increase or decrease in the cost of the time required for performance, an equitable adjustment shall be made in the contract price or delivery schedule, or both. Any claim by the vendor for adjustment under this clause shall be deemed waived unless asserted in writing within ten (10) from receipt by the vendor of notice of change (amendment order). Price increase, extension, extension of time for delivery and change in the quantity shall not be binding on CCE-TS unless sufficiently justified by the vendor and accepted by CCE-TS in a form of amendment/ change order issued and signed by CCE-TS. The agreed changes/ amendments shall be carried out in such manner so as not to affect the on-going process.

10. Contract Period: The duration of the contract shall be for a period of three years, based on the satisfactory performance renewable every year after 1st year.

### Termination of agreement

This agreement may be terminated by either party giving thirty days prior notice to the other party substantiating the reasons therefor in writing and by mutual consent thereto.

CCE-TS may terminate this agreement in whole or in part, for no cause, upon written, e-mail notice to VGPL, effective when sent, provided such notice is sent at least thirty days prior to the delivery date specified.



CCE-TS Shall have no liability to VGPL beyond payment of any balance owing for material purchased hereunder and delivered to and accepted by the CCE-TS prior to receipt the notice of termination by VGPL, and for work in progress requested for delivery to CCE-TS.

12. (A) All the disputes and differences arising between the parties hereto, including any dispute or difference in regard to the interpretation of any provision or term or the meaning thereof, or in regard to any claim of one party against the other or in regard to the rights and for obligations of any party or parties hereto under this Agreement otherwise, howsoever, shall be referred to a sole Arbitrator Commissioner of Collegiate Education, TS, Hyderabad and such Arbitrations shall be governed by the provision so the Arbitration Act for the time being in force.

(B) The Arbitration will be bound to take oral, evidence and may decide the disputes on the basis of the documents produced by the parties and after hearing oral argument by or on behalf of the parties.

(C) Any judicial matter raised in this work shall be solved in the jurisdiction of Hyderabad Court.

This agreement commences on the day of 21<sup>st</sup> April, 2023. After successful completion of the agreement period, it may be extended further on mutually acceptable terms.


