Analysis of Teachers feedback on curriculum




Feedback Analysis on FA1 & Taxation:

An analysis of the feedback received from the respondents out of 15 samples, 90% of the respondents were of the opinion that course objectives were clear and specific. 80% of the respondents agreed that course was well structured to achieve learning outcomes. 20% of the respondents expressed that latest developments in the courses should be implemented. Majority of the respondents agreed that there were flexibility in core subjects and syllabus based e-resources was available.

Suggestions:

The stakeholders from Commerce department suggested that there is a need for system based technological updates in all courses more application level topics to be included.
