ORDER:

The Government in the Order first read above, directed that the Surya Laxmi Degree College (Aided), Narayanpet, Mahabubnagar dist., be taken over and transferred to the Government under sub-section (1) of Section 60 of the A.P. Education Act, 1982 from the financial year i.e., 1-4-2004, subject to the following conditions:-

1. All assets of movable and immovable should be handed over to the Government without payment of any compensation.
  2. Surplus Staff (teaching and non teaching), shall be transferred to needy Government Degree Colleges, in the same zone.
  3. All the teaching and non-teaching staff working in Surya Lakshmi Degree College have to take last ranks after take-over and there will be no right to them to claim seniority in future.
  4. There shall be no additional financial commitment to Government either now or in future.
  5. No member of teaching and non-teaching staff in unaided posts shall be taken over.
  6. The Liabilities, if any, also be settled by the society, before the take-over of the college.
2. The Commissioner of Collegiate Education, Andhra Pradesh, Hyderabad was requested to take necessary action accordingly and to issue a certificate confirming the aided posts and the names of the present incumbent including his/her date of birth, present pay and up dating their service record before takeover the Degree College.

3. The Physical handing-over of the college was however not complied with by the management on the ground that the unaided service sections started during the year 1987-88 were not covered by the above orders.

4. The management of Surya Laxmi Educational Society, in their meeting held on 31-08-2008 has passed the following resolutions:-

- (i) To request the Government to review the orders issued in G.O.Ms.No.3 Edn., dt: 12-01-2004 and take over the college in full shape by including aided and unaided sections/staff.
- (ii) To hand over the college management to Government with full assets without any liabilities including aided and unaided teaching and non-teaching staff
- (iii) To name the college as "Sri Chittam Narsi Reddy Memorial Government Degree College, Narayanpet".

5. After careful examination of the matter, the Government have decided to take-over only the aided sections and aided staff and to re-name the college as Sri Chittam Narsi Reddy Memorial Government Degree College, Narayanpet, Mahabubnagar district. Accordingly, Government hereby direct that the orders issued in the G.O. first read above shall be implemented in toto. Government also re-names the Surya Laxmi Degree College as "Sri Chittam Narsi Reddy Memorial Government Degree College, Narayanpet, Mahabubnagar District" With immediate effect.

6. The Commissioner of Collegiate Education, Andhra Pradesh, Hyderabad shall take necessary action accordingly.

7. This orders issues with the concurrence of Finance (Expr.HE) Department vide their U.O.No.4768/95/Expr.HE/09, dt: 12-02-2009.
