G.O.Ms.No.306, Education, dt.19.7.1983.

O R D E R :

The Director of higher Education has submitted a list of applications received for opening new Degree Colleges during 1984-85 indicating the conditions already fulfilled by the Sponsors/Promised to be fulfilled the conditions stipulated for opening new degree college in G.O.Ms.No.306, Education dt.19.7.83 together with her recommendations based on the reports of the Inspection Reports of the concerned University/ the concerned Regional Joint Director of Higher Education.

2. Government after careful consideration of these applications and the particulars furnished therein, sanction the opening of the Private Degree Colleges as mentioned in the Annexure to this order subject to fulfilment of the following conditions within a period of one year from the date of this order, if not already complied with:-

- (1) The College committee should obtain the feasibility report from the concerned University and submit the same to Government through the Director of Higher Education, if not already done.
- (2) The college committee should deposit in a Scheduled Bank an amount of Rs.4.75 lakhs/2.50 lakhs as the case may be as required under the G.O. read above towards salaries, equipment, etc., in the joint account of the management and the Government, if not already deposited.
- (3) The college committee should provide 15 acres of land and building with plinth area of 8,000 Sq.Ft. and register them in favour of the degree college.
- (4) The college committee should provide adequate temporary accommodation exclusively for degree Classes, from their own funds.
- (5) The College committee should construct permanent building for the college from their own funds within a period of 5 years at the latest. They should form a committee consisting of parents and others to raise adequate public contributions for construction of buildings as per the approved plans.
- (6) The college committee should provide furniture, equipment and library books etc., immediately as prescribed by the University concerned.

- (7) If the existing private junior college is to be upgraded into private degree college, the junior and degree college sections shall exist separately either within the same premises or separately, in which case the college committee will have to provide necessary accommodation exclusively for the degree college and also facilities like library, equipment, furniture etc.,
- (8) The post of Principal of the junior college shall continue since the private junior college and the private degree college will function independently.
- (9) The College shall start with one section each in Lycar B.A. and B.Com, courses and one of the three optionals subjects shall be a restructured course, as approved by the University.
- (10) The medium of instruction should be Telugu. English medium can also be opened, provided there is a minimum strength of 30 students in the course concerned and with the prior permission of the Director of Higher Education.
- (11) The college committee should get affiliation for the college from the concerned University expeditiously, duly depositing the required corpus fund, and recruit staff as per the guidelines prescribed in G.O.Ms.No. 306, Education dated 19-7-1983 and as per the staff pattern prescribed by the Director of Higher Education.
- (12) The appointment of teaching staff should be done by the proposed college service commission. Pending finalisation of the setting up of the college service commission, if the management should appoint teaching staff from out of the panel of names forwarded by the Government.
- (13) The Principal of the college should follow the rules of reservation to S.Cs., S.Ts., and Backward Classes, while making admission of students. The principal will be personally held responsible for violation of rules and the management shall not interfere in this regard.
- (14) If the management desires to have classes in media other than Telugu and English, prior permission of the Government should be obtained.
- (15) The management may collect tuition fees, special fees and miscellaneous fees at the rates not exceeding the limits prescribed by the Government or the Director of Higher Education from time to time. Any amount of fees collected beyond the limits prescribed will be treated as income to Government.
- (16) The management should run the college without any financial aid or assistance from Government either now or at any time in future.
- (17) The college committee should include the following members to ensure proper functioning of the college, collection of fees and to safeguard the interests of the Government.

1. Local M.L.A.
2. Collector/Joint Collector.
3. Regional Joint Director of Higher Education/
District Educational Officer.

- (18) The degree college shall be a separate Unit.
- (19) If the management violates any of the conditions laid down by the Government at the time of permitting the college or any other rules issued by Government from time to time, it will be suspended and the correspondent discredited.
3. The management shall hand over the college along with their assets, but not liabilities when the Government require them to do so, at a future date.
4. The Director of Higher Education shall ensure that the college committees fulfil all the conditions mentioned in para 2 above and also the conditions laid down in G.O.Ms.No.306 Education dated 19.7.1983, within one year from the date of this order.
5. The Director of Higher Education shall appoint an expert committee regionwise immediately to go round all the colleges sanctioned in this order to verify to what extent the respective sponsors have fulfilled the conditions laid down in G.O.Ms.No. 306 Education dt.19.7.83 and the time schedule within which they can fulfil these conditions and submit reports within 2 months.
- If on the basis of the expert committee's report, wherever a college is found not viable in terms of student strength and infrastructural facilities available, action will be taken to close down such an Institution and accommodate the students of that college in the neighbouring institutions.
