**CONDITIONS:**

1. Class rooms must run in proper rooms
2. Teaching staff of the college are to be appointed by the duly constituted Selection Committee as per PU norms
3. Library should be strengthened by adding books worth of Rs.10,000/- each year producing separating reading room
4. Fire safety and sanitary certificate (s) must be renewed
5. Conditions of laboratories are to be improved
6. Governing Body meetings are to be conducted once in three months
7. Biometric system for student and teachers attendance and CC cameras are to be arranged
8. Statistical data should be uploaded for all academic years till 2015-16 and produce a certificate duly signed by Nodal officer at P.U

Therefore, college is directed to submit the Compliance Report on the fulfillment of the above deficiencies in the following format along with the documentary evidence to reach this office by 25-2-2017 through the university representative on the Governing Body of the College / by Special messenger.

**GENERAL GUIDELINES:**

1. Non compliance of the conditions lay down by the Inspection Committee within the Stipulated time shall lead to withdrawal of affiliation.
2. The college should appoint teaching staff through duly constituted Selection Committee as per PU norms and also obtain University approval for the same.
3. The Management is warned not to admit the students over and above the ceiling strength.
4. As per the decision of the Executive Council if the college makes admissions over and above the permitted strength in any Course, that course of the college will be automatically disqualified.
5. For change of Premises/Management/Society/Name of the College, the Management should approach the University before 31<sup>st</sup> December of each year following the guidelines issued by the erstwhile TSCHE and present TSCHE. Any violation in this regard will lead to penal action including disaffiliation.
6. The college is required to maintain institutional records as given in proceedings No.423/AAC/96, dated 4-5-1996 and to keep them ready for inspection.
7. The college should remit the prescribed fee towards AAF/SRF/SRCF/SWF/IUTF Academic records fee etc. as prescribed by the University from time to time
