



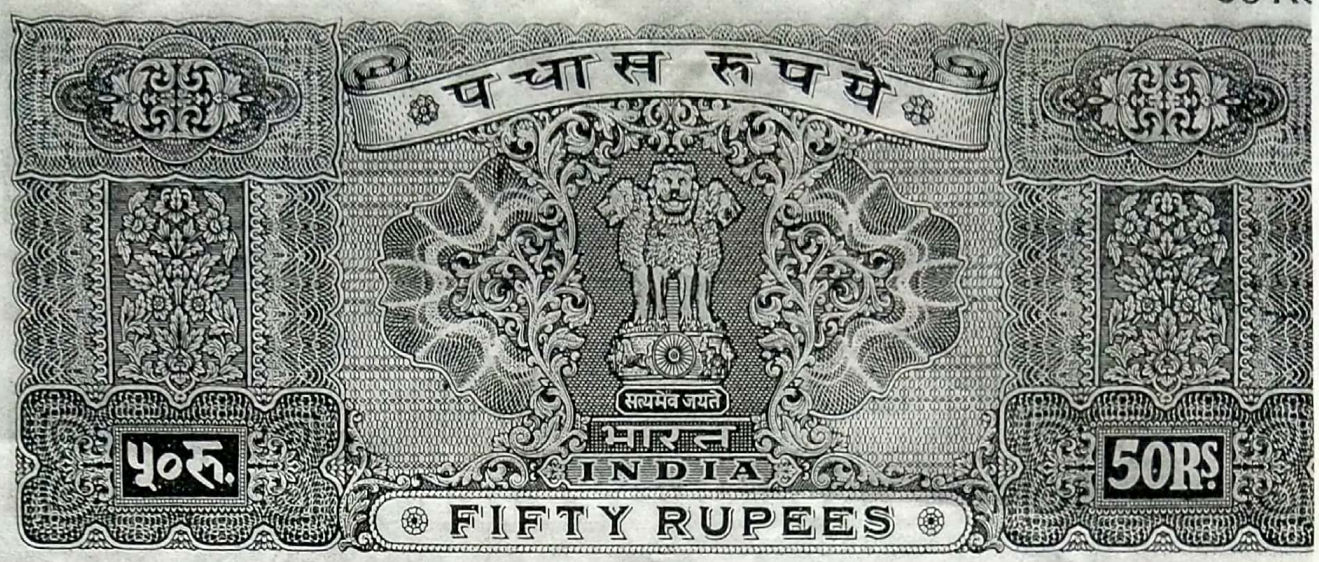

NOW, THEREFORE THIS AGREEMENT WITNESSES AS FOLLOWS

1. That the party to the second part agrees to perform the teaching work in accordance with the curriculum of the University for the course from 27-9-2004 to 26-3-2005. (6 months only).
2. That the party to the second part shall carry out further instructions given to him by the college planning and Development Council from time to time in the discharge of his/her duties as a teacher, mentioned in part 1 above.
3. 




