

The amount of the grant shall be drawn by the Accounts Office, SERO, UGC, Hyderabad on the Grants-in-aid bill and shall be disbursed to and credited to The Principal, Government Degree College for Women, Begumpet, Hyderabad - 500 016 (Andhra Pradesh) through a Demand Draft on the following conditions to be accepted by the College.

The sanctioned grant is subject to the condition that the college has/would utilized/utilize the grants as per the guidelines of Autonomous Colleges

If the College fails to utilize the grants sanctioned by the Commission for the purpose for which these were approved and in accordance with the terms and conditions of the approval or does not furnish the required documents or is disaffiliated from the University, the entire amount paid by the Commission shall be refunded by the College or its governing Body/Committee of Management when a demand is made by the Commission to this effect along with interest of 10% p.a.

The grant should not be used for Self-Financing / Unaided courses.

It may be noted that the accounts of the grant-in-aid institution shall be subject to inspection by Officers of the South Eastern Regional Office, University Grants Commission, Hyderabad.

The institution shall fully implement the Official Language Policy of the Union Govt. and that it shall fully comply with the Official Languages Act, 1963 and Official Language (use for the official purpose of the Union) Rules 1976, etc.

The institution should maintain an inventory of permanent or semi-permanent assets created/acquired on mainly out of the grants given by the UGC. The inventory should be kept up-to-date and a certificate to this effect should be furnished along with the Utilization Certificate.


The College shall maintain a Register of Assets acquired wholly or substantially out of the Grant in the prescribed form.

The sanction issues in exercise of the delegation of powers vide Commission Office order No 25/92 dated 1-5-92.

The above sanction is debit able to Head of Account - 3 (i) b Capital Assets - 35 and valid for payment by Accounts Section during the year 2012-2013.

The institution shall implement Anti Ragging norms applicable.
