## Research Policy Document

The following salient features form part of the Research Policy Document of Tara Government College Sangareddy (A). The document has been prepared by Research promotion committee in collaboration with ethics committee.

### 1. Policy statement

Tara Government College Sangareddy (Autonomous) will pursue research in a responsible, transparent and ethical manner and involve all stakeholders for the benefit of the world.

### 2. Composition

The college assigns the goal of research achievements to a dedicated research committee . The research committee, shall, in turn , work towards furthering Research in collaboration with other committees / agencies

### 3. Salient features of the policy

- 3.1. Sensitisation programmes will be conducted periodically. Required infrastructure will be provided to researchers. All the initiatives will be undertaken to promote research culture
- 3.2. All the researchers will be informed of their roles and responsibilities
- 3.3. Transparency and confidentiality will be balanced depending on the need and requirement
- 3.4. All research ethics will be followed scrupulously .
- 3.5. Staff are allowed to engage in consulting services and activities as long as

their consultation services and activities do not work in conflict with the interests of the institution.

- 3.6. All stakeholders will be sensitised to follow approved research protocols in all disciplines.
- 3.7. Researchers will be encouraged to approach funding agencies / sponsors.
- 3.8. Research committee shall consist of faculty from various disciplines ,viz Languages Humanities , Commerce , Life Sciences and Physical Sciences
- 3.9. Among the members ,one teacher will be appointed as a convener
- 3.10. The committee helps in forwarding the proposals for

  - D. Symposia
  - E. Orientation
  - F. FDP
  - G. FIP
  - H. Projects
  - I. Any other relevant documents
- 3.11. All grievances related to the research polices of college will be addressed by following procedures in vogue .
- 3.12. Faculty will be encouraged to apply patents , copy rights etc .
- 3.13. Expenditure for the above shall be met from seed money fund or any other fund /fee of the college.
- 3.14. Students will be given funds to pursue study projects as per procedure.
- 3.15. Laws governing clinical research such as central council for Indian medicine act -1970 will be strictly adhered to.
- 3.16. All the stake holders will be informed to follow research conduct and consequences of research misconduct

- 3.17. All the departments, staff , students and other entities will be informed to reach MoUs and research collaborations.
- 3.18. The faculty will be encouraged to pursue M.Phil , PhD, Post Doctoral degree and any other research endeavours .
