ORDER:



The Hon'ble High Court while disposing of the C.C. No.714 of 2019 in W.P. No.46869 of
2018 on 27.12.2019, has directed as follows,

"... to cancel the selection of 98 appointments under the Sports quota as Junior
Panchayat Secretaries already made by the respondents in violation of the
undertaking given to this Court on 26.12.2018 in W.P.No.46869 of 2018 and batch.
The respondents are also directed to notify afresh the said posts filled up under
sports quota earlier including the balance of posts which were unfilled as per
Notification dt.31.08.2018, invite applications from the eligible persons, apply the
minimum pass mark of 35% i.e. 70 out of 200 marks in the written test, and proceed
to make appointments strictly on the basis of the merit of the candidates in the sport
concerned as per the Annexure to G.O.Ms.No.74, Dt.09.08.2012 and not on the basis
of the marks obtained by the candidates in the qualifying examination".

The Government vide G.O.4th cited have Issued orders to cancel the selection of (98)
appointees under the sports category of Junior Panchayat Secretaries notified vide notification 1st
read cited, by following due procedure.

It is noticed that, Sri/Smt. Payam Anusha, Gram Panchayat Patha Alligudem, Mandal
Aswaraopeta, District Bhadradi Kothagudem has been appointed as Junior Panchayat Secretary
under Sports quota vide Proceedings. 2nd cited.

Therefore, you are hereby directed to show cause as to why your appointment should not
be cancelled in accordance with the above orders of the Hon'ble High Court.

Your explanation should reach the District Panchayat Officer, Bhadradi Kothagudem by
5.00 PM on 25.03.2021. If no explanation is received, further action will be taken up as per
available record.

ORDER:

The Government have accorded permission for the recruitment of Junior Panchayat Secretary vide reference 2nd cited above. A written examination was conducted to select the candidates as per the guidelines issued by the Government. In the references 9th read above, the Commissioner, PR&RE, Hyderabad has communicated the list of provisionally selected candidates under 5% open category for recruitment to the post of Panchayat Secretaries under Notification No.2560/CPR&RE/B2/2017 and requested the District Collectors to select remaining 95% Local quota candidates as per Government Memo No.7631/Pts.VI/A2/2018, dt.12.11.2018.

Accordingly, Sri/Smt./Kum. **SHEIK MADAR BASHA S/o/D/o. SHEIK AMMAN SAHEB** is provisionally selected to the post of Junior Panchayat Secretary with the consolidated remuneration of Rs.15,000/-only per month subject to following conditions.

Basic Service Conditions:

1. This is a district cadre post as defined in G.O.Ms.No.124 GAD (SPF-MC) Department. Dated:30-08-2018.
2. The Junior Panchayat Secretary shall have to work on consolidated remuneration basis for 3 Years
3. The Junior Panchayat Secretary shall execute an agreement bond on Rs.100/- stamp paper.
4. The agreement is renewable every year based on annual evaluation of performance.
5. The services of those Junior Panchayat Secretaries who show satisfactory performance will be regularized after completion of 3 years as Panchayat Secretary
