ABOUT THE COLLEGE

PART I: BACKGROUND OF THE INSTITUTION

Sri Rama and Bhaktha Gentela Narayana Rao Govt. Arts & Science College, Khammam was established in the year 1956 under private management. The then Chief Minister Sri Boorgula Rama Krishna Rao and Sri G.V. Butt, the then District Collector of Khammam took the initiative for its establishment along with a committee formed with the elite of the town. The primary objective was to provide higher education to the students of the marginalized sections and Tribal community of Khammam District. The College was named after the Chief Donor, Sri Gentela Narayana Rao. The College was taken over by the state government on 1-09-1959 and it acquired permanent affiliation to the Osmania University in 1972. Eventually the affiliation is transferred to the Kakatiya University, Warangal.

Under the able and missionary administration of Principals like K.Y.L Narasimha Rao, D. Natesan, Bankat Lal Agarwal, Dr.K.S.R. Sharma and M. Ramachander Rao the College has grown into an Identified Lead College in the district with a potential to produce a student force equipped with academic excellence and global skills.

The motto of the College is '**Enter to Learn, Leave to Serve**' with a mission to produce autonomous learners who turn out to be independent, self-contained, confident human resource to the nation. In the long history of its onward march towards imparting quality instruction, supported by technology, the College introduced Restructured and Self Finance Courses in addition to the Conventional Courses it has been offering since its inception. With the onset of technology-driven society, the College realized the need to address global demands and began to impart instruction and training in communication, soft and employable skills through a mechanism of its own.

The College acquired state-of-the-art technology, automation, net connectivity, added infrastructure and so on in its long journey towards fulfilling its vision and mission. Many support service are instrumental in imparting value-based, quality instruction to the young of the most needy and marginalized sections of society who also happen to be first generation literates.

The college has an efficient internal co-ordination mechanism helping the smooth conduct of academic and administrative matters.

The college Library has more than 50,000 books. Telangana Skill & Knowledge Centre (TSKC), a unique program of the Government of Telangana which enhances the employability, is functioning well in the college. Hon'ble Commissioner of Collegiate Education has reached an MoU with Telangana Academy for Skills and Knowledge (TASK). Aspart of this, the college has been offering Skills for employability to students.

The Commissionerate of Collegiate Education (CCE) recognizing its academic

and administrative excellence, identified this college as a “Identified College” (**ID College**) & District Resource Centre (**DRC**) from where it discharges several academic and administrative functions in monitoring all the Government Degree Colleges in the district.

NAAC Accreditation:

In recognition of its academic quality and excellence, the National Assessment and Accreditation Council (**NAAC**) has accredited the College with **B⁺⁺ grade** in May, 2017.

CURRICULAR ASPECTS:

The college has been serving the society for the past 6 decades. It is the first Autonomous College under the jurisdiction of Kakatiya University. All the departments have BOS and entire administrative structure was remodeled to suit the needs of autonomy. The college opted for CBCS which gives a lot of scope for improvement. We have enrolled with SWAYAM & IIT Bombay MOCCS to improve the computer literacy among the students & the staff. The students of college who excel in their academics are given incentives. The students who get admission in to PG courses of Central universities are given Rs.50,000/-a year & a laptop as an incentive by the Commissionerate of Collegiate Education, Telangana.

TEACHING-LEARNING AND EVALUATION:

Admission process is conducted through DOST. The college follows transparency in admission process. The admissions into colleges have been made on-line since 2016. The college ensures that all the students from disadvantaged sections of society receive scholarships and more than 90% of the students are drawing scholarships. Experiential learning is encouraged and students participate in the study projects. Our student study projects won state level awards under the JIGNASA Student Study Projects. The college has adopted external paper setting and evaluation. This ensures absolute transparency and objectivity. The library has copious volumes of books. The students can use and benefit by using INFLIBNET N- LIST. Student centered methodology is followed. Several teachers have enrolled themselves into Ph.D programmes. Staff of the college have presented TSAT TV live sessions.

RESEARCH, INNOVATIONS AND EXTENSION :

The teaching staff have 26 Ph.Ds. and 38 qualified UGC/SLET/NET. The online resource such as INFLIBNET, N- LIST and plethora of e- books are available.

The Departments of Telugu, English, Chemistry and Economics organized two National Seminars sponsored by RUSA and other agencies. Apart from this, various departments of the college organized many National Level, state Level, District Level and college level research related activities (including webinars). Various departments reached MOU's with reputed and service-oriented organizations.

INFRASTRUCTURE & LEARNING RESOURCES:

The college has potential to grow and serve the society. It has adequate number of classrooms and laboratories. The Hon'ble Commissioner has permitted for the construction of administrative block and the construction is in progress.

Virtual class room was sanctioned by the CCE, T.S. The college also has LCD projectors and interactive white boards. College has INFLIBNET N-LIST Subscription Access to E-Resources, E-Books and e resources. Students can access INFLIBNET.

STUDENT SUPPORT & PROGRESSION

Mentor mentee system is practiced in the college. More than Ninety percentage of students have been receiving welfare scholarships and bus passes. One of our students participated in the National Integration Camp. Our students also participated in NCC, RD Parade , Thal Sainik Camp, Trekking camps, The Grievance Redress cell looks after genuine complaints and suggestion of the students. Not a single incident of ragging was reported. The college has an active Women Empowerment Cell. To check the menace of sexual harassment, the Internal Complaints Cell was established.

GOVERNANCE, LEADERSHIP AND MANAGEMENT:

The college has a well-articulated vision and mission. With the college embarking on autonomous status new administration has come into focus. Boards of Studies were formed. They adopted new syllabi in their respective subjects. The Academic council and Governing Body were formed. The syllabi (including certificate) and courses examination pattern of the BOS were ratified. The Governing Body formulates policies. All the syllabi have been transacted and evaluated as per CBCS in Autonomous mode. The devolution of responsibilities has been executed and administered by the way of committees/cells. Each committee/ club /cell has its own pre-determined roles and responsibilities.

The IQAC looks after the quality initiatives. It drives the institution towards quality goals. It helps the college in attaining and sustaining quality.

ENVIRONMENTAL INITIATIVES AND BEST PRACTICES:

The campus is lush green with salubrious environment. The campus has become eco-friendly. The college has three NSS units. Efforts are on to minimize the use of plastic material and petroleum by-products. Saplings were planted by NSS volunteers. Harithaharam and Swachh Bharath have been observed and students actively take part in them.

As the college is located in Khammam City, the district head quarters and having a history of more than 60-years of successful years and from the past 5-years being autonomous college, there is huge demand for the admission in the college.

The college is offering more than 28-UG courses which requires 80-class rooms and

8-PG courses requires 16-class rooms, 46-Laboratories but has only 43-class rooms. Due to this shortage of class rooms, college is running under shift system with Arts and Commerce (BA & B.Com) in the morning shift (8:00AM-2:30PM), B.Sc-Physical and Life Sciences in the evening shift (10:30-5:00 PM). **High priority is now for additional class rooms and Laboratories as much as possible.**

The present requirement is mentioned based on need to change shift system into regular timings (09:30AM-4:30PM).

Proposed Five-Year Implementation Plan

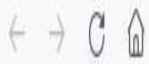

It is to be noted that, though the management of the college should normally obtain affiliation from the university during the respective academic year, as per the rules in force after withdrawing the new un-aided UG courses, but, because of the situation prevailing due to COVID-19, the temporary extension of affiliation is being granted by the University without undertaking any physical inspections of the college, as a special measure only, due to the existing compelling circumstances caused by the prevailing COVID-19 pandemic. Further, the Kakatiya University grants temporary affiliation as the Telangana State Council of Higher Education, Hyderabad has also already given permission to the respective colleges for new un-aided UG courses / additional sections / combinations, since it is not possible at this juncture to undertake physical inspections of the colleges due to the prevalence of the COVID-19 pandemic.

The above temporary extension of affiliation shall be subject to the following terms and conditions:

1. The college management should provide adequate and sufficient accommodation as per the university directives for the management and running of the existing and as well as the new courses.
2. The College Management should renew affiliation from the university during each academic year until permanent affiliation is granted by the University as per the rules existing in force and as amended from time to time.
3. The College Management should submit the FIRE SAFETY CERTIFICATE to the University within thirty (30) days from the date of permission of temporary affiliation for the maintenance of the college without fail.
4. The College Management should abide by the regulations issued by the State Government of Telangana from time to time in respect of rules of reservations during the process of the admission of students and the appointment of teaching staff.
5. The college management should make appointment of eligible teaching staff as per the rules and regulations issued by the University / Government of Telangana from time to time.
6. The infrastructure of the buildings such as accommodation, land, playgrounds, lab-equipment, library, furniture etc. should be improved as per the requirements for efficient maintenance of the college.
7. The College Management should not make any claim for grant-in-aid now or in future under any circumstances.
