In the Government Orders issued vide reference 1<sup>st</sup> to 3<sup>rd</sup> read above, the powers were delegated to the Head of the Department, i.e., the Commissioner of Collegiate Education, Telangana State, Hyderabad, for allocation of Non- Teaching Posts as per student strength of all the Government Degree Colleges in the State.

In this regard, vide Government Orders in the reference 7<sup>th</sup> to 10<sup>th</sup> read above, after allotment of personnel to various zones by the state level committee and issue of orders by the Government Departments/ Head of the Department concerned, allotted personnel have to report to zones concerned.

Accordingly, certain Non teaching Posts have been shifted and allotted w.e.f. **date:31.12.2021** in certain GDCs and hence the revised cadre strength of each category of Non-Teaching Posts in certain Government Degree Colleges annexed to these proceedings is fixed with reference to the Scale Register .

The Principals of concerned Government Degree Colleges as per Annexure are informed that the earlier orders issued with regard to cadre strength of Non-Teaching Posts of their respective Colleges communicated vide CCE's proceedings issued in the references 4<sup>th</sup> to 6<sup>th</sup> read above are superseded by these orders (As per SMPC Annexure).

Therefore, the Principals of concerned Government Degree Colleges as per Annexure are informed to make necessary entries with regard to the revised cadre strength of Non-Teaching Posts w.e.f. **date:31.12.2021** in the respective staff registers and scale registers, and report compliance and further directed to maintain a permanent record for the posts now communicated without fail.
