Part B

CURRICULAR ASPECTS

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

Government Degree College, Narsampet was established on 03-12-1984 to fulfil the higher education needs of the students coming from socially and economically deprived sections of the society in general and the students of rural areas in particular. The college has an inbuilt mechanism for effective delivery of the curriculum prescribed by the affiliating univeristy i.e. Kakatiya University, Warangal. The University prepares the yearly/semester Almanacs at the beginning of the Academic Year which shall be followed by all the affiliated colleges. In accordance with the Univeristy Almanac, the college prepares the time-table, teaching plan, lesson plan at the beginning of each year/semester which are strictly followed for effective implementation of the curriculum and the completion of the syllabus. Time table is prepared collectively by all the teaching staff members to ensure that there are no duplications and clashes in the various subjects. The semester plan consists of commencement date and last working date, dates for conduction of the internal assessments, instruction days, holidays and the commencement of university examinations. All the staff members are encouraged to plan in advance to impart the curriculum through innovative and ICT based teaching methods such as Power point presentations, assignments, extension lectures, workshops, seminars, quiz, field visits, etc. The advanced learners, average learners and the slow learners are identified in the beginning of the semester. The advanced learners are assigned tasks such as Study Projects, Field visits and Student Seminars. The average and the slow learners are motivated towards excellence in their academic performance by taking remedial classes. The progress of syllabus coverage is monitored by the Incharges of the departments concerned as well as the principal of the college through conduct of regular staff meetings. The institution conducts internal academic audit of attendance registers, internal exams, question papers and the evaluation process. Periodical feedback is obtained from the students on aspects of teaching-learning process. The following Registers are maintained by the faculty for effective delivery of the curriculum in a well planned and documented manner: Syllabus copy with text books Departmental Time table Annual Teaching plans Lesson Plans Teaching Diary Attendance registers Assignment registers Remedial Coaching register Students activity register Assignment records Field trip and study project records Question papers of the previous examinations Result analysis every year Feedback Analysis Student Progression reports Periodic reviews of Departmental Meetings and General Staff Meetings are conducted for the establishment of new set standards in the teaching. Timely analysis and review of the internal assessment tests on a regular basis invite the attention of the faculty to identify the shortcomings in the teaching-learning process in curriculum delivery and documentation process. Bridge Courses and complementary classroom instruction are practised to improve the standards among the students in respect of the curriculum. Tutorials are performed through the mode of mentoring which ensures participative learning. Certificate Courses, Add-on Courses, Value Added Courses, Online classes and other skill-based employability courses are added advantages to the regular courses.

The overall objective of the college is the holistic development of the students. In pursuit of achieving this objective and effective implementation of the teaching-learning process, the college has a standard practice of preparing the academic calendars' of its own by keeping in view the Alamanac issued by Kakatiya University, Warangal (the affiliating University of the College) and the annual Academic and activities calendar issued by the office of the Commissioner of the Collegiate Education, Hyderabad, Telangana State in every year. While preparing the academic calendars proper care is taken to include all the important dates as prescribed in the Almanac issued by Kakatiya University such as date of commencement of classes, internal examinations, practical examinations and the last day of instruction. Along with the academic schedule prescribed by the Kakatiya University it is also taken care to include the celebrations of all important dates and days in the year as prescribed by the Academic and Activities calendar issued by the CCE, Hyderabad every year.

It is seen that all the curricular, co-curricular and extracurricular activities are included in the academic calendar for the overall personality development of the student. While implementing the academic plan every year, it is taken care that all the activities as planned in the yearly plan are executed without fail and a proper record of all such activities by the departments concerned is maintained. The academic calendar of the college mainly consists of the following: Almanacs issued by the Kakatiya University Academic and Activities calendar issued by the Commissioner of Collegiate Education, Telangana, Hyderabad.

The academic calendar is prepared by the college in combination of both. Along with the regular classwork utmost care is taken to conduct guest/extension lectures by inviting eminent persons in the related subjects as well as motivational speakers. Student seminars, subject quiz/general quiz, debates, and group discussions are made part of the regular activities for the overall growth and development of the students. Student study projects, report on field trips, assignments, record work and other important academic records are to be submitted by the students as part of the evaluation and to be submitted to the University, wherever required.
