- Physical contact and advances.
- A demand or request for sexual
- Making sexually coloured remarks
- Showing pornography.

- Any other unwelcome physical, verbal or non-verbal conduct of sexual nature

The following circumstances, among other circumstances, if occur or is present in relation to or connected with any out or behaviour of sexual barasment may amount to sexual harasment.

- Implied or explicit promise of preferential treatment in her employment.
- Implied or explicit threat of detrimental treatment in her employment
- Implied or explicit threat about her present or future employment.
- Interference with her work or

creating an Entimidating or offensive or hostile work environment for her, or Humiliating treatment likely to affect her health or sately.
