Legal Awareness Programme as part of Legal Literacy Camp organized by National Service Scheme (NSS) Units- I, II, III & IV and Internal Complaints Committee (ICC) on 30th October 2021 at Seminar Hall, Tara Government College, Sangareddy (A) in collaboration with District Legal Services Authority (DLSA)- Medak district at Sangareddy.

Hon'ble Senior Civil Judge and Secretary, DLSA- Medak district at Sangareddy CH. ASHALATHA garu participated as a Chief Guest and Resource Person and Panel Advocate-DLSA-SRD R. Gowthami garu also participated as a Resource Person and Smt. M. Praveena, Principal of the college, presided over the programme. NSS Programme Officers Dr. G. Jagadishwar, Dr. O. Padmaja, N. Siddulu and Dr. A. Venkatesham, Dr. Vijaya, Convener of ICC, other faculty members AV Sharma, Md. Shareef, NSS Volunteers and Students participated.

Principal has addressed the gathering and briefly explained the Objectives of the Programmes as follows:

- 1. Legal literacy is essential as it is the knowledge of law that can be used as a tool by vulnerable groups to understand and evaluate the law, to get acquainted with the scope of their rights under the law, and get their rights enforced by taking action and bringing the legal machinery into force.
- 2. To know about the Support of national and local justice delivery institutions to improve Access to Justice and developed legal and representational capacities of disadvantaged groups, marginalized, poor and vulnerable sections of the society, particularly women, children, Schedules Castes and Scheduled Tribes etc.

Hon'ble Senior Civil Judge and Secretary, DLSA-Medak district at Sangareddy CH. ASHALATHA garu, as part of Legal Literacy Camp, made awareness among the participants about Free Legal Services rendered by Legal Services Authority nation wide in India and the role of NALSA as following: NALSA along with other Legal Services Institutions undertakes various awareness activities in order to make people aware of their rights and about the role, activities and functioning of the legal services institutions.

A variety of tools are used in order to achieve this objective like conducting seminars, lectures; distribution of pamphlets; participation in Doordarshan programmes, broadcasting jingles, live phone-in programmes etc; floating mobile multi-utility vans for spreading awareness through public interactions; nukkad nataks; short documentaries; cultural programmes by school children on legal issues; various competitions like painting, essay writing, debates and declamation etc. on legal issues and she also made awareness on issues of Ragging, Eve teasing, Harassment, Domestic violence and 498A section and their consequences and Role of Lokadalaths.

Panel Advocate- DLSA- Medak district at Sangareddy Specific issues is taken up for legal literacy programmes varying from place to place depending upon the needs of a locality and its people. Internship programmes are organised for law students to promote the role and importance of legal services activities. Legal Aid Clinics are also being run in law colleges to further the attainment of objectives of Legal Services. Various legal literacy programmes are organized at school and college levels.
