1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Girraj Govt. College is an autonomous Arts, Science and Commerce College well acclaimed for its academic excellence, curriculum development and innovative research. It is the only autonomous and one of the largest institutions affiliated to Telangana University, Nizamabad. It came into existence as a pride of Northern telangana in the year 1956. It is striving for promoting higher education and for the upliftment of socially and economically backward and minority communities of Nizamabad and surrounding districts. The college was started with 6 conventional Under Graduate courses in 1956, and subsequently upgraded continuously with Self Financed Under Graduate and Post Graduate courses on par with global demand. Today the college has spread its wings by offering 20 UG and 9 PG courses and indeed proved to be a front runner in the field of higher education in this region.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The College designs the curriculum through Board of Studies. The revision of curriculum is made once in every two academic years based on local needs and learning objectives. All the departments have undertaken skill development courses to prepare the students for employability. The College has been selected under PMYUVA entrepreneurship development programme sponsored by Ministry of Skill Development and Entrepreneurship, Govt. of India. Three new courses B.Sc Geology, M.Sc Botany and BLISc have been introduced during the last 5 Years. Choice Based Credit System has been introduced in the curriculum from the academic year 2014-15. Semester system is followed right from the inception of College under autonomy i.e 2004-05. The Social consciousness and value based education is imparted by introducing subjects like Gender sensitization, Environmental Education, Value Education, science and technology and Indian heritage and Culture. Telangana State Knowledge Centre programme included in the main curriculum to develop Soft, Computer and reasoning skills, personality development and career opportunities regularly. The College enrolls 40% more students every year on local demand. The College got appreciation letter from the Commissioner of Collegiate Education, Hyderabad for being second highest student enrollment in the entire State of Telangana Students from infield project, trips and other activities.

Feedback collection from students, teachers and other stake holders and analysis has been a regular practice in the College by the IQAC. The feedback and its analysis is discussed with the students, staff in the classes, staff meeting and measures are taken for redressal.

Teaching-learning and Evaluation

The College adopts students centered teaching and learning methodology. The demand ratio for admissions in the College is 1:8. The faculty strength is satisfactory. The gap of vacant faculty positions is fulfilled by engaging Contract and Guest faculty.

All Students are involved in teaching learning through projects, seminars and assignments. Apart from regular class room teaching, ICT based teaching is also provided. The College has 4 fully equipped modern e- class

rooms. All the academic departments have ICT tools and resources. To identify slow and quick learners, every class is monitored by teacher mentor. The mentor facilitates learning of the students and helps them in solving academic problems. The Academic calendar is well prepared in the beginning of academic year.

The faculty of the College are well experienced in teaching and have vide exposure to research work. Most of them have received recognition and honors as best teachers by the authorities. The high pass percentage of students, high demand ratio of enrollment is the evidence of provision of best learning practices in the College.

Being an autonomous institution the College has a well functioning and fully automated examination branch to look after the examination and evaluation process. There are very less cases of grievances of evaluation and reevaluation. The programme out comes and the results are analyzed subject wise and lecturer wise and measures are taken for any shortfalls at the end of each semester.

Research, Innovations and Extension

The College has a well defined policy for research and innovation. A number of National Seminars and Workshops are conducted in the College. Many of the faculty members are undertaking minor research projects of UGC. The College has established central research labs under CPE grants. All science departments are well equipped with adequate research equipments. The College library has a vast collection of e-books and e- journals through INFLIB NET in addition to vast collection of reference books and journals in the Library. Four of our Staff members are recognized research guides. Many staff members are pursuing Ph.D Degree.

All teachers publish research papers in renowned national and international journals. A well defined code of ethics has been framed in the College to check plagiarism. Many staff members have presented their papers in different National and International seminars, in addition to authoring many books with ISBN numbers. The College has made research activity practical on par with regular teaching activities.

Extension activities are taken regularly through NSS and NCC. The College has 5 NSS and 1 NCC Units. The Regular activities like cleanliness, swacha bharath, shramadhan, Haritha Haaram, Health camps blood donation camps, social awareness camps are conducted in neighboring Community. NSS Volunteers and NCC Cadets have been selected for RD and Pre-RD parade in New Delhi. Our NSS and NCC volunteers help the District administration in various programmes like Haritha Haaram Survey in the District, Pulse Polio and other.

Infrastructure and Learning Resources

The college has well maintained building in two blocks of UG and PG with ground of area of 27.23 Acers. The class rooms are equipped with proper lighting, seating with good number of furniture. The College has four technology enabled smart class rooms, Mana TV room, a state of the art auditorium, equipped with modern audio visual instruments, , administrative and staff rooms, academic and examination cells. It has two fully automated UG & PG libraries equipped with INFLIB NET. There are 15 laboratory rooms equipped with good amount of instruments, Botanical and Zoological museums. Separate Boys and Girls hostel building is also in our campus. Fully equipped Gymnasium, Canteen, First Aid Centre, girls rest/recreation room, parking lounge and washroom blocks. The college has an English Language Lab with 30 computers with Wi-Fi connectivity. The college has also safe drinking water facility through three R.O water plants. Uninterrupted electricity supply is ensured with the help of one 100 KV Gen Sets, and many inverters and UPS systems.

The college has a botanical garden and many lush green lawns to beautify its campus, besides a playground spread over 27 acres of land for outdoor games and athletics. The college is equipped with more than 300 Computers, of which more than 100 are internet connected. 05 new class rooms have been constructed, the existing building and auditorium is being renovated under RUSA. All the departments have ICT facilities with interactive boards visualizers, LCD projectors and audio visual equipments.

Student Support and Progression

The College has facilities for outdoor & indoor sports and games. All the deserving students receive scholarship from the State and Central Govts. The details of college and facilities provided are placed on its web site. We also publish an annual magazine "SRUJANA" which provides a platform for the students' creative writing.

Remedial coaching is regularly provided for slow learners. The college also conducts coaching classes for aspiring students for Post Graduate Entrance exams, CSIR-UGC NET Exam and other Job Oriented Exams. The college has well established career counseling cells for guiding students towards a better career. For the support and care of female students the college has a well developed women empowerment cell, Separate Girls rest/recreation rooms. **SHE** Teams have been constituted to ensure safety and security of Girl students. The grievances are redressed through ICC.

During the degree course the students are trained in Language skills, computer skills, Personality development.

The college follows the policy of reservation as fixed by the state government in admissions. The students are also involved in various academic and administrative committees of the College. The college has an Alumni Association. They support the college administration through various activities like declaring awards/ rewards medals to the meritorious students. Our Alumni is placed in higher posts. The present DGP Jammu and Kashmir, Vice Chancellors of Kakatiya University, Directors and scientists of many research organizations like IICT, NIN, ICRISAT etc. Nine members of present regular faculty including Principal are from Alumni.

Governance, Leadership and Management

The College is a government institution, the Principal, teaching and non-teaching regular staff are appointed by the State Government. Principal sets the internal policies and programs with the association of Heads of various departments, conveners of different committees, librarian, members of non-teaching staff. The budget allocation to the college is made by the State Government and UGC which is distributed to different departments for various activities by the approval of Finance committee. The financial management is assisted by the Administrative Officer and other Non Teaching Staff. The college interacts with students through a feedback mechanism, besides giving participation to students as members in various administrative and academic committees. The minutes of the meetings are maintained and presented in the Governing body. The society inputs are obtained through teacher-parents meeting and meetings with civil society and alumni association. The faculty members are encouraged to attend academic and professional development courses including Orientation, Refresher courses and others. The financial transactions are audited both by internal and external audit committees. The college has a well established IQAC which is instrumental as a part of all academic developmental decisions. The IQAC frames a schedule of meetings and other activities at the beginning of the academic session and makes a review to assess their progress on monthly basis. In the scheduled meetings the departments are accessed for their academic progress, attendance records, quantum of syllabi completed, tutorials, assignments and students presentation, etc. The departments are also assessed for their infrastructural needs.

Institutional Values and Best Practices

The College is known for its high institutional values and its best practices. The critical issues like Gender Sensitization, Human Values, Environmental consciousness, our pride Heritage and culture are given utmost importance and they are included in the curriculum.

Environmental consciousness and preservation is given prime importance in the institutional programmes. Consumption of electrical power is made to a minimal extent. The class rooms are fully ventilated as such the fans and lights are seldom used. The air conditioners are used rarely. LED lights have been installed to minimize the power utilization. Students and staff are regularly motivated to use less power.

Rain water harvesting, waste management pits are constructed and they are taken care. Green practices are combined with healthy practices. Most of the staff and students use cycles and public transport. Special programme of Haritha Haaram is taken every year .

Locational advantages and disadvantages are explained to the students. Value education is made compulsory as a part of curriculum. National Festivals are celebrated in the College. Social awareness programmes like Voters Day, Consumer Day and Teachers day and others are celebrated. To create consciousness of National identities and symbols, fundamental duties and fundamental rights, different competitions are held among all the students.

Code of ethics, transparency in finance and administration is maintained. Internal and external audit is conducted every year.

To improve the teaching learning process, many best practices are conducted in all the departments.

In addition to the regular curriculum some of the departments introduced skill enhancement programmes, certificate courses. Quick learners are identified through their performance in examinations, interaction in class room and laboratory, their fundamental knowledge, concept understanding and articulation abilities etc., The College promotes independent learning that contributes to their academic and personal growth through making them participate in study projects in other research activities in and outside the college.

Strategies adopted for student improvement:

Remedial classes are organized to clarify doubts, re-explaining of critical topics for improving performance. Poor performance due to frequent absenteeism is dealt by sending

SMS and registered letters to the parents. Appropriate counseling with additional teaching, eventually helps students to attend classes regularly.

All the staff members maintain good relation with students and deal with their problems in a gentle manner. Each class is under the supervision of a class incharge and students self support system like mutual group discussion along with tutorial classes are conducted to all students for all branches of Undergraduate courses.

Laboratory experiential learning: Practical knowledge is always justified with the moto of of learning by doing. Our college laboratories are fully equipped in all subjects to provide practical knowledge to the students. In languages the IB system is also followed where the listening and speaking abilities are enhanced. Thus we try to expose our students to all the laboratories possible beginning from the first year. Every lab is also automated through latest technologies. The Zoology Department has a museum. Research labs are also made available in each department.

Study projects:

The committee members enjoy the freedom of expressing their views in the strategic modification or improvement of the polices and activities for the overall enhancement of the academic quality.

6.2 Strategy Development and Deployment

Response:

The college Administration along with Head of all Departments discuss & review various academic activities of the College and formulate strategic plans for further improvement by frequent meetings and resolutions. Academic committees are constituted by involving most of the staff members to monitor and evaluate academic policies .

Strategic examples of our College is Counseling method of Admissions: The college has been adopting the counseling method of admission into all UG Programmes for the last ten years till 2015-16. The 10+2 eligible students have to enroll their details through online for their interested and eligible groups. After online registrations the students have to submit the online registration application forms in the college by paying the required fees. Group wise merit lists are prepared and the students are called for admission counseling on four different consecutive days i.e. Mathematical Science groups, Biological science groups, B.Com groups and Arts groups respectively students are given admissions into various groups on merit basis into their interested and eligible groups only. Then the selected students have to pay the required admission fees. The total process of admission is completed on same day of counseling. This process of counseling facilitates the college administration to start the class work at an early date and in time.

Our college has the pride of highest representation of study projects in the state level competitions.

Solid waste management is being given utmost importance in the College. Following swacha bharath programme the waste is dumped after segregation. The garden waste is dumped in the compost pits. The Municipal authorities also cooperate in disposal of waste. The class room waste mostly consist of paper hence it is disposed by incernation. the e-waste and other type of waste are disposed following Municipal guidelines . It is mostly handed over to Municipality. There is no lequide produced as it is directly delivered in to the septic tanks. Hence waste management is done propely in the College. variuos programes of awareness regarding waste management among students are conducted frequently. The compost obtained from the compost pits is utilized for the botanical garden in the College. The department of Chemistry, Zoology and Botany are actively involved in waste management programmes. E-waste generated in the College is identified by the committee and handed over to the technical authorities for disposal.

BEST PRACTICES

1. PROGRAMMS FOR STUDENTS EXCELLENCE

Academic excellence has been the vision of the college since from its beginning. Students of high academic standard choose Girraj College. The trend of Professional courses attracted more educationally conscious students to that field. But many students with high academic interest belonging to economically backward communities join this institution. Most of our students come from rural background with most of illiterate parents. These students cannot afford to go for coaching institutes at farer places. Hence to provide an outreach program to such quick learners and other students and facilitate them achieve academic excellence, this program of "STUDENTS EXCELLENCE" is started as a best Practice from 2010-2011. Since the program is being implemented continuously. This is planned to provide extensive academic assistance to the students apart from regular teaching. Exposure to the outer competitive world will be given to students to achieve higher goals in life. Opportunities are created and made known o the students by making them interact with people who excelled in life. Students are exposed to various life situations so as to decide a right path of their choice themselves. This program is so designed to provide the students to undertake some activities out of their curriculum to help them to face other competitive exams and challenges.

OBJECTIVES:

- 1. To provide an opportunity for the quick learners to excel in life.
- 2. To provide extra academic support.
- 3. To enable the students to achieve their ideals and goals in life.
- 4. To provide free coaching for pursuing higher studies entrance examinations and other Job oriented exams.
- 5. To provide a comprehensive outreach educational program to the students.
- 6. To help the economically poor, students of rural background face future challenges of higher studies and jobs at the college level.

THE PRACTICE

The program is intended to provide extra coaching and exposure in the final year of their graduation and Post graduation. It starts in the first year of the course by providing a week long bridge course. During this bridge course students coming from different +2 (Junior Colleges) level institutions are made to understand the different activities and standard of our college and understand the faculty and the class mates. They are made aware of different facilities available in the college. Every course is assigned a course incharge to guide them. During the whole first academic year it is made possible that students clear all the semester exams so that they are prepared for extra academic support. During the second year of their course students are provided more access to ICT based teaching, extra training in the use of E- Resources is provided. For this the college has sufficient facilities. There are six computer labs with more than 100 computer systems, Four E- Class rooms besides every department has ICT based teaching facility. The final year students are regularly provided coaching to the PG Courses entrance exams by most of the departments. Department of Chemistry, Economics, Commerce, Zoology, Mathematics, and English is regularly conducting PG Entrance coaching. Career counselling cell is providing coaching classes for job oriented exams like VRO, Police constables, Sub Inspector of Police and Group exams. Overall more than 50% of our final year students are pursuing PG courses. The students of Post graduation courses in Chemistry, Physics, Zoology, Mathematics and Botany are given coaching for CSIR NET coaching regularly. Every year 3-4 students get selected for JRF- NET.

OBSTACLES FACED AND STRATEGIES ADOPTED:

The main obstacle was the time for the conduct of extra coaching and funds required. As the college works in shift system, the faculty voluntarily decided to conduct in the zero hours. Requirement of funds is partially met from the autonomy and other UGC grants. College being autonomous helped a lot in choosing various activities and funding them. Above all the active involvement of faculty members helped to undertake this practice regularly.

BEST PRACTICES

2. Faculty motivation for Research:

Research and innovation has been an imported factor for the important of academic standard of any institution. It gives a critical and creative thinking among students and faculty due to centralized syllabus at under graduate level, very less importance is given for research. It can be said there is no place for research activity in the curriculum of any under graduate course. Girraj Govt.,College is an autonomous College, hence we took the liberty of modifying syllabus and made it regular practice among students and faculty to undertake research activity in the College.

Promotion of research among faculty members will help them to profess the subject deeply and inspire the students. Further a teacher involved in research will not only adhere to the basics of subjects but take the students near to the recent advancements and innovations. It will help the students to know the innovation and create similar things. With this context, it is made a best practice the college to promote research activity among students and teachers.

OBJECTIVEs

- 1. To promote research activity among students and faculties
- 2. To motivate the faculty to undertake research project.
- 3. To motivate the staff to publish papers in Journals
- 4. To enable the students and the staff to access the e-journals.

Obstacles and Resources:

Girraj Government College is an Autonomous college, there is a dire shortage of Regular teacher, and hence all the faculty members have to share the responsibilities. They do not get enough time to undertake the research activities. Provision of finance is also a major obstacle.

The college being autonomous and conferred with CPE status get some grants from UGC helps some of the financial provisions were met. The faculty members formed a faculty forum voluntarily to promote research in the college and under taking research with the limited resources.

Impact of the Practice.

The college administration supports the student and faculty members in attending and conduction Seminar and Workshops. The faculty member is actively involved in publishing papers in Journals. Four of the staff members are recognized guides for Ph.D. many books have been compiled and written by our faculty members. Every year some of our faculty members are awarded Ph.D Degrees. Every year a number of National Seminars are conducted. Research projects financed by UGC are being undertaken. Five MRPs have been completed during last four years. A research centre involved all the Departments are functioning in the college. The science Departments have partially equipped Research laboratories. Research activities are regularly under taken in the College as a best practice.

3- Best Practice

SERVING THE SOCIETY BY ADOPTING SCHOOLS AND COMMUNITY

OBJECTIVES:

- 1. To make the students aware of the education system and facilities for higher education available in the locality.
- 2. To create scientific temper and creativity among students and the community.
- 3. To decrease the drop out percentage.
- 4. To maintain a rapport between the college and the society.
- 5. To conduct scientific experiments and demonstrations to eradicate superstitions.

THE CONTEXT

Girraj college always aimed at overall development of the community by providing education which will not only help the individual but to the society. It was mentioned that 70% of the students of rural background become drop outs after their school education. Some do not pursue higher education due to non availability of facilities and most of them due to non awareness of the importance and proper motivation and encouragement. With this intention a practice is started by the college to adopt some of the neighboring schools to make the student and society aware of the facilities of higher education available in the locality. Department of Chemistry adopted Two schools 1) Woodbridge High school NRI Colony Nizamabad and Govt. High School Arsapally Nizamabad. Department of Zoology adopted Govt. High School Dubba Nizamabad.

THE PRACTICE:

Every year in the month of July the faculty of our college visits the school, talk to the students of IX and X class, collect their family details. Then after they regularly interact with the students and few of their parents. Special classes are taken to give them some amusing facts about the subjects chosen. In the mean time we get known the interests of the students and their parents. Teachers of the school are also contacted frequently. Practical demonstration are also conducted. Students are called to the college for directly observing the laboratories and library. They are allowed to interact with the students of the college and other staff. Some competitions like elocution, essay writing, drawing and cultural are conducted among the adopted school children. It helped a lot in achieving the objectives of the practice.

OBSTACLES FACED AND THEIR SOLUTION:

The main obstacle in this activity was the time constraint, it was overcome in the other session of the college as our college works in shift system. The principal of the college cooperated a lot thus the obstacle was overcome.
