#### 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

Government Degree College, Paloncha was established on Dt.: 18-11-1991 by the Government of Andhra Pradesh as a dream of the people of the scheduled area to cater to the higher educational needs of the poor and marginalized. It was started in the premises of local Government Junior College building and worked in shift system from its inception till 2006 and shifted to present new building. The motto of the institution, "NahiGnanenaSadrusham" is taken from a Sloka that belongs to the fourth chapter of Bhagavad Gita', it means wisdom is majesty pure, and divine. Across the period of time, the institution has made its own mark through consistent service to the poor.

Government Degree College, Paloncha had in its humble beginning in 1991 offering only B. Com, B.A course with a meager strength of about tens of students. The college has taken nearly two decades to flourish and introduced Science courses in Telugu medium from 2009. In the academic year 2016-2017 the science course, B.Sc. has introduced with English and Telugu medium. In accordance with UGC guidelines and state government directions, the institution offers all the courses with the choice-based credit system (C.B.C.S) from the academic year, 2016-17. In 2020-21, a Post-graduation course, M.Com is introduced in the college. This college also holds a student study center of the Dr.B.R Ambedkar open university, Hyderabad, Telangana. The institution has been following the curriculum executed by the affiliating university, Kakatiya University, Warangal, and Commissionerate of Collegiate Education, Telangana.

Government Degree College, Paloncha has been providing quality higher education at an affordable cost to the rural youth from far. During the 1st cycle of NAAC accreditation in the year 2016, the college has got 1.86 and got NAAC "C" Grade and now the institution is preparing for the 2nd Cycle of NAAC Assessment and Accreditation.

The institution is framed within demarcated Motto, Vision, Mission and Core Values that reflect the uniqueness as per the needs of the students and value orientation to the downtrodden people residing in surroundings of the college.

#### Vision

The vision of the college is building a reliable qualitative higher educational institute for the students of the agency area especially those from tribal communities and the college was established to bring out the innate potential of the rural poor of Paloncha, a town in Bhadradri Kothagudem District. The college envisages the intellectual development, moral honorableness, social commitment, cultural refinement, spiritual enlightenment and emotional ripeness of the future generation. Developing potential for academic excellence, establishing skill enrichment and inculcation of human values, this institution believes, Graduation is an important phase in a student's life. It is crucial point where the transformation of a student into a professional and holistic social being, begins and paves the way for his/her successful future.

#### Mission

The mission statements of the Government Degree College Paloncha are aimed at rendering the vision of the college into reality through a scrupulous action plan and defining its striving and engagement in the realization of its vision.

#### The GDC, Paloncha is

- Strives to expand access for all sections of people to higher education with a special focus on tribal students with a policy of commitment and excellence.
- To cater to the Academic needs of the students at the UG level with an institutional planning and university curriculum implementation
- To practice innovative teaching methods like Lecture discussion methods, Content generating methods.
- Providing quality education and carrier guidance.
- To motivate and organize the students for self-learning through Internet, Library, Field survey, etc.,

The college addresses, as part of its mission statements, a wide range of students' requirements by introducing new courses to meet the continually changing requirement and employability through various streams of the under-graduate programmes, such as B.A., B. Com., and B.Sc. with different combinations/programmes. The Telangana Skill and Knowledge Centre (TSKC) of the institution impart computer skills and other employability skills to the learners so as to empower them to face the ever-increasing competitive world. *Yuvatarangam* offers students a platform to present their special skills and abilities in sports, games, and literary and cultural activities, while *Jignasa*-Student Study Projects trains them in project-based learning. Career guidance cell organises seminars, workshops, soft skill programs to fill the students' academic advance requirements.

The institution regularly conducts different kinds of programs every year the birth and death anniversaries of the great Indian leaders thereby preparing them towards the universal values of truth, non-violence, honesty, integrity, and universal brotherhood. NSS extension activities, Harithaharam, Swachh Bharat, construction of rainwater harvesting pit, etc., are taken up to frame the character of the learners valuing the coordination between humanity and nature.

### 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

#### **Institutional Strength**

- The college can accommodate a good number of students and programs.
- The College has 15 acres of land and can expand presents facilities further to meet the future needs.
- Hostel Facility for boys hailing from far off places within the campus
- Highly qualified, experienced, and committed faculty
- Affiliated to Kakatiya University which is well-known for its academic and other curricular programs Enthusiastic, meritorious and obedient students
- Well-ventilated classrooms which substantially reduce the power consumption
- The college is offering a Post-Graduation course(M.Com) for rural students in the surrounding areas
- All eligible students can get fee reimbursement from the State Government which is a great incentive

for students from an economically poor backgrounds.

- Commitment to educate the rural lot and harness their potentials enabling them to meet the global challenges.
- Student-centered teaching-learning and intensive counseling.
- Content and process of the core curriculum.
- Conducive Institutional environment to build strong relationships between stakeholders.
- Being a government institution, the college collects a nominal amount of special fee and tuition fee and provide quality education.
- The institution has a National Service Scheme unit that undertakes many outreach programmes for community service awareness and promotion
- The college also promotes distance education by having one Dr.BR. Ambedkar University Study Center for the students who are engaged with their works and not able to classes regularly.
- Good rapport with the Feeder Colleges.
- Advance Planning of academic activities & implementation with efficient communication.
- The college has good greenery and a botanical garden which can create an aesthetic feel for the students.
- The college has different cells and units such as IQAC, Career Guidance Cell, Entrepreneur Development Cell, MANA TV cell, Eco club, BHAGYA Cell, Consumer Club, Cultural Club, Sports Club that support the overall growth of the students.
- The college has 14 CCTV cameras and completely surveillance the classrooms and college premise for the security girl students and students and staff belongings.
- The college also offers Mid-Day meals for the sake of poor and down-ridden students.
- The repertoire of library books and access to e-resources to meet the complete academic needs of the students.

#### **Institutional Weakness**

Though the college is blessed with the strengths mentioned above, the Government Degree College Paloncha is suffering from the following few weaknesses:

- The college has a boys hostel within the campus but for the girls, hostels are far away from campus. So it is somewhat difficult for girls who are staying at hostels to reach the college in time
- The College is located 3 kilometers away from the Paloncha town making it difficult for the students for local transportation.
- Since the college is a public-funded educational institution, it needs to adhere to the stringent rules and regulations of the State Government, reducing the functional autonomy of the college.
- Most of the students are breadwinners of their homes and they are struggling to attend college in order to earn wages.
- The College is affiliated with Kakatiya University and is unable to create its own curriculum.

#### **Institutional Opportunity**

Despite the weaknesses mentioned above, the college has the following opportunities with which it can better itself and can become an institution of eminence:

- Optimum utilization of the available infrastructure and other facilities and resources.
- The NSS can further instill amongst the students a sense of service and train them in social skills.

- A functional TSKC to impart employability skills to the students.
- A team of young, dynamic, and dedicated staff members who are enthusiastic to work for the all-round development of the students.
- The institution encourages the staff members to participate in various developmental programmes, seminars, workshops organized at District, State, and National levels by various Institutions and Universities.
- Students have the opportunity to participate in various Games & Sports and Cultural & Literary competitions to showcase their hidden talent and interact with students of others in the youth festivals at the district level. State Level and National Levels.
- Opportunities are provided to the students to exhibit their skills in their area of specialization.
- Flexible and complete concession of fees to the students who belong to ST and SC and OBC communities.
- The institution always encourages Curriculum expansion.
- Students are provided with the opportunity to get scholarships every year directly into their bank accounts
- With a variety of collection of books and e- sources available in the library off the burden from purchasing the text books.

#### **Institutional Challenge**

In order to grow further as a vibrant educational institution, the college faces the following challenges:

- Maintenance of the huge building with a carpet area of 15 acres campus square feet is a big challenge.
- Scaling up campaigning to reach a much wider student population to attract them towards the college
- Collaboration with philanthropic institutes is needed for the enhancement of educational standards.
- The students being from marginalized families where the parental care and domestic encouragement is far below the optimum, it is a challenge to provide them healthy motivation to a higher life and sustain it against odds.
- To impart seriousness and attract the attention of the students to the concepts of excellence, responsible citizenship, democratic temperament, and life skills like time management and problem-solving is limited.
- Innovative practices for students of various streams is also limited
- Organize a faculty training program to empower and enable the use of various innovative tools and technology for improved teaching and learning is difficult with single faculty in every department.
- Developing global perspectives among students not up to the mark

Develop Community outreach, Curriculum expansion, and technical Support is limited possible

#### 1.3 CRITERIA WISE SUMMARY

#### **Curricular Aspects**

The Criterion-1 deals with the detailed effective curriculum delivery of the Government Degree College, Paloncha by framing a well-planned and documented process. The College Calendar, the affiliated University's almanac and the Commissionerate of Collegiate Education annual Academic and Activity Calendar direct the curricular delivery in the institution.

The College is a developing organization and hence, many new programmes/courses have been introduced during the last five years to meet the curricular demands of the students and other stakeholders. In accordance with the changing educational scenario, the institution has been implementing the Choice Based Credit System (CBCS) since 2016-17 for UG programmes and 2020-21 for a PG Course – M.Com.

Environmental Studies, Gender Sensitization, Communication Skills in English, Computer Basics and Automation, Water Resource Management and Human Values and Professional Ethics are some of the subjects integrated into the curriculum for enhancing Academic flexibility. The curriculum of Telangana Skills and Knowledge Centre (TSKC), a skills training wing of the college contains elements of soft and life skills.

The institution is presently offering 17 UG programmes and has English, Telugu, Hindi, Mathematics, Physics, Chemistry, Botany, Zoology, Economics, History, Political Science, Commerce, and Computer Science Departments. The institution adopts a student admission procedure as prescribed by the government of Telangana and the Affiliating University based on the merit and social status.

The mission statement defines the institution's distinctive characteristics in terms of the needs of the society and institutional responsibility to the society and the students it seeks to serve. The institution values rigorous assessment of the academic process and believes in providing valid and reliable assessments to measure and improve student learning and effective teaching.

The Criterion 1 of the SSR presents the details of the courses imparting transferable and life skills offered during the last five years and field projects or internships undertaken by the students. Similarly, this segment also gives the particulars of the structured feedback received from the stakeholders such as students, teachers, alumni and parents for design and review of syllabus year wise and method of its collection, analyses, and action taken and placing it on the institution's website.

#### **Teaching-learning and Evaluation**

The Criterion 2 of the SSR which is named as "Teaching-learning and Evaluation" provides the details of the year wise enrolment of students in the college against the total sanctioned seats during the last five years: 298/420(2020-21), 221/420 (2019-20), 197/440 (2018-19); 90/280 (2017-18); 85/340 (2016-17). This criterion also explains the facts that 70.61% of the reserved seats have been filled for various categories. That the student full time teacher ratio 36:1; the number of differently abled students (*Divyangjan*) on rolls (03); the full-time teachers against sanctioned posts 17:19 and the percentage of full time teachers 93.56; and the full-time teachers with Ph.D. against the sanctioned post during the last five years 6/17; 6/17; 5/17; 1/17; and 0/17 with their total teaching experience 187 years (average 11 years) also find place in the Criterion.

The details of the bridge courses, extension lectures, quiz competitions, remedial classes for slow learners, and student seminars, project works, PG entrance coaching etc., for advanced learners and the practice of student-centric methods for enhancing learning experiences of the students are also included in this Criterion.

In the college, 17 out of 17 full time teachers use ICT for effective teaching(2020-21); The mentor-mentee

system is followed to provide academic, personal and psychosocial support to its students.

The practice of transparent internal assessment as part of the reforms in CIE system and the transparent, time-destined and competent Redressal of the examination in concern to grievances and observance of the college academic calendar and the almanac of the affiliating university for the conduct of CIE find place in the Criterion. The particulars of students' pass percentage 78 % of its students(104 passed as against 133 appeared in 2020-21) and average for 5 years 66.58% finds mention in the Criterion. The POs, PSOs, and COs and the student satisfaction survey on teaching learning process make their way into the Criterion.

The students database for online student satisfaction survey is also included in this criterion.

#### **Research, Innovations and Extension**

The Criterion 3, as title "Research, Innovation and Extension" indicates this segment provides the details of various aspects associated with research, innovations and extension activities undertaken by the college for the last five years.

A total of 2.0462(INR in Lakhs) was received for the endowment Mid-Day meals and furniture arrangements for Digital Library the institution.

Government Degree College, Paloncha organised 20 workshops/seminars for the benefit of the students; The Research Committee of the institution encourages the staff and students towards research aspects issues, checking malpractices and plagiarism during work-articles, thesis, etc. Due to the efforts of the committee, 8 research papers were published and 7 chapters in edited volumes / books published in the ISBN and ISSN journals.

Around 50 extension and outreach programs organised in collaboration with industry, community and NGO through NSS during the last five years with the active participation of the students. Average percentages of the students in the extensive activities are 63.61. The college also received 5 for extensive activities from Governmental recognised bodies.

The college has 93 linkages for faculty exchange, student exchange, internship, field trip etc., and 62 functional MoU's with institutions of state, national, international importance, industries, corporate houses etc. The students of the college are being benefited from these arrangements.

#### **Infrastructure and Learning Resources**

The Criterion 4 of the Self-Study Report named "Infrastructure and Learning Resources" provides the details of the infrastructural facilities in the institution for effective teaching learning process. This segment of the SSR provides the details of academic, administrative and support facilities existing in the college.

The college is located in a total area of 15 Acres of land and the constructed plinth area of the building is about 1430 Sq., Mts. The building has two floors, one ground floor and one up-stair. The building has 12 Class Rooms which are spacious, well-ventilated and furnished. Four classrooms have LCD projectors and interactive setup computers converted to digital classrooms. Digital Classrooms are connected with UPS Inverter to overcome power interruptions during classes and internet connectivity. One classroom is a virtual classroom

that also enables video conferences. In addition the college also has many infrastructure facilities. The percentage of ICT classrooms is 53.85.

Average percentage of expenditure, excluding salary for infrastructure augmentation during the last five years is 58.5Lakhs.

The college library is fully automated with SOUL 2.0 of UGC and NLIST subscription to avail accession of eresources. The college also has 1 digital library and Jio Wi-Fi facility for the entire college. The college has 14 CCTV cameras surveillance for the entire classrooms and campus. An amount of 0.16Lakhs used for the purchases of books. Percentage per day usage of library by students and teachers is about 19.29 and daily 120 students & teachers visit the library. The college has 97 computers and they are equipped with necessary accessories and software and the student-computer ratio is 7:1. All the computers are connected to the internet and its speed is 50MBPS. 42.95L is incurred for the maintenance of the infrastructure.

Different committees of the college are constituted for fruitful utilisation of the resources available in the college, comprising the Principal as the Chairman, senior members of the faculty as Conveners and other teachers as members. These committees meet regularly to discuss their concerned aspects. Stock verification is done annually. The lists of equipment for repair are prepared by the respective in-charges.

#### **Student Support and Progression**

The Criterion 5 of the SSR, "Student Support and Progression" provides the details of support facilities available in the institution such as scholarships, games and sports, cultural activities and the particulars of students' progression to higher education or success in NET/SLET, PG entrance examinations, and placements.

Scholarships by the State Government: Every eligible student of the institution has been provided a scholarship. 785 students studied in the college for the last years received scholarships to the tune of Rs. 4519594 and its percentage is 48.36.

Guidance for Career and Competitive Examinations: 1758 students benefited from the Career Guidance, Counselling and Competitive examinations in the last five years and its percentage is 63.65.

Transparent Grievance Redressal Mechanism: Through the student Grievance Redressal Committee, the ICC, and the WEC, and the Complaint Box, the college has also put in place a transparent mechanism for redressing the student grievances, if any. There have been only 11 grievances reported during the last five years and these were mainly related to water, internal road, mid-day meals, bus passes, maintenance of washrooms, etc. That there has been no sexual harassment complaint and no ragging complaint reported in the college testifies the standard of descent behaviour of our staff and students. The average percentage of the student placements is 1.46 and 80 students of the college progressed for higher education in different institutions. One old student of the college qualified SLET examination and 6 other students qualified in other employment related examinations.

Cultural and sports events: The college organised 24 different Games & Sports and Cultural and Literary Competitions in the last five years. Our college students won 9 awards or winner positions at various level Games & Sports and Cultural and Literary Competitions. Student leaders of the Student Council were elected by the staff club and Principal based on their academic merit; they are coined as 'Class Representatives'. The Palvancha Degree College Old Student Welfare Association, registered under Societies Registration Act and its

contribution to institutions in concern to the terms of monetary and non-monetary means. The alumni contributed Rs. 41500 worth items to the college.

#### **Governance, Leadership and Management**

The administration of the institution ruins every activity pertaining to the significance of the vision and mission statements of the college and creates an empowering academic environment in that the students recognise their potential and transform themselves into multifaceted personalities. The committees such as CPDC, Staff Council, IQAC, Grievance Redressal Cell, WEC, ICC, Anti-Ragging Committee and other committees constituted with the senior teachers as members under the chairmanship of the Principal contribute their services in the execution of the vision and mission of the college. The views or opinions expressed by the students on the committees are given top priority. The feedback from the stakeholders, students, teachers, parents and alumni is also given priority in the planning and development of the college.

Criterion 6 also provides the Perspective Plan of 2015-25 and organizational structures of the college. The college has been implementing e-governance via e-Office, CAIMS, DOST and e-Pass. The facilities such as HRA, DA, GPF, CPS, TSGLI, home loan, maternity leave, paternity leaves, Group Life Insurance sanctioned for welfare of teaching and non-teaching staff.

The college is provided financial support and encouraged to attend 52 training programs. The college has organised 16 professional trainings for the staff. The college adopted the Institution Performance Appraisal system for teaching and non-teaching staff by API scores, student feedback and academic audits and in that all the faculty members scored good marks.

The college regularly undergoes Internal and external financial audits. AG Office audit was conducted in 2017 and CCE conducted in 2021. Internal audit runs every year under the chairmanship of the Principal.

The college received 44100 worth of material from the philanthropies in the last five years. The college constituted various committees for the mobilization of the funds. Now the college is utilizing the RUSA 2.0 and UGC funds for the infrastructure development.

The IQAC reviews the process of teaching learning and learning outcomes thereby initiates post- accreditation quality initiatives and encourages promoting quality culture by organizing seminars, research activities, ICT utilisation etc. IQAC conducts quarterly meetings for strengthening quality education and succeeded in ISO certification and regular audits.

#### **Institutional Values and Best Practices**

The Criterion 7 of the SSR explains the Institutional Values and Best Practices with the college regular curricular activities. The Institution exhibits gender sensitivity in providing facilities such as Safety & Security, Counselling and Common Room. The college gender action plan and conducted 12 gender equity promoting programs in the college.

The college strives for alternate energy and energy conservation initiatives such as: classrooms are well-ventilated to get natural air and sunlight and use of LED light bulbs in the entire college. The college is efficiently managing degradable & non-degradable wastage as per the standard guidelines and has MOUs with

corporate agencies for the proper disposal of e-content.

Conservation of Water resources is taken as high priority in the college and for this the college has 4 rain pits, 2 Borewells, 1 water tank and well water distribution system. For the Green Campus initiatives the college restricts entry of automobiles for some locations, encouraging ecofriendly vehicles, pedestrian pathways, ban of plastic usage and landscaping. The college conducted quality audits like Green audit, Energy audit, environmental audits with the respective authorities.

The college is providing facilities for the *Divyangjan* students like Ramp, disable friendly washrooms, machinery, software, scribe facilities are available for the differently abled (*Divyangjan*) students.

The college has been taking many efforts in providing inclusive growth i.e., tolerance and harmony towards cultural, regional, linguistic, communal socioeconomic and other diversities by participating in local important festivals and traditional activities. The college is sensitizing students and staff towards values, rights, duties and responsibilities of citizens by the conduction of various awareness programs and celebrating through NSS, Ecoclub and Bhagya/Health Clubs.

The college designed set of code rules for the benefit of the students and institution and inculcate ethics and morality among the all stakeholders. The college has been celebrating many National & International Commemorative days and festivals through different clubs of the college for the purpose of inspiring the students and shaping their character. The college has many best practices in that Mid-Day meals and QR code system for a college garden are mentioned in the Criterion.

The goals and objectives of the institution aim at providing more opportunities for equity, employability and accessibility for the emancipation of the undivided and development of the nation. Government Degree College, Paloncha had in its humble beginning in 1991 offering only B. Com, B.A course with meager strength of about tens of students. #### **Response:**

The curriculum of Government Degree College, Paloncha is merged with cross-cutting issues like Gender, Environment and Sustainability, Human Values & Professional Ethics that play a potential role to transform the student into responsible and service-oriented citizens for strong nation-building. In the curriculum, the affiliating university of the college gave sufficient niche to introduce courses that help in Character and Personality Development. Apart from this co-curricular & extracurricular activities of the college are primarily intended to inculcate knowledge and awareness on gender sensitization, environmental consciousness, and moral values.

A 2 credits HVPE (Human Values and Professional Ethics) paper is intended to inculcate the moral values, social behavior, and ethics among the students. Separate classes are conducted for these cross-cutting issues to all the U.G. Programmes. Our college is a co-educated institution and has to address gender issues. For this Gender Sensitization, an SEC course (2 credit course) is included in the curriculum. Women Empowerment Cell (WEC) is constituted to promote gender sensitization. Bhagya Unit of the college also conducts many women empowerment programs like health and hygiene, legal aid, Rangoli competition, quiz, and essay writing competitions are conducted periodically. #### 2.2 Catering to Student Diversity

# 2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

#### **Response:**

The students joining the college belong to diverse experiences with different academic standards. Appropriate strategies are strained and deployed by the institution to bridge the knowledge gap of the newly joined students to enable them by accommodating the Program of their choice. At first, the institution tries to assess the learning levels of the newly joined students by conducting subject—wise slip tests to device the previous knowledge in each subject in the chosen program. The slip tests act as preliminary tests which confer a cursory understanding of the standard of previous knowledge of a particular student in a particular subject.

Correspondingly, subject-wise bridge courses are organized to encourage them in coping with the challenges they have in learning a particular subject in the initial stages of the program of their choice. It is inculcated to enhance their knowledge and interest. For instance, if a student from a Science course in Intermediate or + 2 level takes enrollment in the Arts (B.A.), he or she is given a bridge course providing basic concepts of the subjects, such as economics, history, political science, public administration. Similarly for the students from non-commerce stream provided with a bridge course in commerce and non-life science background students with bridge courses in Life science subjects.

The institution is conscious of the special educational/learning necessities for both advanced learners and slow learners. The institution responds to them by organizing special programs for them. Advanced and slow learners of the particular programs are identified from amongst the first year (from Semester II), the second year, and final year students depending upon their performance in internal and previous semesterend external examinations, and also made by question and answer method in the classrooms. The Mentor-Mentee system has specially opted for quality educational improvement among students. In the system mentors closely observe the slow learners and guide them every time.

For the advanced learners, special educational programs like Jignasa, Student Seminars, are organized. Jignasa-the Students Study Projects is a flagship program of the CCE, Telangana organized annually at College Level, Cluster Level, and State Level. In 2017 students of the college won the second prize in the Commerce. Further Advanced learners are also encouraged to participate in debates, group discussions, and quiz competitions, etc.

Slow Learners are understood not as ones slow in learning but are labeled so due to lack of motivation for the promotion in studies by the teachers, parents, and peer groups. As such, faculty members offer bridge course like sessions, introductory and more elucidated lessons make them to keep pace with the advanced learners; facilitate them with cooperative learning; monitor their cumulative progress record; offer Remedial Classes; invite them to Soft Skill Programs; address their psychological, emotional, social, personal, fiscal problems, provide easy-to-follow academic material, use judicious use of mother-tongue in teaching; consult their parents and peers to enquire their attitudinal tendencies and above all communicate with them regularly to establish strong enough to come up in life and career.

#### 2.3 Teaching- Learning Process

# 2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

#### **Response:**

Government Degree College, Paloncha has strong faith in the student-centric methods and associated the pedagogical practices in the classroom and outside of it. These methods followed in the college provide the learners with experiential learning, participative learning, and problem-solving skills useful for enhancing learning experiences. These practices ensure an interactive, participatory, collaborative learning experience for the students.

**Experiential Learning:** The institution strongly believes in experienced learning that enables the learners for the overall development. The laboratories of the college are well-equipped to provide experiential learning to the students. The one NSS Unit of our college is the prime platform for the students to experience the prevailing conditions in the rural society. Accordingly, the NSS unit adopts a village per every year Winter Special Campaigning. In the program, health and sanitization awareness campaigns will be conducted. During the campaigning, the volunteers' experience will help them learn things in a better and quicker way.

**Participative Learning:** The institution always strives to provide all the possible support structures and systems for teachers to develop academic skills such as interactive learning, collaborative learning, and independent learning among the students' community. The student seminars, student study projects, students as a teacher program, science exhibition, poster presentation, group discussion, etc., are regularly organized to enable them for more participative learning. ICT-enabled classrooms also support this method of learning.

Problem Solving Methodologies: The main scope of education in teaching-learning processes is the identification of problems that lie in society and to provide possible solutions. The college strives to take all possible measures to provide the students the prospects where the learners get chances to develop problem-solving skills. Programs like classroom debates, group discussions, students seminars organized

by the college fill problem-solving ability to the students. The Jignasa-Student Study Projects, a flagship program initiated by the CCE is providing opportunities for the students to participate in the study of a problem and come up with their own solutions.

**Project-Based Learning:** Academic Projects, field trips, and field surveys are made a part of the curriculum and assessment. Summer-based projects are also promoted among advanced learners. The sampling techniques, methodology of the study, data collection tools and methods, analysis, testing and interpretation of information, report writing enhances practical-based learning. A group of students under the guidance of AR Satyavathi, Assistant Professor of Commerce won the State Level second prize for their study project on 'Effect of Social Media on Youth' in 2018.

**LMS, Virtual Classrooms & Digital Classrooms:** The College supports ICT-enabled teaching. Virtual teaching has been initiated and proved successful in offering students an opportunity to listen to lectures on varied topics from experts. Digital Classrooms have successfully exploited the audio and video sources of learning. The institution is using LMS to promote e-learning and online courses.

The institution functioned as the integral segment of the CCE, Telangana thereby certain MOUs of the CCE implemented in the college that promote the students to learn skill-based subjects and contemporary important studies.

#### **Response:**

Government Degree College Paloncha is pleased to adopt various innovative teaching approaches, methods, and tools. The college is augmented with ICT facilities like e-class rooms and Virtual classrooms. The college has 4 digital classrooms and 1 Virtual classroom for effective and qualitative delivery of the academic content. The faculty of the college are trained in the usage of ICT tools and it became compulsory in COVID pandemic situations.

Every faculty member conducts lectures using PowerPoint presentations, animations, and documentaries. All the teachers created YouTube channels and preserved their respective departmental video lessons in that channel for the welfare of students. The students of the college are also trained for using the ICT tools, thereby facilitating them to present their students' seminars – webinars, online classes through ICT mode. The college also organized many webinars in online mode.

Four Wi-Fi units/Routers are arranged in the college building to provide 50 Mbps speed of internet enabling uninterrupted ICT teaching and learning process. The Wi-Fi facility can be used by both staff and students for academic purposes. Students are motivated to prepare various teaching materials like Charts, Posters. Portraits and exhibit them in the classroom. They are made to solve previous question papers of

the university examinations by using open online educational resources. The knowledge and information gathered from these facilities help to cope up with current trends and new developments. Awareness programs on MOOCS and SWAYAM were conducted to staff and students and encouraged them to register in online courses to expand their learning horizons. The institution is also using LMS to promote elearning and online courses in the college.

The institution is providing access to educational television channels like MANA TV, T-SAT, and NIPUNA to expand the learning experience. There is a prescribed schedule pertaining to the details of the lectures given by the CCE to watch these channels department-wise. Through these channels, subject experts interacted with the students and ratified their doubts.

The Digital Library and Reading Room of the College Library are fully filled with access to a great collection of ebooks, e-journals, reference books in addition to academic books, periodicals, subject journals, newspapers, magazines of different academic fields in print. The college provides access to N LIST to one and all. This is where the faculty, especially teachers are facilitated with the provision of searching for the content they are in need of.

Subject Seminars and conduction of online classes by the apps like ZOOM, Webex, Exrecorder, Open Board Software-OBS, GOOGLE MEET play an encouraging role in the process of Teaching-Learning content of which can be emanated by way of PowerPoint Presentations which gives access to audio-visual graphical effects to make the concepts simpler in an innovative way. During the lockdown period, online classes and evaluations were conducted using Google Classrooms.

#### 2.5 Evaluation Process and Reforms

#### 2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

#### **Response:**

Evaluation and assessment of the performance of students and faculty members are significant and an integral element in the teaching and learning process of higher educational institutions. For this significant and productive educational strategy, the Government Degree College Paloncha too adopts the Continuous Internal Evaluation (CIE) System to value all the aspects of the students with their growth and development throughout the year.

The examination branch of the college deals with all types of examinations and evaluations including internal and external. The college strictly obeys the evaluation schedules prescribed by the affiliating university, *i.e.* Kakatiya University and its Almanac. The Evaluation includes conduction of Internal Assessments for compulsory and optional subject papers and semester-end examinations. The evaluation of the answer scripts and allocation of credits is carried out by the university *i.e.* Kakatiya University. The college is positive in rectifying the grievances of the students, if any issues, related to examinations. Internal Assessment Tests are conducted in the college by the concerned departments in prescribed formats given by CBCS and Kakatiya University for 20 marks (15 marks for written tests and 5 marks for Assignment). Internal assessment will be done twice in each subject, in every semester. At the end of every Semester, Theory examinations are conducted for 80 marks and Practical examinations are conducted to science stream students for 25 marks by Kakatiya University in each subject.

Notice boards of the college and individual departments are regularly updated with every necessary information in detail affecting evaluation. Faculty members of the college as mentors regularly supervise evaluation and act as a linkage between students and college administration. Similarly, the institution also posts the documents of teaching-learning on its always updating website and students and staff are noticed to visit the website regularly. All the departments also constituted Whats-App groups in which students, staff, and college administrative people are the members. In this way, the institution motivates all the departments to post the required information such as assignments dates, internal examination schedules, and university circulars along with prepared subject-related handouts by the staff as and when needed.

Similarly, the institution also analyses the results of internal and semester-end examinations and gives necessary feedback to students and instructions to the faculty members. The institution also provides necessary remedial measures for their academic improvement. The institution practices the reforms of the evaluation system in obedience to the instructions, guidelines, and schedules of the affiliating university i.e. Kakatiya University. The institution is positive in redressing the grievances of the students if any, concerning examinations.

Some of the faculty members of the college are acting as members of the Board of Studies of the university. They regularly interact with the examination authorities, academic in-charges, and other competent authorities of the affiliating university so that they perform as a healthy bridge between our college and university on many aspects like syllabus design, proposing plausible reforms in examinations for their betterment.

### 2.5.2 Mechanism to deal with internal examination related grievances is transparent, time-bound and efficient

#### **Response:**

The Government Degree College, Paloncha adopts the Continuous Internal Evaluation (CIE) System to value all components, aspects of students' growth and development throughout the academic year. The college believes in the establishment of a healthy Mechanism of internal assessment as a transparent system and with a variety of initiatives. It is amenable in respecting fair and equitable internal assessment with well-versed methods, techniques, and tools that encourage the morale and confidential levels among the students. The regularity of this assessment is made very short, to serve as continuous assessment in the institution too. The following unique initiatives of our college are integral parts of the robust Mechanism of internal assessment.

Continuous Internal Evaluation and the Evaluation process are carried out by both internal assessment and semester-end examinations. The evaluation of the answer scripts of the internal assessment tests is carried out by the college and both Theory and Practical examinations of every semester are evaluated by the affiliating university. Internal Assessment Tests are conducted in the college by the concerned departments in prescribed formats given by CBCS and Kakatiya University for 20 marks (15 marks for written tests and 5 marks for Assignment). Internal assessment will be done twice in each subject, in every semester. At the end of every Semester, Theory examinations are conducted for 80 marks and Practical examinations are conducted to science stream students for 25 marks by Kakatiya University in each subject. After evaluation Internal assessment Tests, the answer scripts, are distributed among the students for their response and transparency in evaluation, besides displaying their marks on the notice boards.

The Examination Branch of the college conducts and evaluates the internal and external examinations approved by the affiliating university *i.e.* Kakatiya University. The college strictly obeys the code of conduction and evaluation and their schedules prescribed by the university and its Almanac. Each department has exclusive Whats-App groups in which their students, staff, and college administrative people are members. Hence the institution encourages the departments to post the required information such as assignments dates, internal examination schedules, university circulars besides staff-prepared subject-related handouts.

The institution has established a transparent and healthy internal assessment system for effective and efficient service delivery. The main characteristics of the mechanism are as follows:

- 1. The schedules of the Internal Assessment Tests, the mode and methodology of conduction, the evaluation process of the answer scripts, and the distribution of marks are regularly brought to the notice of the students.
- 2. Transparency is ensured in the Internal Assessment, the college shares the evaluated answer scripts to the students for their feedback or grievance if any.
- 3. The institution also notifies the marks of Internal Assessment by displaying them on the

department's notice board.

4. Periodically Staff meetings are convened at departmental and college levels to review the evaluation process collect feedback and initiate needy action if any.

The institution has a systematic mechanism to redress the grievances of students if any brought the notice in the friendliest manner and in a time-bound manner.

After scrutiny, the details of appropriate suggestions taken for the modifications and constructive changes are made and finally, in charge are asked for submitting the modified documents of the same in hard and soft form. The hard copies of them are photocopied and circulated among the respective faculty members and soft form documents are uploaded to the College website for effective communication among the students.

All the staff members are suggested to explain the programs scheduled in the classrooms to the students at the time of commencement of the semester itself for effective communication among the students. The teachers also share their views in this regard with students to impart positive insights. The process of identification, formulation, and communication of POs, PSOs, and COs for all prescribed programs offered by the Institution to the students is mentioned below which also includes the approach and procedure to formal and notifying on the college website and communication to teachers and students reachable.

**Step-I:** College Principal in coordination with the IQAC and Academic Coordinators convened a general staff council meeting with all the teaching staff and trained the interest, importance, and process of preparation of POs, PSOs, and COs.

**Step-II:** Identification of Program outcomes, program-specific outcomes, and course outcomes for prescribed courses and disciplines at the department level.

**Step-III:** Department in-charges will submit their proposals in the Staff Council meeting, for the thorough and meticulous discussion and for the constructive suggestions and inputs by the council members which effectively strengthen them for enhanced usefulness to students.

**Step-IV:** Photocopied Copies of the approved POs, PSOs, and COs will be circulated among the respective faculty members and soft copies are uploaded to the College website for display.

**Step-V:** The principal conducts periodical analysis on effective implementation of POs, PSOs, and COs in consonance with all the departments in charge of achieving them. If any laps or lacunas are spotted, they can be addressed amicably.

**Step-VI:** For further enhancement of the POs, PSOs, and COs, they can be shared then with the university authorities, academicians, industry people, parents, and the stakeholders of higher education. The constructive suggestions received can be integrated into the document and the modifications will be informed to the students and staff with the instructions.

**Step-VII:** The feedback on effective implementation, impact on students' academic results, and generation of employment opportunities with the POs, PSOs, and COs are taken for the analysis and improvement. The same is communicated again to the teachers, students, and other monitoring members of the POs, PSOs, and COs.

#### **Response:**

Program outcomes, program-specific outcomes, and course outcomes of the programs offered by the Government Degree College Paloncha have been attained positively by the effective implementation of strengthened mechanisms. The institution monitors and evaluates the degree of attainment of POs, PSOs, and COs in comparison with the predetermined targets, and evaluation process is done at various levels such as department level, in general, staff meeting and finally, in college staff council, that is the apex body for academic aspects. The evaluation process of POs, PSOs, and COs of the college is briefly presented as under.

- Students' performance in concern to POs, PSOs and COs is evaluated individually as class wise and even program wise.
- During the evaluation of POs, PSOs, and COs of the college university prescribed norms, CCE initiated procedure, and institutional code of evaluation is strictly followed.
- The evaluation of the attained POs, PSOs, and COs of the college is close monitoring of students' activities is done by the class-wise mentors.
- The active participation of the students in the co and extracurricular activities like NSS programs, classroom-centered group discussions, seminars, quizzes, elocution events are other important parameters of evaluation.

- Curricular aspects like slip tests, unit tests, assignments, internal assessment tests, and performance in semester-end examinations are taken into account for the evaluation. Then the results are communicated to the concerned department in charge and also pursued in the staff council meeting.
- Students' performance in games and sports activities is also evaluated depending on their participation in the event meets at various levels such as district, state, and national. Students' achievements in these events are considered to evaluate their POs, PSOs, and COs.
- The empirical method is a tool to evaluate the POs, PSOs, and COs of the college regarding the students' performance and attainment.
- Short surveys, feedback collection, and mock interviews are also methods of evaluation.
- Students' employment, their scholastic form, research contribution, social awareness activities initiatives, and participation and knowledge over government schemes, etc., are also evaluated depending on their credentials and authorized documents.
- Students' competencies such as knowledge, abilities, skills over POs, PSOs, and COs are also evaluated by the class mentors who rely on students' creative, innovative and critical thinking.
- At the end of each semester, the principal in association with the Academic and the IQAC Coordinators convenes a detailed meeting to sort constructive reviews on the attainment of POs, PSOs, and COs for their evaluation. The positive outputs derived from the meeting are communicated to all the staff members of the college. Action plan for further improvement regarding attained POs, PSOs, and COs of the college is also prepared priory and circulated among the staff.

Youth Day, Plastic-free Orientation, Consumers Rights and Responsibilities, and those earmarked for importance as per the college mechanism accordingly.

The college NSS unit in association with Ecoclub and other departments regularly conducts Swachh Bharat programmes on the college premises and in the nearby villages. The Government of Telangana introduced a plantation program, "Telangana ku Harithahaaram" where the students are actively involved in plant sapling and conservation. #### **Response:**

Government Degree College, Paloncha was established by the Government of Andhra Pradesh in the year 1991 to cater to the higher educational needs of the poor and marginalized people and it has been offering its peerless services to the students of underprivileged families of the rural and agency area milieu. The institution's new building was constructed in 2006 and spreads in 15 Acres of ritzy green campus and the plinth area of the building is about 1430 Sq, Mts. Another new block is under construction with the RUSA 2.0 funds The building has two floors, one ground floor, and one up-stair.

**Digital classrooms:** Four classrooms are equipped with LCD projectors and appropriate software for PPT presentation and for accessing online web content.

**Virtual Classroom**: Ultramodern in Hardware and Software. Used for Video Conferences, Regular Online Classes, Recorded Lectures, Lecture Capturing System, to listen to lessons available in its Database, etc.,

**Laboratories**: The college has 5 laboratories such as Botany Laboratory, Zoology Laboratory, Chemistry Laboratory, Physics Laboratory, and Computer Laboratory and those are well equipped with necessary chemicals, equipment, and computers for the conduction of practical as per the UG syllabi.

**Computer Laboratory**: Total: 1: 68 High-end Configuration Systems with 50 Mbps Internet Speed Facility (wired) besides Jio Wi-Fi for the entire college. Used for MOOCS, Online Exams, Regular Classroom Instruction, Practicals, Admissions through DOST, TSKC Activities, Academic Examinations, etc.,

Government Degree College - Paloncha always strives to fulfill the growing needs and requirements of the students. The institution continuously upgrades IT facilities such as the number of computers per student, internet facility, and establishment of ICT enabled classrooms. The college has a media center with audio and video capture facilities. The number of Information and Communication Technology (ICT) enabled teaching-learning facilities including classrooms, seminar halls, and other academic facilities has now increased to five numbers compared to one number in 2015.

There is one large, spacious and well-ventilated computer lab in the college. The TSKC cell offers employability-based computer skills and is equipped with power backup. The college has a reasonable number of computers — as many as 97 in all. In order to provide a high-speed internet facility to the students and teachers, the institution has subscribed to the internet connection to all the computers via LAN equipment. On average a speed of 50Mbps is made available to the students.

There are 4 digital classrooms allotted each one for sciences, arts, commerce, and one for general classes in the seminar hall. The institution also has one virtual classroom with a lecture capturing facility. It confers video-conferencing facilities within the institute and connects to outside Govt. Colleges in the state of Telangana. The lecture delivered in the virtual classroom can be viewed by the students of any other Degree College across the state and it also enables students to participate in video conferences by district, CCE, and state officials.

The campus at present is enabled through Wi-Fi service. Four Long-range Unifi Access points are mounted on the ceiling to enable Wi-Fi connectivity on the campus. These Access points are periodically monitored and augmented as per the additional requirements. Internet access is allowed to every student in the institution. The password of the Wi-Fi is displayed in a prominent place in the building. The 14 CCTV equipment was also installed in the college to ensure security for student and staff belongings and for the continuous monitoring of the classrooms and laboratories. Most of the departments have computers, the majority of which have internet facilities via Wi-Fi for preparation of PowerPoint presentations as teaching-learning materials.

The IT facilities have been upgraded in several phases during the last five years.

#### Hardware:

Hardware up-gradation is being carried out on a regular basis as per the requirements of individual departments. Systems have been replaced with new models with advanced configurations/specifications with 4 GB/8GB RAM, Intel-i3, and 1TB/500GB hard drives.

### 6.1 Institutional Vision and Leadership

### 6.1.1 The governance of the institution is reflective of and in tune with the vision and mission of the institution

#### **Response:**

Government Degree College, Paloncha was established on Dt: 18-11-1991 by the Government of Andhra Pradesh as a dream of the people of the scheduled area to cater to the higher educational needs of the poor and marginalized sections of the society. The college, Paloncha is framed within demarcated Motto, Vision, Mission, and Core Values that reflect the uniqueness as per the needs of the students and value orientation to the downtrodden people residing in this area. As stated in the vision statement, the institution has good infrastructure with adequate classrooms, well-equipped laboratories; ICT-enabled digital classrooms, virtual classrooms, seminar hall, resource-rich library, greenery campus, playground, etc. Prominently well qualified, experienced, committed teaching and non-teaching staff is an asset to the college. ### 6.1.2 The effective leadership is visible in various institutional practices such as decentralization and participative management

#### **Response:**

The leadership of the Government Degree College, Paloncha strongly believes in building a reliable qualitative higher educational institute for the students of the agency area especially those from tribal and scheduled communities. It obeys the principle of decentralization and participatory democracy in its function. The college implements many practices to gain in leadership nurturing.

The institution constitutes various Committees with Faculty Members and Students and these committees are supervised by the Principal. Major work of these committees is done by the Conveners of the Committees by coordinating all the members. Likely, all the teaching and non-teaching staff as being members of the different committees made representation.

The college also ensures representation from students as these committees constitute nominated student members. The Staff Council, which is the most important committee in the formation of policies and their implementation at the college level, consists of all the senior members of the teaching staff. The Staff Council meetings are held periodically under the Chairmanship of the Principal.

Usually, a senior member of the faculty is nominated as the Academic Coordinator to deal with academic activities and examination-related work; takes major activity in the development of educational programs, faculty development, and implementation of Almanac of the affiliating university. The academics category includes the examination cell, time-table committee, T-SAT, TSKC, library, Audiovisual, and ICT. These committees ensure the academic excellence of students, DOST (Degree online services of Telangana) takes up the entire responsibility of the admission process.

Internal Quality Assurance Cell (IQAC) functions to take care of the quality enhancing and Sustainable initiatives in the college. The Principal assembles meetings with the in-charges of the departments to take important decisions to improve the student learning process, teaching skills and to go to par with the latest developments in the field.

A senior member of faculty acts as Convener of the Infrastructure Committee who looks over infrastructure, the Sports Committee deals with sports and games, and the Cultural Committee deals with cultural activities.

Similarly, the UGC committee, Women Empowerment Cell, etc., act with autonomy in their operation of activities and develop leadership. The in-charges of various departments play a crucial role in the formation and implementation of the College Action Plan. Some senior members of the faculty are placed in the College Planning and Development Committee (CPDC) which is at the forefront of the development

of the college.

The Extension programs committees include NSS, Eco club, Health Club, Harithaharam, College Magazine, and Research Committee. These committees function to develop humanitarian and charitable spirit among the students and instill patriotic spirit, a spirit of service. The student support consists of Antiragging cell, Grievance cell, Women Empowerment cell, Parent committee cell, Alumni, and RTI. ### 6.2.2 The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules and procedures, etc.

#### **Response:**

Commissionerate of Collegiate Education, Telangana State is the administrative dome of all the degree colleges in the state. The Commissioner supervises the performance of the staff, implementation of the policy of the government on education and appointment and transfers of the staff in the state. The Commissioner also monitors and guides the institutions to ensure better delivery of services. The Commissioner is assisted by the Joint Director who in turn is assisted by two Regional Joint Directors who implement the orders of the Commissioner and acts as a mediator between the Commissionerate and the institutions.

The academic matters are prescribed and governed by the affiliated university, Kakatiya University, Warangal. The syllabi of the courses/programmes offered are prescribed by the university. University releases the almanac for the year in the beginning of the academic year which prescribes a tentative schedule for days of instruction, working days, dates of examination, both internal and year-end as well as vacations if so. The entire process of examination, evaluation and certification is processed by affiliating the university.

Principal is the head of the institution for both academic and administrative wings. The Principal constantly and continuously monitors the institution's academic activity in compliance with the orders of the Commissioner. The Principal also supervises the financial matters of the institution. The academic

wing consists of the Heads of Department and the faculty members while the administrative wing consists of a Senior Assistant and Junior Assistants, Store Keeper, Typist, Record Assistant and Office Subordinates. The Senior Assistant is the in-charge of the ministerial staff and supported by two Junior Assistants help in preparation of salary bills, scholarship accounts and other expenditure. The records pertaining to admissions and issue of Academic Certificates are maintained by the Senior Assistant. The ministerial staff extends their support with regard to all the administrative matters.

Different Committees constituted by the Principal in consultation with the Administrative Office of the college look after their job chart proclaiming the duties and responsibilities with accountability in carrying out the schedules mandated officially.

Academic Staff Council comprising all in-charges of the departments which meets regularly to carry out resolutions of all important issues related to academic-related matters and to endorse the grants for developmental activities of the college.

IQAC is the apex body of the institution which comprises the members as per the notification issued by the NAAC in respect of its composition which is destined to look after one and all academic affairs of the institution and supportive of the college administration in specific.

Admissions and Exams: Admissions online through Degree Online Services, Telangana are handled by college DOST Coordinator and Examinations and Results by the Coordinator of Examination Branch of the College.

The Department of Physical Education looks after the Annual Academic Calendar of Sports and Games besides making students take part in Inter-collegiate, university, state and international competitions by encouraging them to prove their mettle.

#### 6.3.5 Institutions Performance Appraisal System for teaching and non-teaching staff

#### **Response:**

The Government Degree College, Paloncha has a systematic performance appraisal system for its teaching and non-teaching staff.

#### **Academic Performance Indicator (API):**

The appraisal system for the teaching faculty is designed as per the UGC guidelines. The procedure for appraisal of Principal and teaching staff is measured by the teaching and contributory role in the administration. The Principal's performance appraisal was measured by the Academic Administrative and development performance indicator (AADPI). API procedures play a key role in the Performance Appraisal System by regularly monitoring the administrative and academic activities of the college. At the end of the academic, the staff has to submit API (Academic Performance Indicator) to the Principal with self-evaluation marks. Further, the IQAC and principal analyze the API score and submit it to the collegiate education for further action. The Performance of the Contract & Guest faculty of the college was appraised by the percentage of results in their respective subjects.

- Every year API scores of the entire faculty will be calculated to measure the performance of the teaching staff. These API scores will help at the time of promotions in the service.
- Poor performance in API scores or in results may lead to transfers, punishments, etc.

The performance of the Non-teaching staff was appraised by their maintenance of the office records, inward and outward entries, training in administration, e-Governance, and proper disposal of the RTI issues.

**Academic Audit:** Every year an academic audit is conducted by a team appointed by the CCE. It will assess the performance of each department. An exit meeting is also held in which the staff are intimated about their shortfalls if any and advised to improve further. The principal has to submit an Action Taken Report on the remarks pointed out by the academic audit team to the office of the CCE.

**Student feedback:** Feedback or Students Satisfaction Survey on the teachers, teaching aptitude, and overall institution performance is taken from the students, parents, and Alumni members at the end of each academic year by administering a questionnaire on curriculum is adopted from the NAAC website. The filling up of questionnaires with the respective persons is administered by the faculty members of the

department other than the one to which the students belong. The concerned persons feel free to express their views and remarks without any inhibition. The questions quoted in the questionnaire choose from the curriculum, delivery, innovation, methodology, evaluation, teaching and learning process, soft and employment skills, and use of ICT and infrastructure facilities. The data is analyzed with the intention of identifying the suggestions for improvement or any correction in the college in terms of infrastructure, curriculum, and teaching. If the survey reveals any significant observations with respect to any of the criteria quoted, necessary action is initiated in this direction. If significant suggestions are raised such as for a new course, new course combinations the institution represents the same to the affiliating university and gets their sanction in subsequent years.

### 6.4 Financial Management and Resource Mobilization

#### 6.4.1 Institution conducts internal and external financial audits regularly

#### **Response:**

The major financial source for the institution is the special fees collected from the students; all the major requirements are met with the same source. The government also sanctions annual budgets headed for administrative items like stationery, traveling expenses etc. In addition, the University Grants Commission (UGC) also grants funds for the improvement of the infrastructure facilities. The accounts for the same are maintained properly.

The principal, the head of the institution transacts all its financial resources through banks online only. All the financial transactions are supported by the concerned bills. Under the chairmanship of the principal and the concerned committees, they countersign the bills and vouchers and then see that no mismanagement is taking place in the transactions.

At the time of retirement or transfer of Principal of the college the external audit is done by the Office of the Accountant General (AG), all the financial transactions that have been done in his or her period are audited by the audit officers assigned by AG office. During the last five years, the external financial audit was done once, 21-12-2017. Similarly, even the academic audit experts were authorised to look into the financial transaction during 2020-21. In addition, the external audit is also conducted by the Commissionerate of Collegiate Education (CCE) Telangana with the help of the State Audit Department, Telangana, and Hyderabad.

**Internal Audit:** The principal obtains the budgetary estimates for every financial year from the office. The salary budget requirement is prepared by the office and sent to CCE for the release of the quarterly budget. The expenditure for the college development is thoroughly discussed in the concerned committees and sent

to CCE for approval to meet the expenditure from the student's special fee account. Moreover, the internal audit is also carried out by an ad hoc committee consisting of senior faculty members and senior members of non-teaching staff the committee also does annual verification of the departments and their stock.

**External Financial Audit:** The external audit i.e Academic and Administrative Audit (AAA) is conducted every year by an academic audit team constituted by CCE and subsequently Action Taken Report on their observations /suggestions is submitted to CCE within the stipulated time. External financial audits are also conducted by state-level AG and CCE on a regular basis.

The income tax returns of all the employees are also verified by the internal committee constituted for that purpose. The college does regular TDS (Tax Deduction and source) in time and the IT returns will be sent to the Auditor for external verification and e-filing.

The Principal and committees allot the financial resources to the departments as per their requirements submitted and resolutions are passed for the same.

The major financial source for the institution is the special fees collected from the students; all the major requirements are met with the same source. Apart from the regular budgetary allocations by the government, the institution also acquaints various government funding agencies like UGC, RUSA. The institution prepares proposals and submits for organisations of seminars, workshops, training programs, and symposia. The institution applies for financial aid from UGC, RUSA, ICSSR, CSIR, and State Higher Education Council. Similarly, the District Collector also extends financial assistance to organise such programs.

Additionally, the funds may be mobilised from CPDC, Alumni Association, philanthropists, and non-governmental organisations to take up some activities in the college. The institution has been providing Mid-day meals to the students since 2014 with the financial assistance of the District Collectorate Authority and local people.

College administration efforts relentlessly and the institution now has been able to get the allocation of 2 crores of rupees for improving and augmenting the infrastructure, academic, support, and auxiliary facilitates and for their maintenance: from RUSA 2.0 funds for the construction of the new classrooms and for other infrastructural facilities.

#### quality assurance strategies and processes

#### **Response:**

The Government Degree College Paloncha established a positive Internal Quality Assurance Cell (IQAC). In pursuance of guidelines of the National Assessment and Accreditation Council (NAAC) for the composition, the college system IQAC on 12-11-2012 and has been reconstituted from time to time. The prime objective of the quality assurance committee is to guide and monitor academic, co-curricular, and extracurricular activities with a view to promote and sustain quality in academic and administrative systems. The IQAC coordinates the faculty members in preparing annual curricular plans, teaching plans, and other records for the purpose of academic audit and NAAC A& A processes. IQAC supervises the execution of these plans through periodic reviews and strives to improve quality education. The cell also gives necessary suggestions for improving teaching-learning process in the institution. The IQAC initiated the following measures for institutionalizing the quality assurance strategies and processes:

- 1.IQAC has encouraged the staff to promote research in the college and to register themselves for the Ph.D. programs resulting in 1 Ph.D in 2020-21, 3 Ph.D. registrations in 2019-20, and 9 in 2015-16.
- 2.IQAC works constantly and conducted 19 workshops/conferences were organized in the college by various departments, including 2 by IQAC itself during the last five years.
- 3. The IQAC of the institution is at the forefront in encouraging the staff to attend RCs, OCs, FDPs, and other training programs. As a result, 6 Refresher Courses, 5 Orientation Programs, and 45 Faculty Development Programs and other training programs.
- 4. The IQAC has encouraged the faculty members to attend workshops, seminars and present papers in respective meetings.
- 5. All the faculty members are trained to teach online and make PPT presentation in COVID pandemic time.
- 6. The faculty members have been maintaining the annual plan, teaching plan, digital teaching diary, and student attendance register, class-wise internal and external marks register as a result of the IQAC's periodic reviews.
- 7. The IQAC always bats for the use of technology-enabled teaching and is successful in establishing four digital classrooms and one virtual classroom facility.
- 8. The feedback from the stakeholders such as students, parents, alumni, and teachers has been obtained every year by the IQAC which is also analyzed and appropriate action has been taken based on the results.

As the nodal agency for quality matters at the institutional level, the IQAC coordinates with the NAAC and other accreditation bodies. The IQAC was contributory in the successful completion of the 1st Cycle of Assessment and Accreditation and the visit of the Peer Team in March 2016 and the award of Grade "C" in April 2016. Now the committee is doing its best for the 2nd Cycle of the Accreditation by NAAC.

#### **Response:**

The Government Degree College Paloncha has been performing an evolving scenario with an integrity framework for quality assurance and consistency of the academic and administrative activities. The Quality Framework of the college to ensure quality includes reviewing the teaching-learning processes, the methodologies adopted to operationalize the processes, and evaluation of realisation of the learning outcomes. For this, the college adopts a strong mechanism to operationalize the same.

The Institution formulates an academic calendar of its own in consonance with the Almanacs of the affiliating university and the calendar issued by the Commissionerate of Collegiate Education (CCE), Telangana state. The faculty of the institution prepares their respective Departmental plans and individual academic plans to achieve the desired goals and objectives.

Action Plan of the IQAC: The IQAC organises a meeting at the beginning of the academic year to discuss its Plan of Action. The opinions and suggestions from the departments and committees/cells are incorporated in the IQAC Plan of Action. The internal quality cell recaps the in-charges of the departments and the committees to take up the activities that are necessary already agreed by the Plan. The IQAC also extends required guidance, supporting timely and successful organization of the proposed activities. The proper documentation is an important task in the revised quality framework of the NAAC and hence the IQAC encourages the organizing department or faculty in maintaining and storing through documentation that is essential.

The Internal Quality Assurance Cell (IQAC) conducts quarterly meetings to review the progress of the teaching-learning process and its implementation. The cell also encourages the staff members in the conduction of all the curricular activities according to the academic calendar to realize the objectives set therein. The IQAC coordinates all the faculty members in preparing annual institutional plans, curricular plans, teaching plans and monitors the execution of these plans through periodic reviews. The records of various committees/cells are maintained in an organised manner with the purpose of being placed before the head of the institution and the IQAC.

Every month, the Principal convenes the meeting of the Staff Council that includes the in-charges of all the departments to approve the departmental action plan. Similarly, the General Staff meeting is also organised month-wise to review the implementation of the teaching plans, the annual curricular plans, the outcomes of various courses, and other activities proposed to be held in the college.

Academic Audit by the CCE, Telangana is a quality ensures procedure to monitor and review the teaching-learning processes and their outcomes at the college level. Annually, a team of two senior teachers from other colleges deputed by the CCE visit the college at the end of the academic year and conduct an audit of all the records, reports, evaluation processes, and their outcomes, and other curricular, co-curricular, extension, outreach programs related academic activities. In the audit, each and every teacher, including the Principal is subject to verification. Finally, a copy of the Audit Report and the suggestions is submitted

to the CCE, TS, and the Principal who in turn initiates appropriate measures and submits the action taken report (ATR) to the CCE. In the regular staff meetings and the Staff Council meetings, the suggestions and inadequacies that have been pointed out by the Audit Team are thoroughly discussed and appropriate measures are initiated for further improvement.

To operationalize the entire procedure, the institution provides training to the staff and nominates them for the training programmes such as OC, RC, and FDP those organized by the UGC- sponsored HRDC (formerly ASC) and the CCE from time to time to enable them to handle the NAAC – related quality procedures. The State Council for Higher Education, Telangana State also organizes training programs for which the college nominates its staff members, besides sending them to attend the seminars and workshops on specific topics organized by various institutions in and outside the state so as to help them equip themselves with the latest developments in education.

The IQAC of the college conducted four meetings in the academic year 2020-21 and mainly focussed on the various curricular, co curricular and extracurricular activities and resolutions made; those meetings and resolutions made are detailed below:

- 1. Every department of the college maintains three best practices to improve quality education.
- 2. To conduct more seminars/workshops, field trips, extension/guest lectures through online and offline mode for the best motivation of the students.
- 3. To maintain the college garden in good condition.
- 4. Strive hard to promote excellence by coordinating all the stakeholders of the college.
- 5. Preparation and conduct ICT-enabled classes and content for betterment use in the COVID pandemic era.
- 6. Faculty members were encouraged to write scientific arctic articles, books publication, and participation in various training programs.

IQAC meetings with the Staff Council are always conscious of the fact that the quality policy should never break loose from the front line importance keeping the future of students in view. Use of ICT, Virtual Classroom, SOUL software in Library, LCD and Smart Boards, Exams and Evaluation in time, Free P.G. Entrance Coaching Online Feedback Mechanism, Syllabus Completion Control, and Check-up; MOOCS Online Courses, Certificate Courses, Remedial Classes, Co-Curricular and Extra-Curricular Activities, Student Progression and Placement opportunities are resolved to be seriously looked into for radical improvement from 2020-2021.

### 7.1 Institutional Values and Social Responsibilities

7.1.1 Measures initiated by the Institution for the promotion of gender equity during the last five years.

#### **Response:**

The Government Degree College Paloncha is much conscious of the sensitivities involves in gender-associated issues and thus has been taken proper care in providing amenities such as Safety and Security, Counselling, and Common Room. To look into the gender issues, the institution has constituted the Internal Complaints Committee (ICC) and the Women Empowerment Cell (WEC) with the senior lady teachers as convenors and other women teachers and some girl students as members. The Grievance Redressal Cell (GRC) is also involved in gender-sensitive measures. The Principal in consonance with the ICC and WEC has taken appropriate measures for the welfare of female students and teachers of the college.

Safety and Security: The safety and security of the female students and female teachers are of prime importance and are the fundamental duty of the college administration. The college monitors every nook and corner of the college using Strong Surveillance systems both outside and inside of the college premises. The entire college is surrounded by a compound wall of above 6 feet in height. The college timings set from 10AM to 4:00PM in view of limited transport facilities for the students of remote regions. To avoid ragging Anti-ragging committee is constituted in the college to address the. Ragging and sexual harassment consequences are placed at Notice boards as per the UGC-MHRD guidelines. However, since students are sensitized enough towards women's safety aspects, there have been no complaints of sexual harassment or other safety-related issues during the last five years. Proper login details of outsiders inside the campus are maintained for better security. Internal security is not essential as all students are girls. A safe and secure learning environment is created for girl students in the college with specific reference Installed 14 CCTV cameras in college and at vantage points to ensure a safe and secured environment in the college. All the CCTV cameras footage is recorded live and accessed from any place. We conduct frequent interactive sessions with SHE teams of Telangana Police sensitizing the students and staff with consequences of eve-teasing and harassment. When the Hawk-Eye app was launched by SHE teams, the college organized awareness programmes on its usage in critical times.

#### b) Counselling:

Since the majority of the college students belong to the vulnerable sections marginal communities of the tribal society there is a dire need to counsel them to boost their willpower and confidence levels. The Mentor-Mentee system and Grievance Cell of the college has taken the responsibility to mentoring and counsel the students in a needy situation. Utmost care was taken to maintain secrecy when dealing with the personal problems of the students. Counseling is intended to encourage the students to report at the earliest as and when they encounter any type of problem. These measures relieve them from mental agony and discontinuation of studies.

#### **Response:**

The waste generated in the college is in the form of solid, liquid, and e-waste. Yet the quantity of waste generated in the college is scanty the administration adopted a wide practice in its management.

**Solid Waste Management:** Generally the college's solid waste is generated in the form of litter, used papers, exhausted pens, and other items of stationery. The quoted below are some of the awareness initiatives that the college has taken to minimize the use of plastic and other solid waste in the college:

- 1. The college systematically manages solid waste in a systematic manner. The waste is firstly segregated into wet and dry waste forms and then handed over to the Gram Panchayat authorities.
- 2. By the conduction of awareness programs the staff and students cooperate to the extent possible to avoid using plastics and instead, use eco-friendly things.
- 3. On special occasions, students are motivated to use the natural flowers and leaves grown in the college garden instead of plastic items.

**Liquid Waste Management:** The building of the educational institution has spread over 1400 sq. mts. in the area and on two floors. It houses around 600 people (students and staff) and causes every day the production of liquid waste that consists mainly of effluent waste generated from washrooms and wastewater discharge from the Reverse Osmosis (RO) plant. The institution constructed four water harvesting pits for the drained water and to increase the groundwater level. Water wastage from RO plant during the purification of water is efficiently used for watering plants, especially banana plants.

**Biomedical waste management:** Biomedical waste such as cotton used in the zoology laboratory, used sanitary napkins from the Girls' waiting hall are disposed of through an incineration machine.

**e-Waste Management:** E-waste denotes discarded computers, office electronic equipment, phones, television sets, LCD Projectors, printers, and refrigerators. This also includes electronics that are destined for reuse, resale, and recycling or disposal. We follow the guidelines proposed by the Commissioner of Collegiate Education (CCE), Telangana in adherence to all the Government Degree Colleges for effective management of the e-waste. Aimed at this purpose, a District level committee shall be formed in one per District under the chairmanship of the District ID College Principal comprising Lecturers as members, especially a Lecturer in Computer Science. The number of members of the committee shall not be more than 5 including the Chairman. As part of the e-waste management procedure, the committee shall:

- 1. Identification of the institution's waste
- 2. Categorization of the e-Waste
- 3. Separation of category wise e-waste
- 4. Preparation of the list of items and handing it over to the institution for the requisite process.
- 5. Then the committee submits the report to the CCE in a stipulated time and with prior permission from the CCE. The college may write to the Director, Telangana State Technological Services and Hyderabad for approved agencies to take up the process of disposal of the e-waste

#### **BEST PRACTISE -I**

#### TITLE OF THE PRACTICE: MID -DAY MEAL PROGRAM

Offering meals/lunch to students of the college in the afternoon session

#### OBJECTIVE OF THE PROGRAM

The mid-Day meal program is one of the best practices in the college. The need of implementing this program is to fulfill the socio-economic and academic gaps of the students. As this college is operating in a complete tribal location, most of the students are coming to the college from interior locations.

#### CONTEXT OF THE PROGRAM

We identified certain difficulties, gaps, problems of the students in concern to the start of this practice.

They are...

- Students belong to mostly tribal villages which are located far from the college and not well connected with proper public transport.
- Most of the students socially & economically belong to poor sections in the society.
- They spend most of the time traveling and are likely to start from their homes well in advance at early timings in the morning to reach the college in time.
- They have no time to prepare food for lunch and most of the time they are attending college with an empty stomach.
- These hurdles impact students' learning, attendance & results.
- Most importantly students are affecting by deficiencies in nutrition, hemoglobin, iodine, and other health issues

#### THE PRACTICE:

- Every semester, two months before the start of the examinations, Lunch is provided to every student in the college. So that students are free from their food preparation in the morning time. It saves students quality time also.
- Students are provided with nutritious and balanced food which is a good combination of veggies & leaves.
- Certain vegetables & leafy vegetables are cultivated and grown on the campus with help of staff.
- Daily one boiled egg is supplied to every student to fulfill their balanced diet intake.
- As lunch is provided in the campus, Study hours & Remedial classes are conducted from 3.30 pm to 4.30 pm every day.

#### INVOLVEMENT OF STAKEHOLDERS IN THE PROGRAM:

- Students are voluntarily participating in the program with their support to the cooking staff. Class wise participation schedule is planned.
- NSS Unit of the college is Supervising the entire program
- Staff contributing funds to meet the expenditure.
- Alumni is also actively involving & contributing the funds
- Local NGOs participating in the program.
- Honorable district collector, Bhadradri district, sanctioned funds of Rs. 1,32,325.00 (Rupees one lakh thirty-two thousand three hundred and twenty-five) to meet the expenditure in the academic year 2017 2018

### **EVIDENCE OF SUCCESS**

With the initiative of the program in every semester as best practice in the college, students are benefited from academic improvement. As students are spending significant time in college, their performance increases academically and it is also reflected in the examinations. Attendance of the students increased

notably Student's learning ability improved with interaction and active involvement in academic activities in the college. Students' health and physical standards also improved considerably.

#### PROBLEMS ENCOUNTERED AND RESOURCE REQUIRED

- During the practice of this program some problems are encountered. The timely supply of nutritious materials becomes hard because of everyday purchase and their transport to the college.
- The cooking and its supporting facilities become somewhat not easy though it is overcome by collective work of the students.
- The successful implementation is much dependent upon the financial resource and for that sake the Governmental and non-governmental bodies have to come in the field in the form of schemes and donations.

#### 2. COLLEGE GARDEN WITH QR CODE SYSTEM:

#### TITLE OF THE PRACTICE: COLLEGE GARDEN WITH QR CODE SYSTEM

#### **OBJECTIVE OF THE PROGRAM**

Title every plant with QR code images for the easy and quick accessibility of the information about the plants we are seeing.

### CONTEXT OF THE PROGRAM

The need of this practice starts with the plantation and their nourishment of what has happened in our institution in recent years. The Paloncha area is located in the premises of Major & Small Industries such as Kothagudem Thermal Power Station, National Mineral Development Corporation Ltd, Nava Bharat Ventures Ltd., Sponge Iron Limited etc. and these industries apparently cause air and dust pollution surrounding areas. Our college is also located in the vicinity of these Industries and has to sustain or tolerate the campus as pollution-free. For this significance another best practice is adopted to maintain the campus eco-friendly with a variety of plant communities that act as pollution combating agents. Consequently this activity also engages the students in social responsibility activities and needs to know the plant's information.

#### THE PRACTICE:

### PLANNING OF THE PROGRAM TO RESOLVE THE ISSUES:

- It is decided to plant a variety of plants such as Medicinal valued plants, Ornamental plants, botanically important plants & Environmental supporting plants.
- The Department of Botany along with the staff and students planned to maintain a Botanical

- Garden and College Garden in the campus and every plant is recorded with a separate QR code about the features and characteristics of the plant.
- In the practice, the Ecoclub cell and NSS Unit of the college supervise the planting, maintenance of the plants.
- The students belonging to Science stream along with the other students are planning to collect the plants from nurseries or their home premises and plant in the college campus and also they have to involve in the clean & green programs for the proper maintenance.

#### INVOLVEMENT OF STAKEHOLDERS IN THE PROGRAM:

- All the students are encouraged to involve actively in the plantation & maintenance of the garden.
- All the staff members are involved in the programs initiated by the Eco club & NSS Unit of the college.
- Alumni is participating in the plantation programs
- NGOs, Forest Department, Prohibition & Excise Department, and other local people representatives are involved in the programs organised by the college.
- College is collaborated with the Forest Department, Prohibition & Excise Department, and NGOs to maintain the campus Eco friendly.
- Regular practice of participation in "Harithaharam" an initiative program of the Government of Telangana is planned.

#### EVIDENCE OF SUCCESS

- With the initiative of the program, so far 3500 plants are planted in the campus and more than 3000 plants have survived with continuous Clean and Green programs and maintenance of the garden. With the facility of a Botanical garden in the campus, students of the Biological stream are comprehended about the plants. With QR code system, students are well aware instantly of the plant features, description, uses, etc.,
- The massive greenery in the campus also helped to sustain pollution-free air in part of an ecofriendly environment.
- The college is giving a pleasant atmosphere for the students and staff and complete information about the plants and their characteristics and uses.

During the practice we have not noticed big problems as this is taken up by all stakeholders responsibly and involved in the program.

#### Introduction

Phyllanthus emblica, also known as emblic, emblic myrobalan, myrobalan, Indian gooseberry, Malacca Tree, or amla, from the Sanskrit amalaki, is a deciduous Tree of the family Phyllanthaceae.

#### Plant morphology and harvesting

The Tree is small to medium in size, reaching 1–8 m (3 ft 3 in–26 ft 3 in) in height. The branchlets are not glabrous or finely pubescent, 10–20 cm (3.9–7.9 in) long, usually deciduous; the leaves are simple, subsessile and closely set along branchlets, light green, resembling pinnate leaves. The flowers are greenish-yellow. The fruit is nearly spherical, light greenish-yellow, quite smooth and hard on appearance, with six vertical stripes or furrows.

Ripening in autumn, the berries are harvested by hand after climbing to upper branches bearing the fruits. The taste of Indian emblic is sour, bitter and astringent, and it is quite fibrous.

#### **Buddhist symbolism:**

In the Buddhist tradition, half an amalaka fruit was the final gift to the Buddhist sangha by the great Indian emperor Ashoka. This is illustrated in the Ashokavadana in the following verses: "A great donor, the lord of men, the eminent Maurya Ashoka, has gone from being lord of Jambudvipa to being lord of half a myrobalan" (Strong, 1983, p. 99). In Theravada Buddhism, this plant is said to have been used as the Tree for achieving enlightenment, or Bodhi, by the twenty first Buddha, named Phussa Buddha.

#### **Traditional uses:**

#### Culinary use

The amla fruit is eaten raw or cooked into various dishes, such as dal (a lentil preparation) and amle ka murabbah, a sweet dish made by soaking the berries in sugar syrup until they are candied. It is raditionally consumed after meals.

In the Batak area of Sumatra, Indonesia, the inner bark is used to impart an astringent, bitter taste to the broth of a traditional fish soup known as holat.

#### Traditional medicine

In traditional Indian medicine, dried and fresh fruits of the plant are used. All parts of the plant are used in various Ayurvedic medicine herbal preparations, including the fruit, seed, leaves, root, bark and flowers. According to Ayurveda, amla fruit is sour (amla) and astringent (kashaya) in taste (rasa), with sweet (madhura), bitter (tikta) and pungent (katu) secondary tastes (anurasas). Its qualities (gunas) are light (laghu) and dry (ruksha), the postdigestive effect (vipaka) is sweet (madhura) and its energy (virya) is cooling (shita).

In Ayurvedic polyherbal formulations, Indian gooseberry is a common constituent, and most notably is the primary ingredient in an ancient herbal rasayana called Chyawanprash.

#### Other uses

Commonly used in inks, shampoos and hair oils, the high tannin content of Indian gooseberry fruit serves as a mordant for fixing dyes in fabrics.

#### **Chemical constituents**

These fruits are reputed to contain high amounts of ascorbic acid (vitamin C), and have a bitter taste that may derive from a high density of ellagitannins, such as emblicanin A (37%), emblicanin B (33%), punigluconin (12%), and pedunculagin (14%). Amla also contains punicafolin and phyllanemblinin A, phyllanemblin other polyphenols, such as flavonoids, kaempferol, ellagic acid, and gallic acid.

#### 7.3 Institutional Distinctiveness

### 7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

#### **Response:**

Government Degree College, Paloncha was established on Dt: 18-11-1991 by the Government of Andhra Pradesh as a dream of the people of the scheduled(Tribal) area to cater the higher educational needs of the poor and marginalized tribal and other backward people. The college administration much more concentrates on these students for whose the higher education has become the main prerogative, uneducated parents are unaware of the fruits of education resort to the extreme step of early marriages to

girls/daughters at a very young age and also sending the boys and girls for agriculture labor at the cost of discontinuing college education.

The college started its beginning in the premises of the local Government Junior College building and operated in a shift system from its inception, in 2006 the college shifted to its present own building. From the year 2019 construction of additional classrooms and infrastructural augmentation with the financial assistance of RUSA 2.0 was started and now it is almost in the final stage of completion. The college has 15 acres of land and about 1430 sq. Mts. plinth area. The college has 34 rooms in which 12 Class Rooms, 4 digital classrooms, 1 virtual classroom, 4 Staff Rooms, 1 Seminar Hall, 1 Gymnasium, 2 units of Toilets, 5 laboratories, 1 IQAC Office, 1 MANA TV/TSAT Hall, 1 Library, 1 Administrative Office, 1 Principal's Chamber, 1 NSS Room & 1 RO Plant Room. Now the college is fully fledged with classrooms and other facilities. The college has a significant play area for sports & games, greenery, botanical garden, and good internal footpaths. One Boys Hostel is located in the college campus and others are situated at walk-able distance from college.

The motto of the institution, "Nahi Gnanena Sadrusham" is taken from a Sloka belonging to the fourth chapter of Bhagavad Gita', it means wisdom is majesty pure and divine. Across the period of time, the institution has made its own mark through consistent service to the poor students.

The Government Degree College, Paloncha had its humble beginning with offering B. Com, B.A course with meager student strength and took nearly two decades to flourish. The Science Courses in Telugu and English medium introduced in 2008-09 and 2018-2019 respectively. In accordance with the UGC guidelines and Government of Telangana directions the institution is offering courses in C.B.C.S pattern from 2016. From the academic year 2019-20 MOOCs programmes are also included with the regular programmes. From the year 2020-21 M.Com is introduced. Now the college is offering 17 programmes. The institution has been following the curriculum executed by the affiliated university, Kakatiya University and Commissionerate of Collegiate Education, Telangana.

The institute with a burden to protect the rights of women has been encouraging girl students to take admission in the college and has been protecting them in all matters possible. The institute has 62 Memorandum of Understandings(MoUs) that help the students to learn more living and employable skills. The college has much collaboration with Public/Governmental and Nongovernmental agencies to support the students for multidimensional growth.

Various committees like Staff Council, Academic and Examination Committee, Complaints Redressal Cell, Women Empowerment Cell, Internal Complaints Cell, Anti-ragging Committee, Jignasa Committee and Ecoclub, Women Empowerment Cell, Bhagya Cell are working under the Chairmanship of the Principal contribute in the implementation of the vision and mission of the college. CPDC meets regularly to discuss the progress of the institution and makes resolutions for the affluence of the institution. IQAC functions to take care of the quality enhancing and sustenance initiatives in the college.

The institution has a student council that is constituted with Student Members. The members are elected by the staff council depending upon the academic merit of the students. Representatives for Ladies, Sports, Games, and NSS are nominated by consulting respective in-charges. Principal of the college is taking into significance their commitment to active participation in curricular and extracurricular activities. The council shares participation in the planning and execution of the events such as sports and cultural meets, plantation, Clean & Green activities. The college has one unit of the National Service Scheme(NSS) organising many extensions and provides the students hands- on experience in societal issues and

problems. It equips them with the service motto and transforms them as potential leaders.

The institution is framed within demarcated Motto, Vision, Mission and Core Values that reflect the uniqueness as per the needs of the students and value orientation to the downtrodden people living in surroundings of the college.
