
Sub: Accreditation of GDCs- New system of Assessment by NAAC-Instructions to GDCs-

The eight Government Degree Colleges mentioned in annexure-II have obtained Grade 'C' from NAAC and therefore are not receiving funds from RUSA. If these colleges opt for reassessment and improve their grading they will be eligible to receive Rs.2.00 crores for each college from RUSA. The NAAC guidelines on reassessment are: *Institutions, which would like to make an improvement in the accredited status, may volunteer for re-assessment, after a minimum of one year or before three years of accreditation. The manual to be followed for re-assessment is the same as that for the Assessment and Accreditation. However, the institution shall make specific responses based on the recommendations made by the peer team in the previous assessment and accreditation report, as well as the specific quality improvements made by the institution in the intervening period. The fee structure and other procedures would be the same as that for initial Assessment and Accreditation with the exception that the Institutions that volunteer for re-assessment will not be eligible for reimbursement of accreditation expenses, as per the "Guidelines of UGC assistance for Assessment and Accreditation".*

Therefore the Principals of Government Degree Colleges with 'C' grade as per annexure-II are hereby instructed to study the recommendations of the Peer Team report and prepare themselves for reassessment as these colleges have good physical infrastructure and have the potential for improving the grade. The principals are requested to furnish the details in the following format by 15-11-2017.


