Code of Conduct Policy

Introduction

- ❖ To formulate code of conduct to be followed in the campus.
- ❖ To sensitise students constantly so that conduct code becomes an innate culture among students.

Code of conduct for students

- All students are expected to be punctual to the college.
- All students should be regular to the college.
- Ragging in any form is strictly prohibited and invites strictest punishment. Till date, not a single case of ragging took place.
- Usage of mobile phones, unless specially mentioned, are prohibited in the campus for students.
- All students are expected to be disciplined in the class and in the campus.

- Students must attend all the programmes and activities undertaken by the college actively.
- They must go through Do's and Don'ts in the labs and other utility areas and oblige.
- Students should follow dress code and wear dress that commands respect.
- They must follow rules of hygiene including COVID-19 guidelines.
- They shall not litter campus.
- Tara GC Sangareddy is a plastic free campus (PFC) and Parthenium Free Campus (PFC). They must respect the value and work towards the goal.
- All plants are to be protected. They must not soil the Green Library or walk on the grass.
- They shall not pick quarrels with office staff or any other staff. They shall not bring in any of their friends/ relatives into the campus without prior notice or unless warranted or asked to do so.
- They must wear their ID card.
- They must know that getting the best of services from the college and its staff is their right and they could register their grievances, if any, in a proper manner.
- All students can participate in any cultural/ sports/ games or any other activities of their choice.
- They must use lab equipment / gym equipment responsibly.
- They must maintain silence in the library.
- They can raise queries about any services through their mentor.
- Any deviation in any form invites serious disciplinary action.

Code of conduct for parents

- We expect courteous behaviour from parents.
- They have every right how the classroom transaction takes place and the progression of their ward.

- Parents can visit their ward's mentor, any teacher or principal with prior appointment.
- They shall ascertain the progression of their son/daughter periodically.

If any parent desires to get to know about the academic information such as dates of fee payment of examination, last working day, they can get information. Most of the data is transparent and displayed on the website. This reduces many an issue of parents and students.

- The college expects them to be an active participant in college activities including parent teacher meetings.
