



## **MEMORANDUM OF UNDERSTANDING (MOU)**

It has been donning the role of service through its NSS units. The college has carved a niche for itself through the services of its volunteers to in and around the town.

Manasamajam Foundation, Regd.No.1611/2018, based at Sadasivpet, Sangareddy district, Telangana, is a fledgling service-oriented foundation with service motto.

Against this background both the parties i.e. NSS Unit 1 of Tara Government College, Sangareddy (A) Manasamajam Foundation, Sadasivpet, Sangareddy district, Telangana (also mentioned in this document as two parties) decided to reach the Memorandum of Understanding (MoU) with the following salient features mentioned here under.

1. Manasamajam Foundation will sponsor the service-oriented activities for the students designated by the NSS unit.
2. The faculty designated by the chairperson of NSS units of Tara Government College Sangareddy (A) will serve as resource persons for Manasamajam Foundation, when required, and as per the rules laid down by the Commissionerate of Collegiate Education.
3. Both parties will jointly organize service activities, skill development programmes/ programmes on issues of the society/ workshops on mutual agreed topics from time to time.
4. The faculty of Tara Government College Sangareddy (A) will offer consultancy services to the Manasamajam Foundation, as and when required.

5. Both the parties may also exchange services, time to time, if need be, that are not mentioned in this document.
6. This Memorandum of Understanding does not cover any financial transactions.

The Memorandum of Understanding (MOU) will come into effect on the date of signature and will remain in force for three years unless either of the parties delivers written notice to the other of its intention to terminate the MOU, in which case, it will terminate three months after the receipt of such notice.


This Memorandum of Understanding (MOU) may be amended by mutual consent through an exchange of correspondence between the two parties.
